## (d) Air Quality Health Index (BOH10008(a)) (City Wide) (M. Lawson) (Item 7.1)

Matthew Lawson, Program Manager, Public Health Services, addressed the Board of Health with the aid of a PowerPoint Presentation. His comments included but were not limited to the following:

What is the AQHI?

- AQHI stands for Air Quality Health Index
- It is a scale that represents the effect of local air pollution on our health.

What does the AQHI communicate

- AQHI is based on the Ozone, Particulate Matter and Nitrogen Dioxide in the air.
- It is translated in a 1 to 10 scale with 4 risk areas.

AQHI and the "at risk" population

• Those at risk are young children, elderly, individuals with respiratory conditions, and individuals with cardiovascular conditions.

AQHI Implementation

 Public awareness campaign (with use of HSR advertising, promotional materials to those in the at risk category, summer festivals and website(hamilton.ca/aqhi))

Board members asked questions and comments of staff. Highlights included but were not limited to the following:

- What is the difference between the last index used and this one, and will it be confusing for the public?
- Will the Ministry of the Environment track how AQI and AQHI interact?
- What has been done to help air quality in the City to alleviate the number of smog days and lower air pollution?
- Is the index site specific or are there a number of testing areas?
- There are two testing units in the City located at Mohawk Road and Upper Wellington and Beasley Park.
- Who in the Public Health Unit would investigate health risks associated with odours?
- Staff indicated that the Public Health Unit would investigate any odours for public health risk.
- Does the City have to take action to stop minor sports from taking place when the index is high?
- The index is for information only and does not have a response mechanism associated with it.
- This is only an awareness campaign, and will not result in any other action.
- We need to start our focus on the causes of air pollution, but it is important to let the public know of the risk associated with poor air quality.
- With only two monitoring stations, how accurate is the index? Is there a possibility we will be misleading the public?
- Can we look at using pixel signboards throughout the City and in cooperation with partners to make citizens aware of the daily AQHI level?

Dr. Richardson addressed the PHS priorities addressed in the report.

Board members were pleased that the 2011 Public Health Services Management Team Work Plan addressed the need for consultation with Board members. Members of the Board were concerned that environmental groups in Hamilton may feel that other priorities should be recognized or reordered, and suggested that there may be a disconnect between Public Health Services and these interest groups surrounding expectations. Councillor McHattie indicated that a meeting between the environmental groups and PHS would be a good idea.

The Board inquired as to how PHS performs performance appraisals and subsequent methodology.

Councillor Ferguson inquired as to where outbreaks would be accounted for in the work plan. Staff indicated that outbreaks were accounted for within Critical Demand Work.
