



The city wants to shrink vehicles and take back scheduling and reservation duties for complaint-plagued disabled transit agency DARTS.

The independently run shared-ride service has seen complaints and its annual deficit grow in recent years, leading councillors to call for a review.

A rider survey was completed recently, but has not been made public yet.

But a budget presentation posted online Friday shows transit officials already have some ideas about how to improve the service.

"Basically, we're looking at moving towards less expensive vehicles and bringing more control back (to the city)," said HSR director David Dixon in an interview Friday.

Specific recommendations include:

- •cutting the service's fleet of 70 small buses in favour of more accessible vans;
- •seeking new private bids for service before the end of the DARTS contract in 2017;
- •repatriate scheduling, reservations and dispatching duties from the contractor.

Complaints about DARTS reached a crescendo not long after the service took control of those duties in 2012.

DARTS officials have argued the initial spike in complaints was due to technical failures that were gradually ironed out.

DARTS executive director Mark Mindorff said he would attend Monday's budget meeting but wanted to learn more about the recommendations before commenting.

But he did say it would be difficult for a contractor to control complaints if it didn't control scheduling. "If you're going to be held responsible for a service, you need to have control of that service."

Other complaints have stemmed from reported hour-or-more rides for some disabled passengers.

The service has also been inundated with new customers by changing provincial legislation that required DARTS to serve a broader array of passengers over a longer time frame each day.

Dixon said he is not suggesting an end to the often criticized shared-ride model of service, which involves the same vehicle picking up and delivering passengers on the same ride.

"We think it will help to better match customers to a more appropriate type of vehicle delivery," he said.

The presentation suggests DARTS is wasting money using buses to transport relatively few passengers over long distances. It recommends buying more but smaller accessible vans, as well as sedans for riders who don't have wheelchairs.

Dixon said he's not recommending folding the disabled transit service completely into the HSR.

Coun. Sam Merulla has repeatedly called for that move. But he said Friday the important thing is to start "rebuilding" an "antiquated" paratransit system.












LOCATION PLAN

## To Amend By-law No. 01-215 Being a By-law To Regulate Traffic

#### **COUNCIL DIRECTION**

Council at its meeting of January 14, 2019 approved the following motion:

That staff be directed to work with the Waste Management Advisory Committee to determine the types of packaging being utilized by vendors for the sale of legal recreational and medical cannabis and report back to the Public Works Committee, with that report to include whether or not those materials are recyclable and the cost associated for recycling or disposal of those materials at a landfill.

#### INFORMATION

As of October 18, 2018, Ontario residents can purchase cannabis online from the Ontario Cannabis Store (OCS) and following that, on April 1, 2019, Ontario residents can purchase cannabis at legal cannabis retail stores. Hamilton has two legal retail stores, one located in East Hamilton and one located in Dundas which are expected to open sometime in the month of April.

# SUBJECT: Cannabis Packaging Recycling and Waste Control (PW19037) (City Wide) - Page 2 of 4

The OCS is the exclusive legal online store that provides Ontarians with cannabis products from Health Canada approved cannabis producers. Each licensed producer supplies the OCS with product which is packaged and labelled with the producer's labels. The OCS then packages each order for shipping through Canada Post from their warehouse(s). Currently, there are 24 licensed cannabis producers that supply products to the OCS.

The two legal cannabis retail stores in Hamilton receive the exact same packaging as the OCS from the 24 licensed cannabis producers.

## **Packaging Material**

Regulations under the Cannabis Act established the packaging requirements for cannabis. Health Canada enforces these regulations that require the packaging to:

- protect against accidental consumption (the package must be child-proof and odour-proof); and,
- be opaque or translucent.

Aside from the requirements above, there is little standardization in the containers that Cannabis is packaged in aside from the sizes which are designed to contain 1 gram. When cannabis is mailed by the OCS, it has additional packaging including each individual container being wrapped in plastic film, bubble wrap and boxboard which is then covered in kraft paper. That means that if an individual orders 3 grams they will receive 3 individual packages in the mail with each package including an individual container with all of the additional packaging listed above. Cannabis purchased from retail stores does not require the plastic film, bubble wrap, boxboard and Kraft paper.

As the regulations under the Cannabis Act lack direction on the type of packaging material that must be used, packaging can vary between cannabis producers. Table 1 lists the materials (as shown in Appendix "A" attached to Report PW19037) used by cannabis producers, retail stores and the OCS to package cannabis products, and includes details about the recyclability of these materials in Hamilton.

#### Cost to Hamilton

To determine the quantity of material generated by cannabis producers that the City must manage, staff reached out only to the OCS for information on the quantity of material shipped to Hamilton given that the retail stores have yet to open. Unfortunately, requests for this information have gone unanswered. Consequently, staff filed a formal Freedom of Information (FOI) request with OCS. The information that has been requested by staff includes the number of deliveries sent to Hamilton and the average weight of these deliveries. Knowing this information will allow staff to estimate the amount of actual packaging entering the waste stream managed by the City and the associated cost. As of the writing of this report, no response to this FOI request has been received.

It is important to note that producers of blue box material pay stewardship fees to Stewardship Ontario to help fund the blue box program. Stewardship Ontario requires all Ontario based companies that exceed 2 million dollars in revenue and generate packaging and paper products to register as a Steward and pay the associated fees. The OCS is a registered steward but currently, none of the twenty-four cannabis producers are. The City is therefore only partially compensated for blue box material generated by the OCS but not for any non-recyclable material generated by OCS or any material generated by the twenty-four cannabis producers (recyclable or not).

**Next Steps** 

Once the OCS responds to the FOI request, staff will update the estimated costs for processing applicable recyclable material and disposal to landfill. This information will be sent back to Public Works Committee through the Waste Management Advisory Committee minutes. In the meantime, staff will continue to advocate for full producer responsibility of the blue box program through future regulations formed under the Waste-Free Ontario Act. Staff will also work with industry groups such as the Association of Municipalities of Ontario and the Municipal Waste Association to advocate for less packaging in the distribution of cannabis and cannabis products.

#### COUNCIL DIRECTION

Public Works Committee, at its meeting of September 17, 2018 approved the following:

This Information Report has been prepared by staff to address "the concerns respecting DARTS safety and scheduling raised by Jonathan Jones, and report back to the Public Works Committee".

#### **INFORMATION**

Concern: ProMaster vans are not practical for oversized wheelchairs. The design has seats along both sides (often towards the front) and a narrow ramp up, which makes it more difficult for individuals in wheelchairs to position themselves.

# SUBJECT: Scheduling and Safety Concerns with DARTS (PW19038) (City Wide) - Page 2 of 3

## Response:

- The standard ProMaster has a 34-inch ramp and the extended ProMaster is a 36-inch rear loading ramp. These ramps are wider than the ramps on our conventional fleet and therefore provide a bit more room to manoeuvre in and out of given the layout of the vehicles.
- The seats along the sides flip up to allow oversized wheelchairs.
- Passengers are able to drive up rear ramp into position.

Concern: DARTS scheduling should be brought back in-house. DARTS is refusing rides due to overbooking/double-booking and are wait listing clients too far out. Response:

- The scheduling team works with clients to try and accommodate ride time requests; rides that we are unable to schedule at the time of the request are placed on a wait list.
- Our records (electronically-tracked performance data) show that refusal numbers are down since 2016. The combination of changing fleet composition and rapidly rising ride requests presents scheduling challenges that we work to improve on a day-to-day basis.
- We have experienced a significant increase in ridership over the last few years and are trying to maintain and/or increase service levels within approved budgets.

Concern: Employees of the subcontractor (Hamilton Cab) talk on their cell phones during passenger load and/or transport.

## Response:

- Passengers should report incidents of poor service to us, noting vehicle number and time of day. We can be reached by calling 905-529-1212 or by emailing ats@hamilton.ca
- We immediately follow up with DARTS (who contacts their subcontractor) for corrective action when we receive a complaint.

Concern: ProMaster does not have the capacity to transport as many passengers as DARTS buses.

## Response:

- This is true, but as outlined in report PW16015, presented to Public Works Committee in February 2016, we found that 70% of our rides carry only one mobility device at a time, and therefore we could move to smaller vehicles such as the MV-1s and ProMasters.
- Council approved our recommendation to increase the accessible and nonaccessible van fleet and reduce the bus fleet.

# SUBJECT: Scheduling and Safety Concerns with DARTS (PW19038) (City Wide) - Page 3 of 3

Concern: Walkers are not always tied down, putting passengers at risk. Response:

- Walkers in MV-1's and vans are to be placed in the trunk of the vehicle.
- ProMasters have a place in the back of vehicle with tie-downs to keep them secure.
- Passengers should report incidents of a walker not being tied down, noting vehicle number and time of day, so that we can follow up with DARTS. We can be reached by calling 905-529-1212 or by emailing ats@hamilton.ca

Concern: Fire safety is negatively impacted by the ProMaster design and breaches of safety rules.

## Response:

- Evacuation is discussed during driver training; in the event of an emergency, both the rear door and the side door are exit points.
- All vehicles are equipped with cutting tools to cut safety belts if an evacuation is necessary.

Concern: DARTS is sending three separate vehicles to one location. Response:

- Smaller vehicles mean more vehicles to locations for passengers.
- As outlined in report PW16015, presented to Public Works Committee in February 2016, the instances of large groups travelling were few enough that they could be handled cost effectively with multiple vehicles.
- We are working with groups to help them get used to the possibility of multiple vehicles arriving by promoting use of the "Where's My Ride" and "Next Bus" mobile applications to track their rides.

Concern: The suspension system in ProMaster vehicles is substandard and passengers in the back of the vehicle are jolted around. Response:

- The ProMasters are equipped with an enhanced suspension system designed to stabilize and level the vehicle. It provides a more comfortable ride by absorbing road shock and improving roll stability.
- While we do not have hard data regarding this concern, anecdotally, requests for a front seat have always been greater with vans than with buses.

Moving Hamilton Towards a Zero Plastic Waste Plan (City Wide)

WHEREAS, pollution from plastics are a growing and direct threat to ecosystems, food chains and human health;

WHEREAS, the City of Hamilton's ability to accept specific plastics and other recyclables was significantly impacted by global markets, forcing formerly recyclable items like black plastics and polystyrene foam into landfill and the environment;

WHEREAS, in 2018, Hamilton only diverted 34% of all waste from landfill;

WHEREAS, many single-use plastics, such as straws, utensils and stir sticks were never recyclable in Hamilton's program;

WHEREAS, municipalities can play a significant leadership role in addressing the tremendous damage done by plastic pollution by exploring new and alternative approaches to support institutional, organizational, corporate and business excellence in achieving zero plastic waste in landfills and the environment;

WHEREAS, Vancouver, Victoria, Halifax and Montreal have successfully introduced or approved measures to reduce and/or eliminate polystyrene foam and/r single-use plastics going into landfill and the environment, and both Edmonton and Toronto are reviewing what other municipalities are doing to reduce single-use plastics and how to best curb their use; and,

WHEREAS, the Province of Ontario is weighing options for regulations that would lead to full producer responsibility of single-use plastics as part of a broader strategy to send less waste to landfills;

#### THEREFORE, BE IT RESOLVED:

That staff report back to the Public Works Committee with information on the feasibility of the City of Hamilton creating a Zero Plastic Waste Plan that includes:

(a) Quantify single-use plastics, polystyrene foam and other products that never were or are no longer accepted by our municipal recycling program and identify items that have readily available re-useable or compostable alternatives;

- (b) Investigate options for the City of Hamilton to develop a strategy to enable businesses, City facilities and City permitted events to move towards zero plastic waste when alternatives are available;
- (c) Review regulatory options for the City of Hamilton to limit or eliminate the acceptance of polystyrene foam and single-use plastics to City landfills, including public education, consultation with business, supplementation of provincial regulations and other methods of increasing landfill diversion rates; and,
- (d) Report back with any costs or savings that may be incurred or realized by implementing a City-led Zero Plastic Waste plan.
