(b) CONSIDERATION OF CLERK'S REPORTS RESPECTING CONTRIBUTORS WHO APPEAR TO HAVE CONTRAVENED THE CONTRIBUTION LIMITS UNDER SECTION 88.9 (1) & (4) OF THE MUNICIPAL ELECTIONS ACT (Item 4)

The Chair made the following opening statement:

This Election Compliance Audit Committee meeting has been convened pursuant to Section 88.34 (8) of the Municipal Elections Act, 1996, to consider the matter of the Clerk's Reports respecting Contributors who appear to have exceeded the maximum allowable contribution limits to any one candidate or two or more candidates in an election.

The Chair called upon J. Pilon, Acting City Clerk, to provide an overview of the meeting procedures, as follows:

As per the Procedures for the Election Compliance Audit Committee, where a meeting of the Committee is required to consider a Clerk's Report respecting Contributions, the Clerk shall give reasonable notice to the contributor, and to the candidate(s) or registered third party of the time, place and purpose of a meeting and of the fact that if any party fails to attend the meeting, the Committee may proceed in the party's absence and the party will not be entitled to further notice in relation to the meeting.

Notice was provided to all respective Contributors and all respective Candidates on May 7th by Registered Mail.

The procedure the Committee will follow for each of the Clerk's Reports being considered at today's meeting, will commence with a presentation by the Acting City Clerk. The Acting City Clerk will address the Committee; the members of the Committee may, through the Chair, ask questions of the Acting City Clerk; and the Contributor and Candidate shall be permitted to view any documents submitted by the Acting City Clerk.

The Contributor or the Contributor's agent will then be given an opportunity to address the Committee and may respond to the content of the Acting City Clerk's address to the Committee; the members of the Committee may, through the Chair, ask questions of the Contributor; and the Acting City Clerk and the Candidate shall be permitted to view any documents submitted by the Contributor.

The Candidate or the Candidate's agent may address the Committee. The Candidate may respond to the content of the Acting City Clerk's or Contributor's address to the Committee; the members of the Committee may, through the Chair, ask questions of the Candidate; and the Acting City Clerk and the Contributor shall be permitted to view any documents submitted by the Candidate.

Following the presentations, the members of the Committee shall each have an opportunity to speak to the matter and may retire to deliberate in private before rendering its decision.

The decisions of the Committee, will be in writing, and shall set out the reasons for the decision, and shall be signed by the members who concur in the decision. If warranted the members can in addition to the written decision, may deliver an oral decision at the meeting. Once the Committee has made their decision, the Clerk will forward the notice of the Committee's decision to the Contributors at the mailing addresses provided to the Clerk.

(i) Contributors who Appear to have Contravened the Contribution Limits under Section 88.9 of the Municipal Elections Act – Venus Llandino (CL19002) (City Wide) (Item 4.1)

The Chair invited the Contributor and Candidate to identify themselves and any agents attending on their behalf.

The Acting City Clerk addressed the Committee respecting the Clerk's Report (CL19002) concerning the contributions made by Venus Llandino to Elenita Ranas' 2018 Election Campaign. Venus Llandino's contribution of goods and services in the amount of \$1,400 to Elenita Ranas' campaign, exceeds the maximum allowable contribution of \$1,200 to any one candidate in an election (Section 88.9 (1) of the Act).

The Contributor, Venus Llandino, advised the Committee that her contribution was only \$1,000 and that her husband contributed \$400 and provided receipts substantiating her claim.

The Candidate, Elenita Ranas, confirmed that the total contribution amount of \$1,400 in the sole name of Venus Llandino, should have been split between Venus Llandino (\$1,000) and Albert Llandino (\$400) and provided a documented explanation substantiating her claim.

(ii) Contributors who Appear to have Contravened the Contribution Limits under Section 88.9 of the Municipal Elections Act – Ralph Pagliuso (CL19003) (City Wide) (Item 4.2)

The Chair invited the Contributor and Candidate to identify themselves and any agents attending on their behalf.

The Acting City Clerk addressed the Committee respecting the Clerk's Report (CL19003) concerning the contributions made by Ralph Pagliuso to Fred Eisenberger's 2018 Election Campaign. Ralph Pagliuso's apparent contribution of funds in the amount of \$2,200 to Fred Eisenberger's campaign, exceeds the maximum allowable contribution of \$1,200 to any one candidate in an election (Section 88.9 (1) of the Act).

The Contributor, Ralph Pagliuso testified that he only donated one contribution of \$1,000, and provided receipts substantiating his claim.

Chris Cutler, the campaign manager for Fred Eisenberger, explained that a second donation of \$1,200 was reported as coming from Ralph Pagliuso due to a cut-and-paste error and that the \$1,200 donation was, in fact, from another contributor whom he was unable to identify.

(iii) Contributors who Appear to have Contravened the Contribution Limits under Section 88.9 of the Municipal Elections Act – Sergio Manchia (CL19004) (City Wide) (Item 4.3)

The Chair invited the Contributor and Candidate to identify themselves and any agents attending on their behalf.

The Acting City Clerk addressed the Committee respecting the Clerk's Report (CL19004) concerning the contributions made by Sergio Manchia to Eve Adam's; Chad Collins'; John-Paul Danko's; Fred Eisenberger's; Jason Farr's; Laura Farr's; Lloyd Ferguson's; Tom Jackson's; Sam Merulla's; Maria Pearson's and Terry Whitehead's 2018 Election Campaigns. Sergio Manchia's contribution of funds in the amount of \$5,300 to Eve Adam's; Chad Collins'; John-Paul Danko's; Fred Eisenberger's; Jason Farr's; Lloyd Ferguson's; Tom Jackson's; Sam Merulla's; Maria Collins'; John-Paul Danko's; Fred Eisenberger's; Jason Farr's; Laura Farr's; Lloyd Ferguson's; Tom Jackson's; Sam Merulla's; Maria Pearson's and Terry Whitehead's campaigns, exceeds the maximum allowable contribution of \$5,000 to two or more candidates for office on the same council or local board (Section 88.9 (4) of the Act).

The Contributor, Sergio Manchia testified that he made an error in estimating the value of goods and services contributed in-kind to Fred Eisenberger's campaign and acknowledged that he did contravene the *Municipal Elections Act* by inadvertently overcontributing and apologized for his error.

²Section 17(3) of the *Municipal Elections Act, 1996*:

The following are prohibited from voting:

- 1. A person who is serving a sentence of imprisonment in a penal or correctional institution.
- 2. A corporation.
- 3. A person acting as executor or trustee or in any other representative capacity, except as a voting proxy in accordance with section 44.
- 4. A person who was convicted of the corrupt practice described in subsection 90 (3), if voting day in the current election is less than five years after voting day in the election in respect of which he or she was convicted.

Dear Committee,

I am writing to you in support of my application for an Election Compliance Audit in respect of John Vail's campaign for Ward 2 Councillor for the election on October 22, 2018.

I believe Mr. Vail has likely contravened subsection 88.9.1(1) of the *Municipal Elections Act* (the "Act") related to contributions by the candidate and his spouse in excess of the prescribed limit.

The prescribed limit in respect of the Ward 2 Council election was \$8,971.40.

Mr. Vail's self-reported self-financed amount was \$8,315.57 under his attached Form 4.

However, Mr. Vail reported a value of \$0 for election signs repurposed from a prior provincial election campaign, at Table 4 on page 6. I noted Mr. Vail used these signs, from his race with the Progressive Conservative Party of Ontario, in the campaign. They were cut down so as to hide the PCPO branding, but were unquestionably those same signs and they stated "VOTE JOHN VAIL".

A value of zero cannot be an appropriate valuation of those signs.

The value of goods and services donated to a campaign, for the purposes of the Act, is not their value in present condition. Value is determined by 88.15(5)(b) of the Act:

(5) The value of goods and services provided as a contribution is,

(a) if the contributor is in the business of supplying these goods and services, the lowest amount the contributor charges the general public in the same market area for similar goods and services provided at or about the same time;

(b) if the contributor is not in the business of supplying these goods and services, the lowest amount a business providing similar goods or services charges the general public for them in the same market area at or about the same time. 2016, c. 15, s. 53 (3).

I believe that a sign order from a commercial sign company for similar signs in similar volume would

be unlikely to be fulfilled for less than \$655.84, and therefore I believe that Mr. Vail exceeded his contribution limit under section 88.9.1 of the Act.

I request a compliance audit on whether Mr. Vail has exceeded the 88.9.1 limit, and to determine whether there were any other violations of the Act in relation to the donation and use of these signs.

I am writing to you to take notice of the expenditures of Ward 12 Councillor Lloyd Ferguson for the 2018 municipal election. He has substantially exceeded the spending limit for "the cost of holding parties and making other expressions of appreciation after the close of voting" established under subsection 88.20(9) of the *Municipal Elections Act, 1996,* S.O. 1996, c. 32 (the "**Act**").

Mr. Ferguson's expenditures, as detailed below, are on the face of his filed Form 4 in excess of the spending limit prescribed by regulation, which you established as \$3,025.18. Mr. Ferguson's expenses as provided by his Form 4 (attached) on the cost of holding parties and making expressions of appreciation after the close of voting were \$4,088.23.

Mr. Ferguson's spending exceeded the maximum prescribed by law by \$1,063.05, over 35% in excess of the lawful limit.

As you will know, the legal penalty for exceeding the spending limit established under subsection 88.20(9) of the Act is established by paragraph 88.23(1)(c) and subsection 88.23(2):

- Mr. Ferguson forfeits the office of Ward 12 Councillor; and
- Mr. Ferguson is ineligible to be elected or appointed to any office under the Act until after the next regular election.

As you will further know, the above being the case your mandatory legal duty is established by subsection 88.23(3):

- you must notify Mr. Ferguson and the Council of the City of Hamilton in writing of the default; and
- you must publicly announce Mr. Ferguson as having defaulted under the Act with a description of the default.

I request that this be announced as soon as possible once you have verified Mr. Ferguson's default, and I asked to be kept up to date on your deliberation in this regard on this extremely important matter of clean government and clean elections. My telephone is in the letterhead.

The Default

Mr. Ferguson's Form 4 "shows on its face" that he has outspent the limit established under subsection 88.20(9). His Form 4 describes two such expenses:

- a "volunteer appreciation" expense, correctly disclosed on Page 2 as "Expenses subject to spending limit for parties and other expressions of appreciation", and totalling \$2,435.60; and
- an expense for "Thank You Voters notice in News Paper", believed to be related to two announcements after Election Day in the *Ancaster News* and the *Flamborough Review*, incorrectly disclosed under "Expenses not subject to spending limits--Other" on page 3, and totalling \$1,652.63.

As "Thank You" is an "expression of appreciation", Mr. Ferguson's Form 4 shows on his face that he has exceeded the spending limits for "the cost of holding parties and making other expressions of appreciation after the close of voting" by incurring \$4,088.23 of such costs.

I request that you act forthwith to declare the position of Ward 12 Councillor forfeited, immediately. There is no permissible alternative to this action under the Act. I remind you of your duty to faithfully carry out the Act, and the penalties established by subsection 90(6) for failing to do so wilfully.
