WHEREAS, the City of Hamilton has declared a climate emergency with a mandate to achieve net zero carbon emissions before 2050:

WHEREAS, TradePort International Corporation as a subsidiary of Vantage Airport Group has a mandate from the City of Hamilton to operate John C. Munro Hamilton International Airport and grow passenger and cargo volumes in order to maximize the economic potential of the airport and surrounding Airport Employment Growth District (AEGD);

WHEREAS, the City of Hamilton is currently in negotiations to extend the current Head Lease between the City and TradePort (Vantage Airport Group);

WHEREAS, the City of Hamilton recognizes that climate action and the low-carbon transition represents a massive opportunity for economic stimulation and growing job opportunities in the new low-carbon economy;

WHEREAS, air travel and air cargo have a significant inherent carbon footprint;

WHEREAS, John C. Munro Hamilton International Airport is ranked as North America's fastest growing airport and is known as Canada's busiest overnight express cargo airport;

WHEREAS, air travel passengers and air cargo consumers are increasingly concerned about the carbon footprint of their consumption choices;

WHEREAS, Greater Moncton Romeo LeBlanc International Airport under management by Vantage Airport Group has achieved Airport Carbon Accreditation Level 2 – Reduction and is working towards Level 3 – Optimization;

WHEREAS, increased uncertainty, severity and frequency of extreme weather events as a result of climate change have been observed in the Hamilton area and are projected to increase into the future;

WHEREAS, air travel and air cargo operations are vulnerable to unforeseen severe weather events and disruptions caused by such events could result in significant travel disruptions and monetary losses; and,

WHEREAS, London Luton Airport and Cardiff Airport as comparator airports have commissioned climate change studies to identify the resiliency of their operations to future climate change impacts;

THEREFORE BE IT RESOLVED:

- (a) That the City of Hamilton request that Vantage Airport Group commit to the implementation of the four stage Airport Carbon Accreditation program (or agreed alternative) at John C. Munro Hamilton International Airport, with the goal of achieving net-zero carbon emissions before 2050;
- (b) That the City of Hamilton request that Vantage Airport Group commit to an evaluation of the resiliency and preparedness of their operations and assets due to potential climate change impacts and develop a prioritised risk assessment and adaptation plan; and,
- (c) That the City of Hamilton negotiating team include these actions as part of the current negotiations to extend the Head Lease between the City and TradePort (Vantage Airport Group).



John C. Munro Hamilton International Airport is pleased to publish "The Runway" - a quarterly e-newsletter communicating key highlights of the Airport's performance and achievements.



National Trade Corridor Funding for Hamilton International Airport

John C. Munro Hamilton International Airport will undergo an Airfield Rehabilitation and Modernization Project to fully restore its two main runways, supporting taxiways and lighting systems over the next four years, starting in August 2019. These projects will improve the efficiency, reliability and safety of airport operations, accelerate investment to accommodate the increasing use of larger wide-body aircraft for domestic and long-haul traffic to support current and future growth through Hamilton International.



"Modernization of Hamilton International's runways, taxiways and lighting systems will ensure longevity of this critical infrastructure, and position the Airport to continue serving a strategic transportation and trade corridor, and the many businesses who rely on connections to port, train, major route highway and U.S. border routes to access new markets for Canadian imports and exports," said President & CEO, Cathie Puckering. "We look forward to completing these critical infrastructure improvements so that Hamilton International can continue to deliver on its vision to be the best global gateway in Canada for affordable travel and goods movement and continue to be a key economic contributor in our region."

The total project cost is \$38.89 million, and Transport Canada's National Trade Corridor Fund (NTCF) will contribute \$18.54 million, with the balance funded by airport operator TradePort International Corporation, as part of its capital investment plan. To minimize closures and interruption to existing 24/7 operations, airfield work will be completed in phases.





- 62% need to extend hours to accommodate early morning (first bus arrives 525AM however, airport activity as of 4AM) and late evening (last bus departs at 728PM however, airport activity until 8PM)

Monitoring and minimizing the environmental impact of airport operations is important to Hamilton international. The Airport is committed to protecting the environment and to safeguarding the health of its employees, business partners and the general public.

PFAS MANAGEMENT AND MITIGATION

A **Preventive Measures Order** (a "PMO") has been finalized to address legacy environmental impacts associated with Transport Canada's historical firefighting practices.

Working jointly with the Ministry we developed and, as of **September 16, 2019**, has implemented, a **Mitigation Plan** that calls for:

- the dewatering and restoration of an existing stormwater retention pond;
- excavation and long-term containment of PFAS-impacted soil and sediment; and
- the creation of a capped area on the former fire-fighting training area.

Following construction of the capped area, ongoing monitoring and inspections programs will be conducted to demonstrate the contamination is mitigated.

This collaborative process demonstrates our ongoing commitment to public safety and the protection of the environment.

TAKE ACTION ON CLIMATE CHANGE



As a member of Sustainable Hamilton and Burlington (SHB) since 2017, Hamilton International is committed to a collaborative approach to manage the Airport's carbon footprint. Focus areas include:

Established Ten-Year Goal

- Reduce total Carbon-dioxide equivalent (tCO2e) by 20%.
- Measurement intensity factor for green house gases/total employee hours.
- Lighting, HVAC, Sensors


