**BY-LAW NO. 19-253**

**To Amend By-law No. 03-126**

**Being a By-law for Prohibiting and Regulating the Alteration of Property Grades, the Placing or Dumping of Fill, and the Removal of Topsoil**

**WHEREAS** Council enacted a by-law for Prohibiting and Regulating the Alteration of Property Grades, the Placing or Dumping of Fill, and the Removal of Topsoil being City of Hamilton By-law No. 03-126;

**AND WHEREAS** this By-law amends City of Hamilton By-law No. 03-126;

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Subsection 3.3.1 of By-law No. 03-126 is deleted and replaced by the following new subsection 3.3.1:
  - 3.3.1 Notwithstanding any other provision of this By-law, no person, on any lands in the City of Hamilton, including any lands which are submerged under any watercourse or other body of water, shall place or dump fill or cause or permit the placing of dumping of fill that has been excavated from and removed from a location that is outside the City of Hamilton.
2. This By-law applies to any permits, as that term is defined in By-law No. 03-126, issued, extended or renewed after the coming into force of this By-law, but does not apply to any permits issued prior to the coming into force of this By-law.
3. This By-law comes into force on the date it is passed.
