Built Environment Working Group Notes October 1, 2019

Present: Lance Dingman, John Hawker, Mary Sinclair (contributing past member ACPD) and Jayne Cardno

Those present expressed disappointment that only 3 committee members were present.

The Group reviewed work in progress and listed outstanding business with some priorities indicated.

Re Built Environment - structures, recreational facilities, parks, and roadways to review

Some urgency in addressing Winter issues that have been raised frequently:

- Staff from Public Works have presented and answered related questions that indicated the need to move forward with bringing 2 other departments together with Public Works. They are By-Law and Property Standards. Concerns include clearing intersections, bus shelters and stops, sidewalks and bicycle paths. Noted previously were guidelines that allow bicycle paths to be cleared quickly and how they allowed mixed use that included mobility devices. Metal plates were identified as a slip and fall hazard.

ACPD Ask: That we take immediate action to bring these three departments together for a discussion on how to move forward on winter mobility concerns. Motion to be shaped and put forward.

The Housing Working Group is keen to hear from Mr. Edward John regarding the now long-standing list of questions prepared early last spring.

Because subsidized and social housing is a top City, federal and provincial concern and a number of groups are working on housing concerns there was discussion around inviting such groups to hear the presentation and questions for Edward John. The Housing and Homelessness Advisory Committee and the Seniors Advisory Committee were two such groups.

A sample of concerns and questions relate to the percentage of units that will be accessible as well as an accessible application process that could include a number of the 40-some housing providers in the City.

- A priority is to support 15% percent of all new builds as being accessible units.
- Housing Guide - action via email to inform key organizations of the availability online and in print (45 copies)
- On-going work on providing detail regarding accessibility issues with current application for housing used by Access to Housing.

Mandate:

The Advisory Committee for Persons with Disabilities recommends to the City of Hamilton policies, procedures and standards that address the needs and concerns of persons with disabilities.

Composition:

The Advisory Committee for Persons with Disabilities shall be comprised of 18 citizen members and one Member of Council.

The majority of members of the ACPD will be persons with disabilities in accordance with the *Ontarians with Disabilities Act, 2001*.

The membership should reflect a wide range of disabilities and should advocate for all disabilities.

Terms of Reference:

1. To advise Council annually about the preparation, implementation, and effectiveness of its accessibility plan required pursuant to the Ontarians with Disabilities Act (ODA), the Accessibility for Ontarians with Disabilities Act (AODA), and related regulations.
2. To ensure that the right of access for persons with disabilities to programs and services provided by the City is sustained, maintained, and/or improved in accordance with Provincial legislation, regulations and City standards, and/or policies.

3. To review and comment to Council and other levels of government on pertinent reports, proposed legislation and studies which affect all persons with disabilities, where appropriate.
4. To provide a forum where persons with disabilities and service representatives can express their concerns, share information and recommend improvements to the existing level of City services for persons with disabilities, while taking into consideration a wide spectrum of disabilities in discussions and decision making.
5. To educate and increase awareness to City Council on issues which affect people with disabilities.
6. To support the work of the Committee through Sub-Committees and Working Groups, as required, and specifically related to the Provincial standards, including Customer Service, Housing; Transportation, Employment, Built Environment, and Information and Communications.
7. To maintain knowledge of the work of the committee through attendance at meetings and review of agendas and supporting materials.
8. To regularly review the progress and measure the success of the committee and its activities.
9. Committee members missing three consecutive meetings without appropriate notification to the Chair or Staff Liaison shall be considered as resigned from the Committee thereby reducing the required number for quorum.
