School Zone Safety Petition Regarding Arterial Roads and Elementary Crossings

On December 1, 2020, at the intersection of Upper Gage Ave. and Royalvista Dr., Jude Strickland was struck and killed by a driver at an intersection controlled by both a traffic light and a crossing guard. Both measures failed to save this 11-year old's life. This accident was preventable, but the short sightedness of decisions made in recent years that have affected neighbourhood elementary schools and traffic calming have caused a dangerous atmosphere for our children.

This petition is to request City Council and Tom Jackson in particular take note of the issue and take immediate steps to prevent future incident.

We would like, effective immediately, the stretch of road on Upper Gage Ave from Stone Church Rd to Rymal Rd be set to 40km/h as this stretch is a required crossing for pre-High School children to attend Templemead School.

Road Resurfacing and Sidewalk Replacement on Oakland Drive (between Kentley Drive and Ellingwood Avenue) and Ellingwood Avenue, Hamilton (Ward 5)

- (a) That Public Works staff be authorized and directed to resurface the roads and replace the sidewalks on Oakland Drive, Hamilton, between Kentley Drive and Ellingwood Avenue, at an estimated cost of \$590,000 to be funded from the Ward 5 Area Rating Reserve Account (#108055);
- (b) That Public Works staff be authorized and directed to resurface the roads and replace the sidewalks on Ellingwood Avenue, Hamilton, at an estimated cost of \$410,000, to be funded from the Ward 5 Area Rating Reserve Account (#108055); and,
- (c) That the Mayor and City Clerk be authorized and directed to execute any required agreement(s) and ancillary documents, with such terms and conditions in a form satisfactory to the City Solicitor.
