An overall review of the FC process is being completed by senior staff and will report back.

6. Removing Holding Provisions (HP) – Steve Robichaud

DILG members relayed their concerns regarding the HP holding up the building permit. Staff advised some reasons are the older by-laws are not clear to the site requirements. Action: Tony and Steve to review and report back on changes to the language in the condition(s) relating to the Holding symbol to provide clarity as to when the Holding zone can be lifted.

7. GRIDS 2 and Municipal Comprehensive Review Process Submission Hamilton Chamber of Commerce - Paul Szachlewicz

8. Modern Surety Bonds Update – Kirk Weaver

Finance staff are still working with Legal Services who are assisting with drafting the language. Advised they have gathered wording from other jurisdictions and will circulate with the group once completed.

9. Low-Rise Zoning Building Height & Grade – Steve Robichaud

Staff received good feedback from the workshop held and are drafting zoning regulations which will include diagrams in the document for easy/friendly reference use.

10. GRIDS-2 / LNA – Status Update / Next Steps – Steve Robichaud

GRIDS 2 and Municipal Comprehensive Review – Final Land Needs and Assessment, and Evaluation Framework and Phasing Principles will be presented at the Special GIC meeting on March 29 for approval.

Report PED21064 - Growing the Greenbelt is projected to be on the PC agenda for April 6. The Province is seeking feedback on ways to grow the size and further enhance the quality of the Greenbelt; the City will provide their comments to the Province.

11. Waste Design Requirements Update – *Steve Robichaud*

Waste and Planning staff continue to review the comments provided by WE HBA and will be responding to WE HBA's letter by letter in the next couple of weeks. A current status of the Design Requirements project will be provided to members of the Waste Management Advisory Committee on March 9th. A council report will not proceed to Public Works Committee until staff have finalized discussions both internally and with WE HBA. The goal is to attend PWC in Q2.
