*12.1. Municipal Law Enforcement Weekly Updates to Council

- 1. Today Planning Committee deals with the future of Ancaster Village. Bold words, but the truth.
- 2. Your decision is not just about the fate of Phillipo House at 398 Wilson Street East. It is about the streetscape that defines Ontario's third oldest community—Ancaster 1793

It is obvious Philippo House would have disappeared overnight with its neighbours save for this designation.

3. The Ancaster Wilson Street Secondary Plan was developed after commendable consultation with the community. I will simply say that the core of this Plan is preservation of the unique character of Ancaster with a primary focus on the Village Core. Design guidelines preserve the Village and I am not aware of any other secondary plans that have this detail. This is unique, and needs your careful consideration.

The underpinning of a decision on Philippo House should be a careful read of the Secondary Plan and the special attention it pays to the Village Core.

- 4. The C5a zoning for the Village Core is unique in Hamilton as it requires a specific height—9 meters—and spacing between buildings. This preserves the three dimensional character of the heritage buildings in the Core—you see the side of the building as well as the front. The Ancaster Village Core is VERY different from Dundas, for example, where the buildings touch each other. The Ancaster zoning in the Village Core reflects that—it is the streetscape of a 1793 village rather than a late 1800s community we also consider heritage.
- 5. The Wilson streetscape east of Phillipo House has already largely been destroyed or is under threat. Three years ago there were 12 unique buildings between Academy Street and Rousseaux Street, a distance of about 2 blocks.

Today there are 8 left.

Two more have been identified for demolition in a proposed development, one may or may not survive as part of that development, and this Committee is considering whether the most important one of all can be removed.

When the developers are done about 60% of the streetscape in two blocks of the Village Core will be gone. *(See note below for details)

6. The heritage designation of Philippo House is "in place". If it is moved the heritage designation ends and the building has no protection in a new location.

The 1978 Public Notice designating 398 Wilson Street is more powerful than any words I can craft.

I quote "The use of stone as a construction material relates the building to several other important buildings on Wilson Street. For these reasons the building is of great importance to the Wilson Street streetscape"

The takeaway? "Great importance to the Wilson Street streetscape".

Will it even survive a move? Please take a careful look at the state of the stone work before answering this.

7. Much has been made about soil contamination migrating from the adjacent lot.

A critical question: was the soil **<u>beneath</u>** Phillio House sampled, or does this concern rest totally on estimations? It strikes me before a decision as critical as the one you face is made that this is a basic question; one easily answered.

In addition, has the air quality been sampled in Philippo House?

If there is concern about air quality, what remediation has been considered?

My understanding is that the City has flexibility to consider situations like this and exemptions have been granted in Dundas.

8. This decision is a footnote to a developer for a demolition plan creating the largest piece of development property in the Wilson Street Secondary Plan catchment area.

To the community......it is the key to whether there will be a true Village Core, or vast lengths of new construction that might sort of look historical..... if this Committee holds the developer to the Official Plan.

9. If a new building wraps around Phillipo House, in accordance with the setbacks in the zoning, and had some careful design, this could be the crown jewel of the Village Core.

The Ancaster Village Core has suffered too much heritage demolition because no one thought anyone would tear down pristine heritage buildings like Brandon House or the Marr House or try to move a designated building like Philippo House.

If you own this building and have as your goal the preservation of Phillipo House in place to protect the streetscape there are ways to do it.

If you own this building and want it out of the way no doubt you can come up with justification.

Please, follow the recommendation of staff and the Heritage Committee and ask this applicant to do better for Ancaster and take the path to preserve the diminished streetscape.

It has come to my attention that developers are proposing to attempt to move Marr House from its current location on Wilson street to pave their way to put up a 7 story development.

NO NO NO DO NOT ALLOW THIS TO HAPPEN !!!!

This historic/heritage building is fragile and must be preserved. So much of traditional Ancaster is being lost to intensification that we are losing our history and losing the small, home town village lifestyle that we love so much about life here in Ancaster. We have lost the Brandon House. We could lose the house at 15 Church street to a developer who was able to skirt over 21 by-law variances in an effort to build an oversized condo/townhouse development on a site that is far too small for the proposed development. Why should a developer's wishes be more important than the wishes of current residents??

At what point do we put our foot down and just say NO. Some things are worth saving and preserving. This old stone building has great historical value.

Do not allow our precious Ancaster to become another Brampton or such place where over-crowding and bulldozing of the old ways is considered acceptable.

Do not enable developers who have no long term vested interest or responsibility to our town and the health of our community call the shots. Developers are in the game to win and make their profits. Hello City Planning Committee,

I support the Marr House remaining where it is. Marr House is one of the very few remaining buildings on Wilson Street dating from the early era when Ancaster Village was first established, beginning at the end of the 18th century. It is a crucial link with the historic origins of Ancaster. Beside it until recently there had been a contemporaneous frame building, the Marr House - dated similarly to the Marr-Philippo House and closely associated with it - which was suddenly demolished without notice and without acknowledgment of its value to the Village by these same developers.

Developers propose to move the Marr-Phillipo House to an out-of-sight position at the rear of the lot - that is, if it survives the move, which is doubtful. If it survives, in its new location it will be lost to view, away from Wilson Street and hidden to the rear of a massive condominium development which is proposed on that large lot, **but most importantly and unknown to most other than the developers is that it loses its heritage-designated building status and associated protection**. According to plans presented by the developers to two local voluntary organizations, which were reported in the Ancaster News, the use of the Marr-Phillipo House in that new position will be restricted only to condominium residents, as an amenity. In their public presentations they threatened Ancaster residents that they will not go ahead with their plans if they are not allowed to move the Marr-Phillipo House.

This is another step in the destruction of Ancaster's unique position as the second earliest established village in Upper Canada.

The Marr-Phillipo building is remarkably well-preserved, but it is fragile. Moving it clearly represents a significant cost to the developers, which raises concerns about its ultimate preservation. Moving it will deprive Ancaster of another precious landmark, similar to the loss of the Brandon House over two years ago now.

We ask that you maintain Marr House's heritage designation, which can only be accomplished by keeping it where it is and has always been for over 180 years.

To whom it may concern:

I have read that you will be discussing/voting on the fate of the Philip Marr house which is currently located on Wilson Street in the "historic" area of Ancaster. I have already expressed my concern to council regarding the fate of this building if the developers are allowed to attempt to move it. I sincerely hope that you will stand up to the pressure of the developer and vote no to this proposal. Here are my reasons. I have learned that if there is an attempt to move a building from its current site this will result in that building losing its protection of its heritage designation. Take a moment to think about that! You will be negating the efforts of the group of local volunteers responsible for ensuring that the Marr house received its designation of a heritage building. I also understand that it is not an easy process to have a building designated as being historical.

According to current legislation the act of moving this building means that it will have been seen by law to have been demolished. It will lose its heritage designation and become vulnerable to demolition. My understanding is that the developers will then not be obligated to to ensure that the building survives the move. Your decision on this request will set a precedence. Why would any future developer make the effort to preserve any historical building if you can just apply to move it? This answers my question re: what happens if this historical building does not survive the move. Will the developers be responsible for ensuring that the Marr house survives the move intact? Apparently not.

Why is this even an issue? At one point in time developers were expected to try to blend in with the current streetscape and bylaws of our town. Take a look at The Barracks and the plaza where the Olive Board is located. Developers made an effort to blend in with the streetscape a few years ago but the current generation of developers appear to be all about cramming inappropriate projects in spaces where beautiful, historic buildings once stood as a reminder of our heritage.

Oh wait! I forgot! The planning board is not obligated to actually visit any of the areas where the decisions that they make will affect local residents. Apparently the voice of the people who reside in an area is not as important as the developers who come in with plans that are contrary to the current streetscape and as a result demand many variances.

So let me see if I have this straight. You are deciding the fate of a designated historical building in the historical area of Ancaster? If the request is granted the developers will not be required to preserve this historical building since the very act of moving the building nullifies its historical designation. The request is coming from developers, not the tax paying citizens of Ancaster who are currently being bombarded with a large number of new building projects.

If the Marr house is able to survive the relocation procedure, the proposed new location for the building is inappropriate. It will not blend in with the houses already in that area. It will be totally out of place. I beg you to say no to the request to move the Marr house. Take a step back and actually consider the wishes of the current residents of this area.

Application to relocate 398 Wilson St. E, Ancaster, ON

As a resident of Hamilton, I request the committee,

- Do not approve the application to relocate 398 Wilson St. E. The property know as The Marr House is an important heritage-designated building. If moved from its current location, it will be deemed to have been demolished.
- 2. Businesses benefit from locating in designated heritage preserved areas. Demolishing such buildings is economically flawed.
- 3. Remediation of The Marr House could use" in situ bio remediation". This technology is used elsewhere in the province for difficult sites thus allowing this heritage building to remain in it's current location if this is an issue for remediation and if the City of Hamilton grants public ERASE funds for the private site alteration.

In addition please note:

- Ministry of Environment should be apprised of the situation and there should be an investigation of the areal extent of the contamination. If hydrocarbons have migrated laterally to beneath the Marr House, then it's quite possible that these contaminates have migrated to beneath adjacent properties(ie: both sides of Wilson Street E). The developer, Wilson Street Ancaster Inc., as owner of the source of contamination is also responsible for remediation of everywhere contamination may have migrated from 392,398,406,412 Wilson E to other locations.

Hello City Planning Committee,

I support the Marr House remaining where it is. Marr House is one of the very few remaining buildings on Wilson Street dating from the early era when Ancaster Village was first established, beginning at the end of the 18th century. It is a crucial link with the historic origins of Ancaster. Beside it until recently there had been a contemporaneous frame building, the Marr House - dated similarly to the Marr-Philippo House and closely associated with it - which was suddenly demolished without notice and without acknowledgment of its value to the Village by these same developers.

Developers propose to move the Marr-Phillipo House to an out-of-sight position at the rear of the lot - that is, if it survives the move, which is doubtful. If it survives, in its new location it will be lost to view, away from Wilson Street and hidden to the rear of a massive condominium development which is proposed on that large lot, **but most importantly and unknown to most other than the developers is that it loses its heritage-designated building status and associated protection**. According to plans presented by the developers to two local voluntary organizations, which were reported in the Ancaster News, the use of the Marr-Phillipo House in that new position will be restricted only to condominium residents, as an amenity. In their public presentations they threatened Ancaster residents that they will not go ahead with their plans if they are not allowed to move the Marr-Phillipo House.

This is another step in the destruction of Ancaster's unique position as the second earliest established village in Upper Canada.

The Marr-Phillipo building is remarkably well-preserved, but it is fragile. Moving it clearly represents a significant cost to the developers, which raises concerns about its ultimate preservation. Moving it will deprive Ancaster of another precious landmark, similar to the loss of the Brandon House over two years ago now.

We ask that you maintain Marr House's heritage designation, which can only be accomplished by keeping it where it is and has always been for over 180 years.
