Mr. Mayor & Council,

I was reminded today that citizens Age 80+ who live in 50% of Ward 10 are still paying a surcharge to use our non-conventional public transit service.

Specifically, they are still charged an extra Transcab fee; unlike citizens Age 80+ living in Waterdown for example that have a superior On - Demand transit system.

While I appreciate On-Demand is a pilot, the continuation of this surcharge to our 80+ citizens in Ward 10, in my opinion, doesn't align to our Equity, Diversity & Inclusiveness policy.

All citizens Age 80+, no matter which area they live in or no matter what transit system is provided, should be treated equitably.

Please also note, these citizens & business owners (as shown in the Transcab boundary map below) are already paying & have been paying upwards of 30 years, an urban Transit levy in their property taxes

During this year's budget deliberations, I respectfully request that Council consider expanding the Golden Age policy to include all of Ward 10 citizens & absorb (waive) the Transcab surcharge fee.

Re: 2022 Municipal Budget Call for Action

Thank you for the opportunity to engage with you and voice our support of the Just Recovery Coalition's call for the 2022 Municipal Budget to work towards an equitable recovery for our Ambitious City.

The pandemic is not over and it continues to wreak havoc. Across the city, individuals and community groups have trusted us to understand the unique impacts that they're experiencing. The frontline agencies that we support have told us of devastating stories of isolation for their clients, burnout for their staff, and lower volunteer rates due to the risks involved. We've also heard from our donors and corporate partners of the emotional fatigue of those in their workplaces, due in part to the concerns and confusion of working from home and supporting families during this time. And, we know from our community partners that those who are most vulnerable – those with disabilities, and those experiencing or at risk of homelessness, and those experiencing other forms of systemic oppression such as racism, homophobia & sexism in their many forms – have been further isolated during this pandemic.

More than 43% of the agencies that we are connected with have reported increased demand for their services, in addition to inconsistent support for those increased costs that they are incurring. With this in mind, as well as the emotional effects of the pandemic noted above, we call on the City of Hamilton to centre those most vulnerable in the 2022 Budget. There are many possibilities to do this; we can prioritize accessibility in the HSR transportation budget and snow clearing practices, and increase the City Enrichment Fund to recognize the increased costs incurred by the social sector, and invest in housing as a municipality by supporting temporary and permanent solutions to our homelessness crisis. You can be assured that United Way is grateful for the opportunities we have had through our donors and partners to increase our funding and provide emergency supports, and we hope you will take this opportunity to do the same. Whatever the options brought forward, United Way Halton & Hamilton, as members of the Just Recovery Coalition, appeal to you to thoughtfully and creatively centre equity and community support in your decisions.

It is only when we are all supported that we can thrive as a city. We thank the Council for the opportunity to delegate, and for the commitment to the community that you exhibit in this process and beyond.

Happy Friday Councillor Wilson!

I hope this email finds you well. I am unfortunately unable to delegate virtually on Monday for the GIC Budget Meeting, and wanted to share my input on the budget with you in writing instead. I have also cc'd the Clerk's office with the hope that this can be included in the agenda.

Dear Councillor Wilson,

First, I was thrilled to see the recent motion directing staff to explore ways to make Hamilton's bike share system financially sustainable. I would like to **voice my strong support for the City to provide ongoing operational funding to bike share.** Hamilton Bike Share provides a reliable, affordable and year-round transportation and recreation option for tens of thousands of Hamiltonians, and visitors to Hamilton. Through projects like the Everyone Rides Initiative, Hamilton bike share has worked hard to provide a mode of transportation for residents who need it, and a 2018 study of North American Bike Share Systems also found that Hamilton was the only Canadian city where bike share access was greater in lower socioeconomic areas of the City. Other Canadian bike share systems, like those in Montreal and Toronto, receive public operational support, much like transit and roads are publicly supported. Hamilton's bike share network is essential to many, and should receive public operational support on an ongoing basis to reflect that.

Personally, I had never considered winter cycling an option for myself until I moved to Hamilton and had access to the bike share system. I cycled in the snow on my very first day living here, and continue to do so with the support of bike share. I also use it regularly to connect to GO transit.

Secondly, I would like to follow-up on the items I delegated about for the 2021 budget.

In February of last year, I voiced my support for the Just Recovery Hamilton proposals, and highlighted the need for city-wide winter sidewalk maintenance. I was encouraged to see the council vote to move forward with priority sidewalk clearing around transit stops in the short term, however, I still believe there is an urgent need for reliable, city-wide sidewalk clearing. As demonstrated with the recent winter storms, snow build up on sidewalks and at crosswalks can severely restrict the mobility of many people, including people with disabilities, seniors, and families. Studies also show that since women are more likely to rely on walking, not maintaining sidewalks has a disproportionate impact on women. The City of Hamilton has committed to increasing walking as part of the Transportation Master Plan, and has the vision of making Hamilton the best place to raise a child and age successfully. That can only happen if we treat walking as an essential mode of transportation, and invest in maintaining all of our sidewalks yearround.

In that same meeting, I also supported calls for more opportunities for residents to engage on the budget in advance of the budget being drafted. **Thank-you for hosting an initial public budget session for the public a few months ago.** I hope we continue to see new and accessible ways for more residents to engage with the city.

Lastly, I voiced my frustration with seeing the overfunded police budget continue to grow while essential community services and organizations are underfunded, particularly affordable housing. This continues to be an urgent issue for Hamilton, and I urge council to treat this like the emergency that it is and prioritize much needed community services and supports in the upcoming budget.

Thank you for the opportunity to speak to you today about the Mayors Motion to help make Hamilton Bike Share Sustainable.

I am here today as a Board Member of Cycle Hamilton and cyclist and a bike share user. Over the last few years of my cycling journey I have seen the many benefits both physically and mentally of riding a bike. Hamilton has a vibrant cycling community that includes many Bike Share users.

Bike Share is an affordable, accessible alternative for many that don't own a bike or are afraid of theft, or owning a motor vehicle to those people that live in or visit the service area on a regular basis. Bike Share opens the doors to shopping, medical appointments, exercise and even employment. Recently I had my own bike stolen and through bike share I was still able to go get groceries, attend medical appointments and even get to New Hope Bikes to purchase a new to me bike.

Before the pandemic and during, BikeShare was important in filling the gaps or last mile for using public transit. During the pandemic it allowed people to stay connected with essential trips allowing the seats on Transit to be used by essential workers. This making it a important and vital part of the transportation network. Bike share also allows people a choice in mode of transportation in making these trips.

I am an adult who has difficulty walking and through Bike Share and owning my own bike has allowed me to be active in the community and be car-free. Through the Mayor's Motion to make Bike Share more sustainable it will allow Bike Share to continue to be affordable, accessible and a vital part of the Transportation network in the lower city.



MUNICIPAL PRE-BUDGET SUBMISSION 2022

THE MCMASTER STUDENTS UNION

RENTAL LICENSING AND ZONING

Recommendation:

The City of Hamilton should proceed with the Rental Licensing Pilot in Wards 1, 8, and parts of 14.

After McMaster Students Union representatives delegated to the City of Hamilton's Planning Committee with ACORN Hamilton and a number of other community members in August of 2021, the committee passed a motion to go forward with a licensing pilot for rentals in Wards 1, 8, and parts of 14. These areas each have substantial student populations and high-density rental units that have been flagged for being unsafe and in ill-repair. It's critical that the City of Hamilton move forward with the pilot as landlords must be held accountable for maintaining rental units to safety codes. The operating budget estimate of \$2 million over the two years allocated for the pilot will directly impact the lives of McMaster University's nearly 30,000 undergraduate students, most of whom live in the neighborhoods surrounding the campus.

The need for a change has been demonstrated numerous times in the past few years as people from vulnerable backgrounds have fallen prey to predatory leasing practices. Most alarmingly, the number of students who have been exposed to dangerous living situations is unacceptable with 12-bedroom houses without fire or safety inspections advertised to international students and those with limited finances. In 2016, a fire at an unlicensed lodging house killed three people after inspectors were unable to investigate due to a lack of resources for city staff to ensure responsible and accurate zoning and licensing.¹ In Windsor, Ontario, the municipality is drafting a bylaw to enact a rental licensing pilot in the wards surrounding the University of Windsor and

St. Clair College, due to similar problems with the "deplorable condition" of rental housing.² As highlighted during the August 2021 delegation for the City of Hamilton's Planning Committee, there is a need for landlords to be held accountable for complying with City bylaws and safety measures, but also a need for data to determine whether the rental licensing is effective in Hamilton.

TRANSIT

Recommendation:

The City of Hamilton should commit to retiring the Area Rating system so all residents pay equally into the HSR.

In 2008, the City of Hamilton staff presented the Area Rating Policy Update and Area Rating Options (city-wide) to the City Council with the recommendation to remove the HSR's area rating system. As of 2021, Hamilton is one of the only municipalities to maintain an area rating system which has garnered negative feedback and hindered transit development across the region. With the recent adoption of the Hamilton Light Rail Transit, there is no better time to phase out the area rating system for Hamilton transit. The Hamilton public transit system is an essential service to everyone in the city, including McMaster University students. However, the area rating system has continued to stunt the HSR's growth and serve as a barrier to residents. Currently residents pay based on the following scale:

After years of supporting Hamilton's LRT project, the MSU is committed to standing behind the development of more efficient and cost-effective transit within and beyond the city of Hamilton. That said, McMaster University students provide a significant portion of the HSR's budget with each student currently paying a mandatory fee of \$233.94 for an HSR bus pass. With close to 30,000 McMaster students holding a pass, the HSR must be held accountable for providing reliable and effective service. In the fall of 2021, the HSR cancelled trips along the 51 route due to COVID-19 vaccination staffing shortages without warning or consultation with McMaster students.³ The global pandemic has provided challenges for everyone, and students have undoubtedly felt these struggles, however every effort must be made by the City of Hamilton to provide essential services like transit. The City of Hamilton should review the HSR's practices to ensure students and those with limited means are supported and informed during unprecedented times. especially as the LRT progresses and students begin to live and commute from communities farther from the McMaster University campus.

Recommendation: The City of Hamilton should ensure timely and consistent connections between the McMaster University campus and HSR routes through the LRT and buses.

CYCLING INFRASTRUCTURE

Recommendation:

The City of Hamilton should guarantee funding for the Hamilton Bike Share Inc. to promote healthy lifestyles, accessible transportation, and community initiatives.

As of 2020, the Hamilton Bike Share Inc (Sobi), has 900 bicycles used by 26,000 visitors and residents annually. In addition, the bike share system facilitated 13 million kilometers traveled, as well as a savings of over \$1 million in gasoline burned, and therefore close to 1 million kilograms of carbon reduced.⁴ Despite the clear health and environmental benefits of the shared bicycle program, Hamilton's Council decided not to provide funding for the bike share after Uber Inc terminated its contract with the City.⁵ Although the bikes are used predominantly in Wards 1, 2, and 3, with Councillors Wilson, Farr, and Nann advocating for the collective benefits of the program, the bike share program was ultimately saved by the community. Funding provided by Cogeco and the Downtown Hamilton BIA, along with donations from the Patrick J. McNally Charitable Foundation, LiUna, and just under 900 other individuals and organizations allowed the program to continue providing a safe and accessible method of transportation across Hamilton.⁶

Recommendation: The City of Hamilton should conduct a review of lighting in neighborhoods around McMaster University and prioritize improving effective lighting.

In the McMaster Students Union 2021 Your City Survey, 55% of students surveyed said that feeling safe in their neighborhood was the most important factor in finding a rental unit in Hamilton. As part of this survey, students elaborated their concerns with Hamilton's neighborhoods saying "Hamilton isn't the safest city so it's important to me that I feel safe on my street" and the need to be " ... able to walk home and feel safe, especially at night".⁷ In the McMaster Students Union's 2020 *Lighting Survey* students were asked how important street lighting was in neighborhoods around campus with 94% responding with "extremely important" or "quite important" in regard to their feelings of safety. In particular, students living in the Ainslie Wood North and Ainslie Wood East neighborhoods noted that lighting was particularly poor.⁸ The areas that were flagged as particularly concerning were **Glenmount Avenue, Sanders Boulevard, Broadway Avenue, Hollywood Street North and South**, and **Whitney Avenue**.

LIGHTING



The need for improved lighting in the neighborhoods surrounding McMaster University has been ongoing since 2018 when the McMaster Students Union engaged with the City of Hamilton's Senior Project Manager for Street Lighting and Electrical. The subsequent improvement in lighting on Thorndale Avenue, Leland Street, Bowman Street, Stroud Avenue, and Cline Avenue allowed McMaster students residing in the area, as well as community members, to feel more secure. Although the areas where lighting is being requested in generally safe, there have still been a number of serious crimes reported in the neighborhoods that surround McMaster University. In October of 2020, there was a fatal stabbing near Main Street West and Haddon Avenue South. That incident was after another altercation which resulted in two stabbings in September of 2019. Also, there were a series of break-ins in the Westdale area in Fall 2019.⁹ With better lighting, McMaster students will not only feel safer, but communities will feel more protected.

In 2021, the City of Hamilton passed a motion to expand their snow clearing service to sidewalks on transit routes after decades of staff reports on snow clearing. Despite the progress being made to improve Hamilton's accessibility, snow clearing in Ward 1 neighborhoods remains underfunded. McMaster University students come from intersectional backgrounds with a varying needs and resources to support not only their academic pursuits, but also their ability to engage with local communities and organizations. Without snow clearing services, many students are limited in their ability to access critical services. As noted in the City of Hamilton's Sidewalk Snow Clearing (PW19022(d)) (City Wide), the tax impact to cover the addition 469km along Priority 1 and 2A roadways for a total of 866km was estimated to be \$4 in 2022 and \$6 in 2023 for residents. Currently, Ancaster already receives snow clearing services however it is not limited to transit routes.¹⁰

In the McMaster Students Union 2021 Your City Survey, students were asked to rank how strongly they felt about increased snow removal by the City of Hamilton with 10 being very strong and 1 being impartial. The average answer among surveyed students was 7.98 with 'accessibility' flagged as a major cause of dissatisfaction and ten respondents noted they had received a by-law violation for snow and ice clearance.

SNOW CLEARING

Recommendation: The City of Hamilton should fund snow clearing services across the entire city.

RACIAL EQUITY

Recommendation:

The City of Hamilton should continue to support and invest in the Hamilton Anti-Racism Resource Centre.

Systemic racism and barriers experienced by underrepresented communities have been particularly prevalent during the COVID-19 pandemic, as equity-deserving groups continue to be excluded from conversations and community initiatives. In 2018, the City of Hamilton, McMaster University, and the Hamilton Centre for Civic Inclusion launched the Hamilton Anti-Racism Resource Centre (HARRC) in response to the growing demand within the region for increased resources and supports.¹¹ The need for this centre rose from the lived experiences of Hamiltonians, where 79% of people have personally experienced or witnessed racism.¹² As McMaster students come from diverse backgrounds both across Canada and the world, the need for resources in all communities remains a priority. With the federal government introducing Canada's Anti-Racism Strategy in 2019 and Ontario presenting the Ontario Anti-Racism Strategic Plan in 2017, the City of Hamilton should continue to make active efforts to support Black, Indigenous, and people of colour.¹³

The McMaster University population is known for its diversity and the large variety of clubs, services, and offices that are devoted to support people from all communities. However, McMaster students, faculty, and community members are also valued members of the greater Hamilton community and deserve to feel supported regardless of whether the supports are offered on or off campus.

POLICING

Recommendation:

The City of Hamilton should review the Hamilton Police Services budget and reallocate funds to social services, community initiatives, and incentives for learning and education.

In the past decade, there has been a shift in public perspectives around policing and community-based safety initiatives. As of 2020, the Hamilton Police Services' budget was over \$170 million after a 3.87% increase from 2019 and made up approximately 18% of the City's municipal levy on taxpayers.¹⁴ Compared to the \$582 allocated to education, \$129 for the Library system, and \$385 for to Fire Services, the Hamilton Police Service receives \$648 from the \$3,689 of municipal tax charged to the average residence.¹⁵ In 2021, the Hamilton Police Service reported a \$2.1 million surplus from 2020 and yet Hamilton Police Service chief, Eric Girt, argued reducing the budget would negatively impact public safety.¹⁶

McMaster University students have made it clear that police presence does not instill comfort or feelings of safety, especially given the Hamilton Police Services reputation for aggressive methodology. Though crystallized following the murder of George Floyd and the wide scale coverage of the Black Lives Matter movement, McMaster University students have long called for the dismissal of McMaster University's Director of Parking and Security Services, Glenn De Caire, the former chief of the Hamilton Police Service.¹⁷ Additionally, in January of 2021 the McMaster Students Union passed a motion calling on McMaster University to remove the former chief of police as Director, to phase out Special Constables, and to end working relationships with the Hamilton Police Service and Halton Police Service.¹⁸



- **102.** Develop a municipal procurement policy that incorporates living wages and incentivizes contractors doing business with the City to pay their employees a living wage.
- **103.** Through Hamilton Anchor Institute Leadership (HAIL), work with other large employers in Hamilton to encourage living wages are paid at all of Hamilton's large institutions.

Continual Response

104. Through the Economic Development Department, implement a new Living Wage policy that actively encourages new employers relocating to Hamilton to pay their employees at least Hamilton's living wage rate.

Investing in the Arts

The arts are one of the sectors hardest hit by the COVID-19 pandemic. Shutdowns and restrictions of gatherings have taken a heavy toll on the performing arts, while lower disposable income has caused spending on the arts to wane. The closure of music and theatre venues and the cancellation of many events and festivals has further contributed to the precariousness of those working in the arts.

The city should lead a fulsome discussion around support for the arts with those in the community to ensure that this important aspect of COVID-19 is addressed. The organizations involved have limited knowledge in the arts fields, but felt this important aspect of COVID-19 recovery must be discussed. Commissioning public art could become a core focus of our efforts in Hamilton in building a Just Recovery, as it has the ability to spur not only artistic production and community engagement but also skilled trades and fabrication employment. The points below are recommendations for a starting point for the city to discuss this very important aspect of a Just Recovery. In order to support the art and creative sector, the City of Hamilton should:

Urgent COVID Response

- **105.** Begin extensive engagement with members of the Arts community and Arts organizations to prioritize their needs and requirements.
- 106. Re-establish a Cultural Plan Roundtable with clear objectives and resources.
- **107.** Work with artists and arts organizations to steam-line, and make the SEAT process barrier-free. Create a fund to ensure all local events have free access to GAMEDAY insurance.
- **108.** Encourage the use of visual arts and performance arts in community spaces and public parks.
- 109. Reinvest in expanding opportunities for concerts, performing arts, music and festivals.
- **110.** Choose to increase spending on the arts with projects prioritizing, people of colour, women, Indigenous communities, and 2SLGBTQQIA+ communities.
- 111. Provide Resources to the Hamilton Music Strategy and the Hamilton Music Advisory Team.

Continual Response

- **112.** Create a separate Cultural Enrichment Fund to establish a dedicated funding stream for BIPOC, 2SLGBTQIA+, and other equity-seeking artists and cultural producers.
- **113.** Fully fund the Cultural Enrichment Fund so it grows each year to meet industry growth and cost of living increases in Hamilton.
- 114. Create a designated fund either CEF, the Hamilton Future Fund or a combination of Ward Funding to support capital investments in cultural spaces from a wide range of cultural producing partners.










