#### RECOMMENDATION

That Council approve the single source procurement with CareRx Holdings Inc. pursuant to Procurement Policy #11 – Non-competitive Procurements, and extend the current contract for the supply of pharmaceutical services at Macassa and Wentworth Lodges until June 30, 2023 or until a new contract is awarded (whichever is earlier) and that the General Manager, Healthy and Safe Communities Department be authorized to negotiate and execute the amendment to the Contract and any ancillary documents required to give effect thereto, in a form satisfactory to the City Solicitor.

#### **EXECUTIVE SUMMARY**

This Report is requesting Council's approval for the extension of Contract C5-04-15, the Supply of Pharmaceutical Services for residents of Macassa and Wentworth Lodges (the "Homes") until June 30, 2023 or until another competitive procurement process can be issued and a new contract awarded (whichever is earlier).

#### HISTORICAL BACKGROUND

The current contract for the Supply of Pharmaceutical Services for Macassa and Wentworth Lodges, Contract C5-04-15 ("Contract") was awarded to Rexall/Pharma Plus Pharmacies Ltd. ("Rexall") on January 5, 2015 and was scheduled to expire on January 4, 2021.

Since their sole focus was to provide enhanced care to the residents and support the staff during the COVID-19 pandemic, staff at the Homes were not able to undertake a competitive procurement process and award a new contract prior to the expiry of the Contract. In order to maintain continuous services to the residents, a Policy 11 Non-Competitive Procurement was approved in June 2020 to extend the Contract for an additional 12 months until January 5, 2022 to allow staff the time to issue and award a new contract.

In mid-2021, the City was requested to consider an assignment/corporate change from Rexall/Pharma Plus Pharmacies Ltd. to CareRx Holdings Inc. and in October 2021, the assignment was completed, and the applicable contracts were changed. The new vendor for the Contract was CareRx Holdings Inc. ("CareRx").

In September of 2021, the nursing leadership team worked with the Procurement Section to begin to develop a new Request for Proposals ("RFP") to secure a new a proponent to provide pharmacy services for the residents of both Homes. However, due to staffing shortages and the COVID-19 pandemic, it was necessary to delay the work on the competitive procurement by both LTC and Procurement staff.

Once again, in order to maintain the services, a second extension to the Contract was approved in October 2021 through another Policy 11 Non-Competitive Procurement, extending the Contract with CareRx to July 5, 2022.

#### POLICY IMPLICATIONS AND LEGISLATED REQUIREMENTS

The Long-Term Care Homes have an obligation under the *Long-Term Care Homes Act 2007 (2010)* and Ontario O. Reg. 79/10: 119(1) Every licensee of a long-term care home shall retain a pharmacy service provider for the Home.

The recommendations in Report HSC22004 comply with the City of Hamilton's By-law 21-215, Procurement Policy 4.11, Policy #11 – Non-Competitive Procurements, section 2, subsection (b):

- "(2) Council must approve any requests for negotiations for:
  - (b) an extension as set out in subsection (1)(c) of this Policy #11, where the extension exceeds 18 months from the expiry of the Contract with a vendor."

#### **RELEVANT CONSULTATION**

Procurement Section staff was consulted and support the Recommendation in this Report.

#### ANALYSIS AND RATIONALE FOR RECOMMENDATION

These services provided to residents at the Homes under the Contract are at zero cost to the City. All costs are paid by the either the Province or the resident where applicable. Additional services provided to City staff by the pharmaceutical vendor are also included in the Contract's scope of work and are also at zero cost to the City.

CareRx has proved to be a competent and satisfactory vendor to the City, without any vendor performance issues. They have been supportive of the recent Contract extensions and have provided the services without interruption or concern.

Due to continuance of the pandemic, and specifically Wave 4, staff is requesting an additional 12-month extension to the Contract with CareRx until July 4, 2023, to allow the leadership team to continue to focus on the health and safety of our residents, staff, and Homes. The extension of the Contract will allow staff to continue to work with the Procurement Section on a new Request for Proposal process to ensure a successful competitive procurement. The further extension will also ensure there are no service disruptions to our 430 residents across both Homes.

The Procurement Policy, Policy #4.11, Policy 11 Non-Competitive Procurement requires Council approval where the extension of a contract "exceeds 18 months from the expiry of the contract with a vendor". Since the Contract has been extended from January 5, 2021 to July 5, 2022, Council approval is required to extend the Contract further.

The Ministry of Municipal Affairs and Housing is consulting with the public regarding regulatory changes to the *Housing Services Act, 2011*. The changes are in the service of modernizing and expanding community housing system.

The hallmarks of the current system include an exclusive focus on Rent-Geared-to-Income (RGI) assistance, coordinated access to RGI assistance and a focus on legacy social housing programs built between the 1960's and 1990's. In many regards, this system is now outdated as non-profit projects built since 1997 fall outside of these rules. Similarly, older federal projects are reaching their end of agreement and facing decisions about the future, such as should they continue, sell or redevelop. Selling or redeveloping removes these projects from the existing system.

A response, attached as Appendix "A" to this Report, has been developed to the provincial consultation (proposal 21-MMAH031). The response urges the provincial

government to update the existing system by expanding beyond legacy social housing's focus on RGI assistance. It should expand the types of housing assistance around which the system is organized to focus on lower cost, but still deeply affordable housing assistance that take into account the shelter allowance provided by social assistance programs. This would mean that these forms of assistance should form part of any new service level standards. The response also supports the development of regulations to spell out common expectations for agreements with providers that have reached the end of their operating agreement or new providers whose projects were not funded under legacy social housing programs. It also reminds the province that almost all community housing administration is funded by the municipal tax base and that any changes should not result in increased costs or be accompanied by increased funding.

#### HISTORICAL BACKGROUND

On July 22, 2020, the *Protecting Tenants and Strengthening Community Housing Act, 2020* received Royal Assent. It amended the *Housing Services Act, 2011* (the Act) in several fundamental ways.

- Allowing community housing providers to move into a new streamlined part of the Act once they have reached the end of their original obligations. In addition, community housing providers and projects that are not currently in the Act could enter the system under this new framework.
- Broadening the types of housing assistance that could be counted towards a Service Manager's required service levels. The Ministry plans to work in partnership with Service Managers and sector partners to propose a modern, outcomes-based approach to accountability and service level standards in regulation. This would consider how different types of housing assistance could be counted towards new service level requirements.
- Expand the types of assistance offered through the housing access system beyond just rent-geared-to-income assistance and could include other types of housing assistance set out in regulation.

On December 20, 2021, the Ministry of Municipal Affairs and Housing posted a consultation document regarding proposed changes to O. Reg 367/11 under the Housing Services Act. The deadline for the consultation is February 18, 2022.

#### POLICY IMPLICATIONS AND LEGISLATED REQUIREMENTS

The City of Hamilton is designated as the Service Manager (SM) under the *Housing Services Act, 2011*. The Act requires the SM to fund certain social housing providers through prescribed formulas. It further requires that the Service Level Standards for the number of Rent-Geared-to-Income (RGI) units are maintained. The Act also requires that SMs maintain a coordinated access system for RGI assistance.

Performance against the Service Level Standard is reported to the Ministry of Municipal Affairs and Housing annually in a Service Manager Annual Information Return. The Act lays out penalties if a SM does not fulfil their obligations.

#### **RELEVANT CONSULTATION**

Ontario Works was consulted in the preparation of the response. They identified that the regulatory changes recommended in the response would not have an adverse effect on the City as social assistance is funded by the province.

#### ANALYSIS AND RATIONALE FOR RECOMMENDATION

It is important for the City of Hamilton to participate in the consultation process as the proposed regulatory changes could have financial and administrative implications. These implications could include:

- what types of financial assistance must be provided to community housing providers whose operating agreement has ended;
- what types of assistance are included in the new Service Level Standards; and,
- what types of assistance must be provided through an expanded mandate for coordinated access to housing assistance.

#### Response to Consultation Regarding Changes to O. Reg 367/11

This document outlines the City of Hamilton's response to the Ministry of Municipal Affairs and Housing's proposed regulatory changes to O. Reg 367/11 as outlined in proposal 21-MMAH031.

As a general comment, it should be noted that municipal Service Managers pay most of the operating costs associated with legacy social housing programs. In addition, the City of Hamilton has allowed providers to keep their full operating surplus and has provided municipally-funded capital dollars totalling \$3 M annually. The City of Hamilton has also provided used municipal tax dollars for capital contributions to the development of new community housing as well as annual rent subsidy for new community housing. These contributions are significant and still the costs of maintaining legacy social housing units grows beyond municipal means.

These investments have been made recognizing the significant need for affordable housing in Hamilton. Given limited municipal tax dollars, these investments are made by Council in careful consideration of the full range of municipal needs. While many aspects of the proposed regulatory changes are welcome, they cannot unilaterally impose additional costs to the municipal taxpayer.

#### Service Agreements:

The City of Hamilton supports the creation of a regulatory framework that would enable existing housing providers with matured operating agreements and mortgages to remain in the community housing system by signing a Service Agreement with their municipal Service Manager (SM) and spell out provisions governing entry of new housing providers into the community housing system.

While the current legacy social housing system's focus on Rent-Geared-to-Income (RGI) and chronological coordinated access has its challenges, it provides useful underlying principles and common expectations for tenants, housing providers and SMs. Without a minimum framework, the SM and provider must negotiate each agreement separately. One of the primary challenges in the current environment is that agreements with the federal government for co-investment or rapid housing funding become the foundation for these agreements. These agreements reflect Canada Mortgage and Housing Corporation's focus on risk management and securing the public investment and only minimal attention to the needs of tenants and SM.

- The framework must be flexible to reflect the needs of individual projects.
   Creating rigid expectations for funding arrangements could result in over or underfunding projects and unnecessary costs to the municipality.
- It should also speak to protections for affordability for existing tenants at the end of an agreement. Similarly, phase out periods at the end of agreements should be limited to ensure units are available for the full duration of the agreement.

- The new framework must remain committed to coordinated access. In an attempt to house tenants whom, they believe to be "lower risk", some housing providers prefer to hand select tenants rather than rely on coordinated access.
- It is also important to maintain the system of quasi-judicial review of decisions regarding social assistance. This provides a useful system to review decisions made by housing providers and the service manager regarding eligibility for housing assistance.
- Creation of the requirement for an exit agreement for providers whose mortgages have expired is also beneficial. Currently, when a federal provider's mortgage expires, the decision about what to do with the property is left largely to the nonprofit board. In some cases, boards see the project as their asset and do not recognize the significant public investment made over the years. Exit agreements should require short- and long-term plans for the property and affordability to tenants.

#### Service Level Requirements:

The City of Hamilton appreciates the move to reform Service Level Requirements. The current requirements are based on the number of social housing units downloaded from the Province to the municipality in 2001. They also focus almost exclusively on Rent-Geared-to-income (RGI) assistance.

Any revised approach should include the considerations listed below:

- The focus should be expanded beyond RGI to reflect the variety of forms of assistance that are provided by Service Managers (SM) and that they meet different needs. A new system should include RGI assistance, assistance calculated according to the municipally-funded portable housing benefit formula even if it applied to properties, and units made available at 80% of Average Market Rent (AMR).
- The new service level standard should be negotiated regularly to reflect changing community need and current investments by both levels of governments.
- The renegotiation of service level standards could be tied to the regular renewal and update of 10-year housing and homelessness plans.
- Currently, the provincial government provides no funding for general administration of social/community housing programs. As a result, reporting expectations must not be expanded as this would result in additional costs to the municipality.

#### Access:

The current coordinated access system focuses exclusively on RGI. Legislatively, households offered other forms of assistance must remain on the centralized waiting list.

Changes to coordinated access should reflect the concerns listed below:

- Any form of assistance that results in "deep affordability" or a household paying no more than 30% of its net income in rent should be considered an offer of housing and those households should be removed.
- RGI rules currently state that households in receipt of provincially-funded social
  assistance pay on a discounted scale rather than a percentage of income. This
  makes RGI assistance very expensive for providers and municipalities to offer.
  Allowing SM to offer assistance that requires social assistance recipients to pay
  the maximum shelter allowance would stretch limited municipal tax dollars
  further.
- The basic requirements of eligibility and coordinated access should be included in any new agreements discussed above.
- Provincial rules need to support better integration between By-Name Priority Lists for people experiencing homelessness and coordinated access to community housing. SMs are required to operate both systems, but the logic of the two systems is hard to reconcile, yet they are expected to work in tandem.
- Coordinated access is funded directly by municipalities. Hamilton's coordinated access system has no capacity to provide additional services or forms of assistance without funding from the provincial government.
