The Committee was that due to staff redeployments and staff shortages, the grant 2022 Keep Hamilton Clean and Green Neighbourhood Grant cycle timelines have been delayed by one month. Promotional materials for the 2022 grant cycle are currently being developed. The 2022 grant cycle will be promoted through various forms of communication including, but not limited to, Instagram, the City of Hamilton website, digital display boards throughout the Public Works facilities, printed posters for all branches of the Hamilton Library, and various recreation centres.

(ii) Keep Hamilton Clean and Green Committee Summer Meetings Update (Item 13.2)

(iii) Team Up to Clean Up Updates (Added Item 13.4)

Staff Liaison, Whitney Slattery, Clean and Green Coordinator, provided an update on the Team Up to Clean Up Program. Due to COVID-related staff shortages and redeployments, the program is not currently fulfilling any supply/collection requests. The program will be operational before the spring.

Changes have been made to capture statistics, increase efficiency, and improve transparency/accountability more accurately. Staff are working with Web Services to automate the request for supplies. The online form will provide citizens with two options; “one-time cleanup event” and “ongoing community cleanups”. For “one-time cleanup event” supply/collection requests, supply packages will be tailored to the number of participants. For the “ongoing community cleanup” supply requests, pre-made standardized packages will be available.

Staff will be working to develop an optional feedback form to distribute to volunteers near the end of the season. This will provide an opportunity to capture more qualitative data that can have significant impacts on continuous improvement initiatives.
