Dear Mayor Eisenberger:

I am writing further to my earlier correspondence of March 15, 2022, acknowledging your request for the authority to establish a Vacant Home Tax for the purposes of improving housing supply and choice in Hamilton.

Ontario's recently updated Housing Supply Action Plan anchored by the *More Homes* for Everyone Act, delivers important reforms to help address Ontario's housing supply crisis. This included measures to crack down on bad actors who are making the housing supply crisis worse, including tough penalties for new home contract cancellation, and serious fines and license impacts for speculators and developers wrongfully withholding housing permits and approvals to restrict the supply of new homes and drive sales prices up. The government has also significantly expanded the Non-Resident Speculation Tax.

The City of Toronto has identified and advanced its Vacant Home Tax as a potential additional tool to disincentivize actions that reduce housing options for more Ontarians. The establishment of a Vacant Home Tax is a municipal decision that, like the City of Toronto, you are approved to proceed with in an effort to improve housing supply and choice for those hopeful to call Hamilton home. Ontario is prepared to facilitate municipal discussions over the summer through the establishment of a working group to provide a forum for the sharing of information and best practices, as well as to explore opportunities to enhance the existing legislative framework.

The findings and recommendations of this working group may have implications for municipal Vacant Home Tax by-laws that you should be prepared to accommodate.

I look forward to Hamilton's participation on this staff-level working group. Officials from my ministry will be in contact with more details.

To members of council:

I'm writing to you again to ask that you do not commit the city any further to a Commonwealth Games bid. Very simply, I believe this endeavour would be a waste of time and money, and a giant distraction from what should be the city's top priority: directly addressing the housing and homelessness crises.

Every dollar and minute council and city staff spend considering this proposal would be better spent lobbying upper levels of government to invest in new public housing.

Investing hundreds of millions (if not 1-2 billion) of public money on a two week event would be a mistake.

Additionally, considering a significant number of councillors have signalled they don't intend to return after this year's election, this council shouldn't commit the next council to the untold costs of a Commonwealth Games bid.

If it is truly in the best interests of Hamiltonians to be involved in the Games, proponents should make their case and let voters decide that.

To members of council:

I write to you to express my opposition and to ask that you do not commit the city any further to a Commonwealth Games bid. I agree with many other citizens that the Commonwealth Games bid is a colossal waste of city staff time and city budget. Given the litany of structural, public safety, health and welfare issues plaguing this city, not to mention the massive deficit in capital funds for repairs, this is no way a priority or a reasonable decision from any perspective.

Additionally, this is in no way a decision that should be made by a government on the eve of an election. There are huge implications across much of the city for this type of undertaking, and should be left to those that will be here over the course of said process to listen and engage with Hamiltonians, not ram through a literal earth moving decision at the 11th hour.

Those decision makers who will not have to live with the results of these decisions also raise great concern, as it is possible once freed from any legal conflicts, they will seek personal reward as "consultants" or other paid positions with the Games they in fact approved. It calls to question whose interest is this in? The people of the city who rely on their elected representatives to do what's best, or their own?

For these and many other reasons, I submit this is not the prudent, ethical or reasonable path for city council to undertake on behalf of the people of Hamilton. To quote another submission, "If it truly is in the best interests of Hamiltonians to be involved in the Games, proponents should make their case [to the public] and let voters decide."

- (b) That the 2022 implementation costs, estimated at \$2,600,000 for the Vacant Home Tax to be funded through an internal loan plus interest from the Investment Stabilization Reserve (110046) to be repaid from revenues collected from the program over a 5-year term, be approved;
- (c) That the estimated gross annual operating costs of \$2,200,000 for administration of the Vacant Home Tax Program and related 16 Full Time Equivalents (FTE), to be funded from revenues generated by the program, be referred to the 2022 Budget Process for consideration; and,
