Subject: Current Living Conditions at the Cathedral Women's Shelters

Hello, my name is Zoe Kazakos, and I am very very concerned, outraged and frustrated at the current living situation at the Cathedral women's shelters in downtown Hamilton. I am e-mailing to echo the demands of residents at Cathedral shelter and the Hamilton Encampment Support Network for the immediate redress of the dangerous and inhumane living conditions.

It is clear, based on countless testimony that Good Shepherd services are not able to maintain proper safe and healthy shelter conditions. We call on Good Shepherd services to work in conjunction with other social services and supports to improve the conditions within the Cathedral Shelter.

We call on the City of Hamilton and Good Shepherd services to guarantee access to clean and safe drinking water for all residents. For guaranteed dietary considerations, reflecting the different health needs of shelter residents. To have clear and standardized fire safety plans, including fire and emergency protocols that are posted and respected.

Together the city and Good Shepherd must remove any and all disturbed asbestos, pests and airborne illnesses like mold and mildew.

We know first hand what happens when residents are not protected, as we have witnessed countless deaths and prolonged illness due to negligence and lack of safety protocols throughout this pandemic. Good Shepherd Hamilton has allowed a bad situation to get worse, either from laziness, lack of resources or what have you - but this is not an excuse. This must be rectified. The people of Hamilton must be protected, and offered safe living conditions. There is no excuse for this blatant disregard of human life.

I look forward to hearing back from you, to discover what steps are being taken and when they go into effect.

Recommendation:

That the content and design of the revised Seniors Advisory Committee brochure entitled "Seniors Advisory Committee (SAC)" attached as Appendix "A", be approved.

Background:

At the May 6, 2022 Seniors Advisory Committee meeting, committee members passed a motion under item 11 (Motions), for Council to approve the content and design of the revised Seniors Advisory Committee brochure.

The Seniors Advisory Committee's goal is to create more awareness of the committee as well as their role on behalf of other seniors who reside in the Hamilton community. The brochure was a project of the Seniors Advisory Committee's Communications Working Group who felt the older brochure required updating. In addition, that the brochure could be used as a communication tool when engaging with other seniors at in person events such as the upcoming Seniors Kick-off event taking place on June 1, 2022 at Michelangelo's Event and Conference Centre located in Hamilton.

Analysis/Rationale:

The Seniors Advisory Committee is a key partner with the Hamilton Council on Aging and City of Hamilton for Hamilton's Plan for an Age-Friendly Community (2021-2026). The Seniors Advisory Committee's Communications Working Group has aligned their

workplan with goal 3 (Communications and Information) of the Age-Friendly Plan. One of the objectives under goal 3 is to "increase and improve access to information for older adults." More specifically, one of the recommendations under this objective states, "ensure that information is available in multiple formats and languages including online and print."

In addition, most seniors prefer information in a hard copy format versus on-line and/or through social media. According to a survey conducted by the City of Hamilton's Communications Department, 70% of seniors over the age of 65 get information from local newspapers while 30% get information from internet search engines and 12% from social media.

We are a volunteer-based advisory committee of the City of Hamilton. Members of the committee are residents and/or business owners in Hamilton who are appointed by Council.

SAC is a full partner with the City of Hamilton and the Hamilton Council on Aging in the development, governance and implementation of Hamilton's Age-Friendly Plan.

SAC's active working groups, include:

- Communications
- Elder Abuse
- Housing
- Getting Around Hamilton

SAC also has membership in several external committees/groups.
