Staff provided information on the status of the 2020 Solid Waste Management Master Plan action items.

#### 6. DISCUSSION ITEMS

#### (Hunt/Lukasik)

#### (i) Waste-Free Ontario Act Updates (Item 8.1)

#### (a) Hazardous and Special Products

Staff informed the Committee that the City signed a contract with a battery Producer Responsibility Organization (PRO), Call2Recycle in July 2020 to manage eligible batteries collected at the Household Hazardous Waste depots. The City was awarded the "Leader in Sustainability Award" from Call2Recycle for collecting 58,193 kilograms of used batteries in 2021.

Staff provided information on contracts with PROs to manage hazardous and special products collected at the City's Community Recycling Centres. All hazardous and special products are currently being collected at the City's Community Recycling Centres at this time. Staff will share a report

with Council if changes are recommended for the operation of the City's hazardous and special products program.

#### (b) Blue Box Program Transition

Staff informed the Committee that a road map will be developed for transition of the City's Blue Box program including all tasks that need to be completed prior to the Blue Box program transition in April 2025.

#### (ii) Operations Update (Item 8.2)

#### (a) Waste Collection Service Operations

Staff provided information on the City's waste collection service operations:

1) Curbside Yard Waste Collection schedule

Staff informed the Committee that the weekly leaf and yard waste collection program will operate between February 28, 2022 to December 9, 2022.

2) Curbside Waste Collection Service Interruption

It was reported that during January and February 2022, curbside waste collection service interruptions were experienced due to COVID-19 absences among the City's waste collection contractor and a winter storm event.

### (b) Recycling and Waste Disposal Operations

Staff provided information on the City's waste processing and disposal operations:

1) Central Composting Facility (CCF) Updates

The CCF is currently processing at an approved annual capacity of 20,000 metric tonnes. The City is working on updating the facility's odour management system to increase annual processing capacity to 40,000 metric tonnes.

2) Materials Recycling Facility (MRF) Updates

The MRF started to receive merchant cardboard materials.

Staff is currently undertaking a project to revise the method of proper handling of hazardous and special waste products which are found in blue box materials. Although these products are not accepted in the recycling program, hazardous and special waste is

inadvertently placed in the recycling program which requires removal from the processing operation.

#### 3) Transfer Station and Community Recycling Centre Updates

Staff is reviewing the land requirements for the expansion of an additional Transfer Station/Community Recycling Centre. The cost of land continues to be cost prohibitive.

The City will be undertaking a project to replace the tip floor at the Kenora Transfer Station in 2022.

### 4) Glanbrook Landfill Operations

The Request for Proposal to construct Cells C, D and E within stage 3 at Glanbrook Landfill was awarded to Seawaves Development Services. The contractor has mobilized their operations as of March 13, 2022.

### (c) Promotion and Education

Staff provided information on promotion and education initiatives:

#### 1) 2022-2023 Recycling and Waste Calendar

The calendars were mailed in early March. Residents that didn't receive a calendar by March 25<sup>th</sup> can contact the Customer Contact Centre to have one mailed to them.

#### 2) Compost Give-away

The City will be holding a compost giveaway on April 30, May 7 and May 14, 2022 at Turner Park.

### (d) 2020 SWMMP Action Item - Reduce and Reuse Policy

Information was provided on the City's Reduce and Reuse Policy. The City developed the Reduce & Reuse Policy to provide direction on how the City may support waste reduction and reuse programs led by community groups and non-profit organizations so that the City's involvement is conducted in a consistent and fair manner.

#### (e) Federal Draft Regulation on Single Use Plastics

Information was presented on the Federal draft Regulation on single use plastics which was released on December 25, 2021 for public comment. Staff provided a response on March 4, 2022.

The proposed Single-use Plastics Prohibition Regulation would prohibit the manufacture, import, and sale of six categories of single use plastics in Canada. The manufacture and import of these six single use plastics for the purposes of export would not be subject to the proposed prohibition. The proposed Regulation includes exceptions for plastic straws to allow the public to obtain these products under certain circumstances, for example, hospitals and health care facilities may provide flexible straws for patients and residents who require them.

The Federal Government also released a document outlining best practices for choosing less-impactful plastics or non-plastic alternatives to the six categories of single use plastics identified in the proposed Regulation.

On February 11, 2022, the Federal Government released a technical issues paper that includes a plan to set minimum recycled content requirements of 50% for certain plastic manufactured items by 2030. Staff provided comments on March 10, 2022.

Staff will review the local impacts from this proposed Regulation among the City's divisions and services that purchase and provide these single use plastic products. Staff is planning to develop educational material for local businesses on alternatives for these single use plastics products.

### (f) Recycling in Open Spaces

Staff provided an update on the public space recycling project which will take place beginning in May in four sites including Dundas Driving Park, Red Hill Trail, Sam Manson Park, and William Connell Park. The project will review the performance of the recycling program including container fullness and contamination.

Discussion took place concerning the City's streetscape public litter containers. Staff is undertaking a review of this program which includes the use of technology to improve operations and updating the procedure for litter container placement. Staff reported that new public space recycling containers were installed in the Westdale Business Improvement Area.

Update on the Hazardous and Special Products Program

Item 7.1 (a)

## Hazardous and Special Products Program





- New regulation assigns full collection cost of certain household hazardous waste (HHW) to producers
- Agreements have been signed by the City with PROs for all hazardous and special products (HSP) covered under the new Regulation
- 58 HSP items currently collected at Hamilton Community Recycling Centres (CRCs) compared to 14 covered under the new Regulation



## Hazardous and Special Products Program

- The gap in the HSP program is common to municipalities in Ontario and most are choosing to pay to maintain their HSP program
- The rationale for municipalities to continue the program includes avoiding service disruption to residents and ensuring HSP is properly disposed and not poured down storm or sanitary sewers, illegally dumped, or landfilled
- Hamilton's contract for operating the HSP depots expires on September 30, 2022
- Report to reviewed at PWC on July 6, 2022 will speak to HSP contract and related services









## Waste-Free Ontario Act Updates

Update on the Blue Box Program Transition

Item 7.1 (b)

## **Background**

- O. Reg 391/21 released on June 3, 2021 makes Producers fully responsible for the operation and financial management of the provincial Blue Box program. Highlights of the Regulation include:
  - Creation of a common collection system across the Province
  - Expanded list of acceptable Blue Box materials
  - Providing service for all eligible sources
- On April 14, 2022, O. Reg 391/21 was amended to simplify the Regulation and the requirements for the common collection system
- By July 1, 2022, Producer Responsibility Organizations (PROs) will finalize the rules for the new producer led Blue Box Program



## **Transition Update**

- Circular Materials Ontario (a PRO) issued draft Agreements and RFPs for municipalities to become recycling service providers to CMO
- Municipalities will need to determine if they will provide collection operations or operate materials receiving facilities
- Next steps:
  - Staff report to be shared in August 2022 concerning the City's transition
  - The roadmap is being developed to identify all tasks that need to be completed prior to transition in April 2025
  - Staff will continue to participate in inter-municipal working groups concerning the Blue Box program transition

# Operations Update Waste Collection Service Operations Item 7.2 (a)

## Waste Collection Service Operations

## Continuous Improvement Project - Bed Bug Contaminated Bulk Waste

- Review due to staff safety and resource pressures (supply and delivering bags to residents to wrap contaminated bulk items)
- Providing bags is not an approved program with designated resources
- Staff will phase out supplying bags to residents by end of year
- Phase out plan includes:
  - Education campaign on proper bulk waste preparation including tips
  - All mattresses / box springs shall be wrapped in plastic
  - Education campaign focusing on waste collection safety



## Waste Collection Service Operations

## **Street-side Public Space Container Program**

- Award of new contract for street-side containers
- Current initiatives
  - GIS based inventory
  - Refined criteria for container placement
  - Pilot project fill sensors in containers in several locations
  - Illegal dumping enforcement

## **Open Space Recycling Program**

 The parks recycling pilot project is in progress at 4 sites which is monitoring materials captured and contamination





# Operations Update Recycling and Waste Disposal Operations Item 7.2 (b)

## Waste Processing Service Operations – Central Compost Facility

## The Low Carbon Economy Fund Application – Odour Management System Upgrade

- Staff reviewed the requirements for the Government of Canada's Champion Stream of the Low Carbon Economy Fund as a potential funding source to upgrade the odour management system at the Central Composting Facility
- The City will not proceed with the grant application since the Fund requires the project construction to be completed prior to March 2025
- Staff will continue reviewing industry best practices on latest technologies to improve the CCF operations



## Waste Processing Service Operations – Transfer Stations/Community Recycling Facilities

## **Site Capacity Review**

- In 2019-20 City Staff completed Needs Assessment on sites to determine capacity issues. The Mountain facility appears to be exceeding the reasonable maximum capacity for periods as long as a month. The Kenora facility will do so in 2029 using the most recent growth trend
- The Real Estate Section is continuing to search for a land parcel that could fully or even partially meet our needs. Cost of land for a fourth transfer station continues to be cost prohibitive.
- Staff will be looking at alternative options if staff cannot find land that meets the requirements

## **Current Operations**

- Kenora T.S. tip floor is targeted to be repaired in Fall of 2020
- Staff is working with the contractor to prepare for the upcoming leaf and yard waste season to ensure the sites transfer these materials to Glanbrook in a timely manner



## Landfill Operations – Glanbrook Landfill

## **Glanbrook Landfill – Stage 3 Construction Update**

- Construction of Stage 3, cells C, D and E at the Glanbrook Landfill Site is on-schedule and is expected to be complete by September 30, 2022
- Cells C, D and E is the next landfill filling stage once cells A and B have reached capacity. Cells C, D and E will take approximately 6 years to reach capacity
- An assessment of the current landfill gas collection system will be conducted in 2022 to identify any possible efficiencies and recommendations for future operations

## Promotion and Education

## Waste & Recycling Workers Week

- Held across North America during June 13<sup>th</sup> to 17<sup>th</sup> to recognize waste management industry professionals
- Awareness was raised through a media release, social media posts including a video highlighting the work done by Waste Management staff
- Social media as of June 17<sup>th</sup>:
  - 1,087 people reached
  - 78 engagements





## **Promotion and Education**

## **Waste Collection Safety Campaign**

- Phase 3 campaign began in June on "Keep Safe and Separate Sharp Waste"
- Designed to educate residents on how to keep waste collection staff safe by safely disposing of items
- Campaign includes video, radio spots, social media posts and information on website

Keep Safe and Separate Sharp Waste

Sharp object hidden in garbage bags and blue boxes can pose serious injury to waste collection workers.

Separate, box and label your sharp household waste and place on top or beside your garbage bag.

## **School Virtual Presentations**

- During COVID, virtual presentations were developed to continue education program of students
- Implemented in October 2021 and 37 classes participated in the first 3 months
- As of May 31, 2022: 148 classes (~3,300 students) signed up to participate in 2022
- Virtual presentations will continue to be offered when/if live presentations may begin again at CCF

- Program changes planned to be in place for 2023 festival season
- Staff report in PWC in Q1, 2023 with program recommendations
