(i) Hamilton Cycling Committee Meeting Minutes - June 1, 2022 (Item 4.1)

5. COMMUNICATIONS

(i) Update: Citizen Committee Report - Terms of Reference and Roles, Responsibilities and Expectations (Item 5.1)

Staff provided an update on the approval from Public Works Committee and Council on this item. Staff highlighted that the quorum piece has been modified to reflect the Procedural by-law and that meetings for the new committee (2023-2027) term have been moved to the 1st Tuesday of each month.

6. CONSENT ITEMS

7. STAFF PRESENTATIONS

(Oates/Jamnik)

That the staff presentations respecting Open Streets and School Streets, be received.

CARRIED

(i) Open Streets (Item 7.1)

A. Carlyle made a presentation on Open Streets noting the concept, proposed location (King St), timelines as well as engagement strategies and survey results. Committee members expressed gratitude and excitement for the project and asked questions regarding how closures

(intersecting streets) will be accommodated, potential of having this in other areas of the City and the intent of reporting back to Council on the project.

(ii) School Streets (Item 7.2)

C. Johnson made a presentation on the recent School Streets event held at Strathcona Elementary School and closure of Lamoreaux Street. Staff noted that the event was very successful, but Hamilton Police indicated that enhanced barriers (more than pylons/barrels) should be considered for future School Street events. Committee members asked questions about how to facilitate this event in other areas of the City (i.e. Dundas), cost of the event and the potential of expanding the areas that are closed within the school area.

8. **DISCUSSION ITEMS**

(Oates/Muis)

That the following discussion items be received:

(i) Citizen Committee Report - Dewitt Rd Reconstruction (Item 8.1)

Committee members reviewed, discussed and supported the citizen committee report.

(Beukel/Oates)

That the Citizen Committee Report - Dewitt Rd Reconstruction, be approved.

CARRIED

(ii) Longwood Rd (King St to Main St) - (Item 8.2)

Staff provided an overview of the Longwood Rd project between King St and Main St. Committee members asked questions related to the potential of extending the cycle track north of King Street, the crossing/transition at Main Street, consideration of additional traffic calming features and increased barrier types.

(iii) Hamilton Cycling Committee Work Plan (Item 8.3)

Committee members reviewed the workplan and noted that some of the items that have been worked on by the committee should be added to the workplan. An updated workplan will be shared with staff for inclusion in

future agendas. The committee discussed another potential movie night within Dundas and will provide additional detail at next months meeting.

(iv) Planning and Project Update (Item 8.4)

Staff provided members with an update on current and planned cycling projects. Committee members asked questions regarding:

- King St (Stoney Brook-Hwy 8): tender closed; project includes a road diet with buffered bicycle lanes
- Southcote Dr: tender closes in a week; project includes a multi-use path on the north side
- Cootes and West 5th: consulting assignment for detailed design and tendering documents. Most likely not implemented until 2023
- Pipeline Trail: update on the project status and some general maintenance needed on existing trail
- Upper Paradise @ Mohawk Rd: really happy with what was done and filling in the gap
- Butler Hydro Corridor Trail: why on hold? Staff will follow up
- Inverness Ave: include in the scope improvements for the Upper James Street intersection and include wayfinding to/from the Keddy Trail
- Chippewa Rail Trail @ Rymal Rd: has anything been planned for here and can anything be done to accommodate the crossing of trail users? Staff will follow up.
- Pearl/Kent: still planned for 2022, but weather may impact pavement marking application
- Hatt St: update on Shed Brewery barriers; vehicles continue to park within the bicycle lane
- On-street patios (James St): with the signage and additional steel barriers, area looks like a construction zone
- King Street and Haddon Avenue: committee members recall that a raised intersection was being considered at this location. Staff will follow up

9. NOTICE OF MOTION

(Meulen/Oates)

That the motion respecting Upper Wellington Environmental Assessment Network Connectivity, be deferred to a future meeting.

CARRIED

(i) Upper Wellington Environmental Assessment Network Connectivity (Item 10.1)

WHEREAS the City is currently doing an Environmental Assessment along Upper Wellington between Limeridge Road and Stone Church Road;

WHEREAS Hamilton's cycling master plan includes cycling infrastructure over the Lincoln Alexander Parkway along Upper Wellington Street;

WHEREAS it is important that cycling infrastructure connect to existing infrastructure to develop increased ridership;

WHEREAS a cycling lane over the Lincoln Alexander Parkway would connect the planned cycling infrastructure south of the Parkway to that north of the Parkway;

WHEREAS a connection over the overpass is a key component of a minimum grid of cycling infrastructure on the Hamilton mountain;

WHEREAS there is currently no north-south crossing over the Parkway closer than West 5th to the west and Upper Sherman to the east;

WHEREAS it is possible to reduce the number of car lanes on the bridge along Upper Wellington;

WHEREAS it is possible to consider having only two lanes, along with a center turning lane, all along Upper Wellington from Lime Ridge Road to Stone Church Road to match Upper Wellington to the south of Stone Church Road;

WHEREAS having four traffic lanes and with no cycle lane does not fit the goal of balancing infrastructure on the overpass; it instead prioritizes automobile transportation with respect to north-south connections on the Hamilton mountain;

WHEREAS a multi-use pathway slows down commuter cycling traffic;

WHEREAS a multi-use pathway causes unease for both cyclists and pedestrians; and,

WHEREAS pedestrians with ear-buds do not hear the bells of cyclists

THEREFORE, BE IT RESOLVED AND RECOMMENDED:

- (a) The road improvements on Upper Wellington Street from Limeridge Road to Stone Church Road include cycling infrastructure over the Lincoln Alexander Parkway; and,
- (b) That the cycling infrastructure be clearly separated (e.g. separated facility) from the pedestrian traffic along Upper Wellington.

(Meulen/Oates)

That the motion respecting Bike Lane Asphalt be deferred to a future meeting.

CARRIED

(ii) Bike Lane Asphalt (Item 10.2)

WHEREAS road works, emergencies, development, construction, utilities and other events require removal of asphalt and/or concrete in bicycle lanes;

WHEREAS asphalt is typically patched quickly then properly repaired at a later date;

WHEREAS work requiring removal of asphalt and/or concrete can take months or years;

WHEREAS bicycles require a smoother surface, both for safety and quality of ride; and,

WHEREAS there are various examples of uncomfortable and unsafe patchwork on key pieces of cycling infrastructure.

THEREFORE, BE IT RESOLVED AND RECOMMENDED:

That all asphalt and concrete repairs impacting a bicycle lane, bicycle trail, bicycle route, or other bicycle infrastructure be repaired and/or patched immediately after road work is complete to the same pre-repair quality or better, regardless of whether the entire project is complete or in progress.

10. GENRAL INFORMATION / OTHER BUSINESS

- (i) Staff advised committee members of an upcoming survey related to the existing cycling map, which is planned for an update in 2023. Once the survey is developed, committee members will be notified and encouraged to share the survey with other members of the community.
- (ii) Report was brought to Public Works committee earlier today on reducing lanes on Main Street
- (iii) There is a plan for a ghost ride Monday July 11 @ 5:30 starting at Southam Park and proceeding to Upper Wentworth and the LINC

Upper Wellington Cycling Infrastructure Connectivity Motion

Whereas

- The city is currently doing an EA along Upper Wellington between Lime Ridge Road and Stone Church Road
- Hamilton's cycling master plan includes cycling infrastructure over the Lincoln Alexander Parkway along Upper Wellington
- It is important that cycling infrastructure connect to existing infrastructure in order to develop increased ridership
- A cycling lane over the Lincoln Alexander Parkway would connect the planned cycling infrastructure South of the Parkway to that north of the Parkway
- A connection over the overpass is a key component of a minimum grid of cycling infrastructure on the Hamilton mountain
- A minimum grid fits with the goals of Vision Zero and the city's declaration of a Climate Emergency.
- There is currently no north-south crossing over the Parkway closer than West 5th to the west and Upper Sherman to the East
- It is possible to reduce the number of car lanes on the bridge along Upper Wellington
- It is possible to consider having only two lanes, along with a center turning lane, all along Upper Wellington from Lime Ridge Road to Stone Church Road to match Upper Wellington to the south of Stone Church Road
- Having four traffic lanes and with no cycle lane does not fit the goal of balancing infrastructure (as per Complete Liveable Better Streets) on the overpass; it instead prioritizes automobile transportation with respect to north-south connections on the Hamilton mountain

THEREFORE, BE IT RESOLVED:

- (a) That the Committee recommends all asphalt and/or concrete crossing the path of a bicycle lane, bicycle trail, bicycle route, or other bicycle infrastructure be repaired/patched immediately after work is complete. All asphalt and/or concrete for these locations be repaired to the same quality regardless of whether the entire project is complete or in progress. The quality of the repair should be to the same quality or better than the adjacent untouched asphalt and/or concrete; and,
- (b) That the Committee recommends Public Works Committee take this motion and present it as direction to staff.
