Subject: Immigration Number Targets

During the February meeting of the Committee, a question was raised with regards to immigration targets for cities and provinces. I advised the committee during that meeting that I will find a resource that could answer this question.

I approached Mohammad Araf, Program Officer for the Hamilton Immigration Partnership Council (HIPC) with the question. Below is his answer to our inquiry:

There are no immigration target numbers for cities or provinces (except Quebec which has its own immigration level targets). Every year, the government of Canada announces its immigration level targets for the next three years. It sets targets for each of the class/categories of immigration, such as economic class, family reunification, refugees. However, there are no provincial or municipal targets. Historically, immigrants have tended to move to large urban centres.

In the recent past, there have been several programs towards regionalization of immigration and ensuring that smaller and remote/rural communities benefit from immigration. The Rural and Northern Immigration Pilot, the Atlantic Immigration Pilot, the Municipal Nominee Program (not implemented yet) are examples of programs that aim to distribute immigration to other places than large urban centres like Toronto, Vancouver, Montreal etc.

The closest case of immigration numbers being determined provincially is the Provincial Nominee Program (one of the several programs under Economic Class), which allocates a certain number of permanent resident spots per province. For example, the Ontario Immigrant Nominee Program allocation was 9,000 in 2022.

As for Family Reunification and Refugee categories, there are no allocations per province or city. Under the Refugee category, the Government Assisted Refugees (GARs) are resettled to a particular community based on their existing family ties or

other considerations. These refugees are matched with cities where a Resettlement Assistance Program (RAP) agency is operating. Usually these agencies agree on a certain target number each year with IRCC.

Please note that immigrants, especially economic class immigrants, are highly mobile and move from one city/province to another in search of opportunities, connections etc. A recent HIPC report showed that while many immigrants move in and out of Hamilton each year, Hamilton is a net beneficiary of secondary immigration.
