The Director of Licensing's request, made February 21, 2023, under Section 12(1) of the General Provisions of the City of Hamilton Licensing By-law, for a Show Cause Hearing respecting a City of Hamilton Establishment Licenses 19-296000 and 17-293170 – 1W Second Hand Shop for Dean Pearson.

At the hearing the Tribunal will decide whether or not to uphold the refusal, and/or to revoke, suspend or have conditions imposed on your business licence. The hearing will be conducted in accordance with the *Municipal Act, 2001*, the Business Licensing By-law No. 07-170 and the *Statutory Powers Procedure Act*. Please be advised pursuant to Section 12(1) of the General Provisions of the City of Hamilton Licensing By-Law (By-law) 07-170, as amended, we are requesting that a show-cause hearing be scheduled and brought before the Hamilton Licensing Tribunal to consider whether the above-referenced licence(s) should be revoked, suspended or conditions imposed.

Section 12 (1)(c)(vi) of the By-law provides that the Director of Licensing and By-law Services (Director) shall refuse to issue a licence or may recommend the suspension or revocation of a licence when, in the opinion of the Director:

- 1. The operation of the applicant's or licensee's business would put the public's safety at risk.
- 2. The operation of the applicant's or licensee's business is not or will not be carried on in compliance with the law; or
- 3. The conduct of the applicant or licensee affords reasonable grounds for belief that the applicant or licensee will not carry on or engage in the business in accordance with the law or with honesty or integrity

Namely,

As a result of a Hamilton Police Services (HPS) investigation:

The business(es) purchased over \$200,000 (two hundred thousand dollars) in stolen merchandise over a 2 (two) year period, and were sold for profit

SUSPENSION OF LICENCE

City of Hamilton Licence(s): Second-Hand Shop File No(s). 19-296000 1W and 17-293170 1W

- Multiple victims identified over \$30,000 (thirty thousand dollars) in stolen merchandise that was subsequently seized from the business(es) several items were not held for the required time-frames as required under the By-law
- A sworn statement has been submitted by an accused indicating direction from the business(es) requesting specific items to target to steal, which would subsequently be sold to and then by the business(es)
- HPS attended the business to retrieve identified stolen items as a result of an investigation to find those items has been moved to the other business and sold without being held for 30 (thirty) days.

Further, these actions are in violation of Schedule 22 (Second-Hand Goods, Jewellery and Precious Metals Businesses) of the By-law:

5.(g) notify the Hamilton Police Service of the name and description of any goods which are believed to have been stolen or unlawfully obtained; and

10.(1) Every second-hand goods business operator and jewellery and precious metals business operator shall retain all purchased goods on the premises of the business in an unchanged condition for a period of at least 30 days after the day on which the good was purchased.

You will be notified by the Legislative Co-ordinator of the Hamilton Licensing Tribunal of the scheduled hearing before the Hamilton Licensing Tribunal. A hearing shall be commenced by the Hamilton Licensing Tribunal within sixty (60) days from the date of generation of this letter.
