City-Wide Litter Review Status

Item 7.1

City-Wide Litter Review

Council Direction

- **May 15, 2023 – Public Works Committee** – Staff conduct a service level review across all divisions in Public Works for proactive and reactive litter collection in the public realm and report back on any operational and budgetary changes to address service levels
- **June 14, 2023 – General Issues Committee** – Staff to identify opportunities to enhance service levels within the downtown core for critical street level issues such as waste collection, street sweeping, etc.
- **2022-2026 Council Priorities** – Outcome 3; Provide vibrant parks, recreation and public space. Measure of Success; Increase cleanliness of public spaces through the expansion of Public Works standards related to garbage and litter collection.

City-Wide Litter Review

Project Deliverables

- Complete review and identify current state of city wide litter management
- Complete engagement exercise
 - Public engagement (Survey)
 - Council engagement (Interviews)
 - Business Improvement Area engagement (Interviews)
- Public Works to identify expansion of services related to city wide litter management
- Develop Key Performance Indicators
- Report back to Public Works Committee any operational and budgetary changes that may be required related to expansion of services; recommendations would be referred to the 2024 Operating Budget process



Hazardous and Special Waste

Item 7.2

Hazardous and Special Waste

- The City of Hamilton is working with the Producer Responsibility Organizations (PROs) for Hazardous and Special Products (HSP) covered under Ontario's Regulations for HSP disposal from our household hazardous waste depots located in Community Recycling Centres (CRCs)
- A tender for operations of the three Household Hazardous Waste (HHW) depots and material haulage has recently closed
- Waste Management Staff are currently working with the City's Procurement section to evaluate vendor submissions and look at further options to operate the HHW depots
- Staff are analyzing the current reimbursement program and continuing to work with waste industry associations and the PRO to finalize a fair compensation model as the current funding model falls short of municipal costs; Options and Contract will come to PWC



Closed Landfill Monitoring

Item 7.3

Closed Landfill Monitoring

- Recycling and Waste Disposal (R&WD) manages the maintenance and monitoring at 13 Closed Landfill Sites (Sites) in the City of Hamilton (City)
- These Sites require regular monitoring as required by the Ministry of Environment, Conservation and Parks (MECP) through an Environmental Compliance Approval (ECA) and Provincial legislation to ensure the Sites are environmentally sound
- Activities at the Sites include ground water, surface water and landfill gas monitoring as well as bi-annual inspections to identify any maintenance issues that may need to be addressed

Closed Landfill Monitoring

- Five of these Sites have active leachate collection systems that need to be monitored and maintained
- One of the closed sites has a passive landfill gas collection system that is maintained and monitored
- Several Sites have identified end uses, including sports fields, walking trails and special features that the public can utilize like the Red Hill Valley turtle meeting place!
- The Upper Ottawa Site has a Bobolink and Eastern Meadowlark designated habitat as registered with the Ministry of Natural Resources
- The City continues to work with the MECP to review monitoring requirements on an annual basis based on sampling results and consultant recommendations

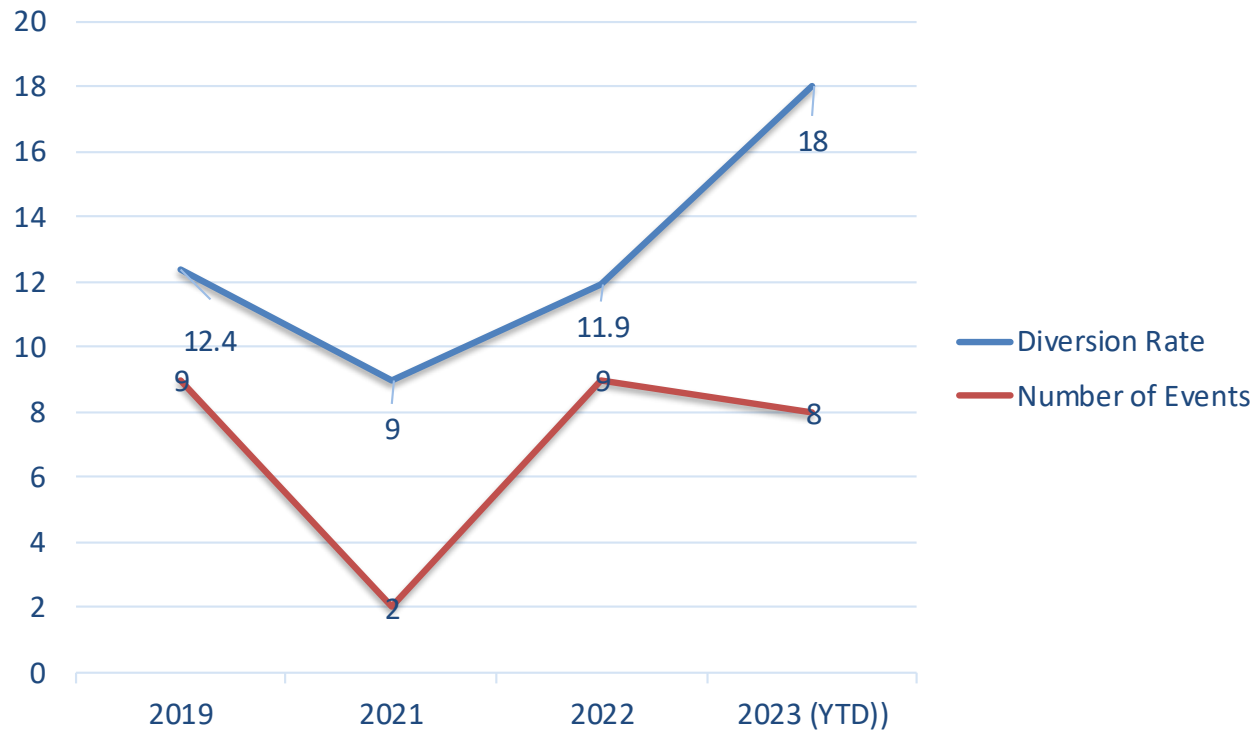
Waste Diversion at Special Events

Current Program

- City provides waste support to events that are:
 - Expected to have between 15,000 to 100,000 attendees;
 - On City property; and
 - Coordinated by non-profit organizations
- Some events that don't meet criteria have historically received service
- Support includes providing:
 - Roll-off containers for the collection of garbage, recycling and organics at the end of the events
 - Carts for collecting recycling and organics throughout the event
 - Signage
 - Disposal at City facilities

Waste Diversion at Special Events

Waste Diversion at Events



- Additionally, two to four events per year fail to divert any waste

Waste Diversion at Special Events

Program Review

- As part of the 2020 Solid Waste Management Master Plan update, staff have been working to improve waste diversion at events
- Work included piloting different options and services to improve waste diversion at four events including:
 - Providing the option of using front-end containers to organizers of smaller events
 - Providing staff and equipment for waste sorting stations
 - Providing training to event organizers on waste diversion

Waste Diversion at Special Events

Pilot Results:

- Front-end containers were proven to be a practical solution for smaller events
- Appropriate waste diversion occurred when City staff were on site running sorting stations but stopped once staff left
- Three sorting station tents provided by City went missing
- Event organizers need to be held more accountable for waste diversion and City equipment



Waste Diversion at Special Events

New Program

To be eligible to receive support from City moving forward:

- Expected attendance between 1,000 to 100,000:
 - 1,000 to 15,000 to have combination of front-end containers (smaller) and roll-off containers (larger)
 - 15,000 to 100,000 to be provided with roll-off containers for all material
- Events must be on City property
- Events must be put on by non-profit organizations
- Events with multiple locations / insufficient areas for containers will not be eligible for service
- Events with food service / food trucks etc.

Waste Diversion at Special Events

New Program (cont'd)

- Support subject to sufficient infrastructure at event location (i.e. space for containers)
- Events that are provided with diversion containers and do not divert waste / put forth sufficient effort to divert waste will no longer be eligible for support in the future and will be required to pay tipping fees for material not diverted
- Historical servicing will no longer determine future servicing
- Support is based on a first-come, first served basis due to resourcing
- City staff will not operate sorting stations

Waste Diversion at Special Events

Next Steps

- Work with the Special Events Advisory Team (SEAT) to implement the revised program
- Update guide for event organizers with new program requirements
- Create an agreement for event organizers to receive City support



Business Recognition and Education

Item 7.5

Business Recognition and Education

Program Review

As part of the 2020 Solid Waste Management Master Plan update, staff have been working to determine a new program to increase waste diversion and knowledge of best practices at Hamilton businesses

- 10 businesses agreed to be interviewed on recognition and education:
 - Majority (eight) said they were interested in a recognition program with (seven) wanting to be publicly recognized, i.e. on social media, other responses that received single votes included financial rebates and City small business grants
 - Seven asked for assistance with waste audits, five asked for access to educational material and training and four asked for networking opportunities with other environmentally conscious businesses

Business Recognition and Education

Next Steps

- Staff will work on designing a program for businesses that addresses the wants that were provided
- Education will include providing alternatives to single-use plastics

- Staff submitted Hamilton's Blue Box Transition Report to the Resource Productivity and Recovery Association by the deadline of August 31st
- Next decision for City will be on servicing properties deemed non-eligible for producer responsibility program; Report to PWC in Q4

Off-Campus Student Housing Education

- McMaster – Approximately 1,200 houses known to be used for student housing received in-person education between August 28th and August 31st
- Mohawk – Approximately 600 houses known to be used for student housing received in-person education on September 8th
- Material provided included a waste calendar, postcard and trash tags
- Distribution of material will continue until end of November through Waste By-law when responding to issues and by students contacting the City

- A technology assessment, including costing is to be completed by fall 2024

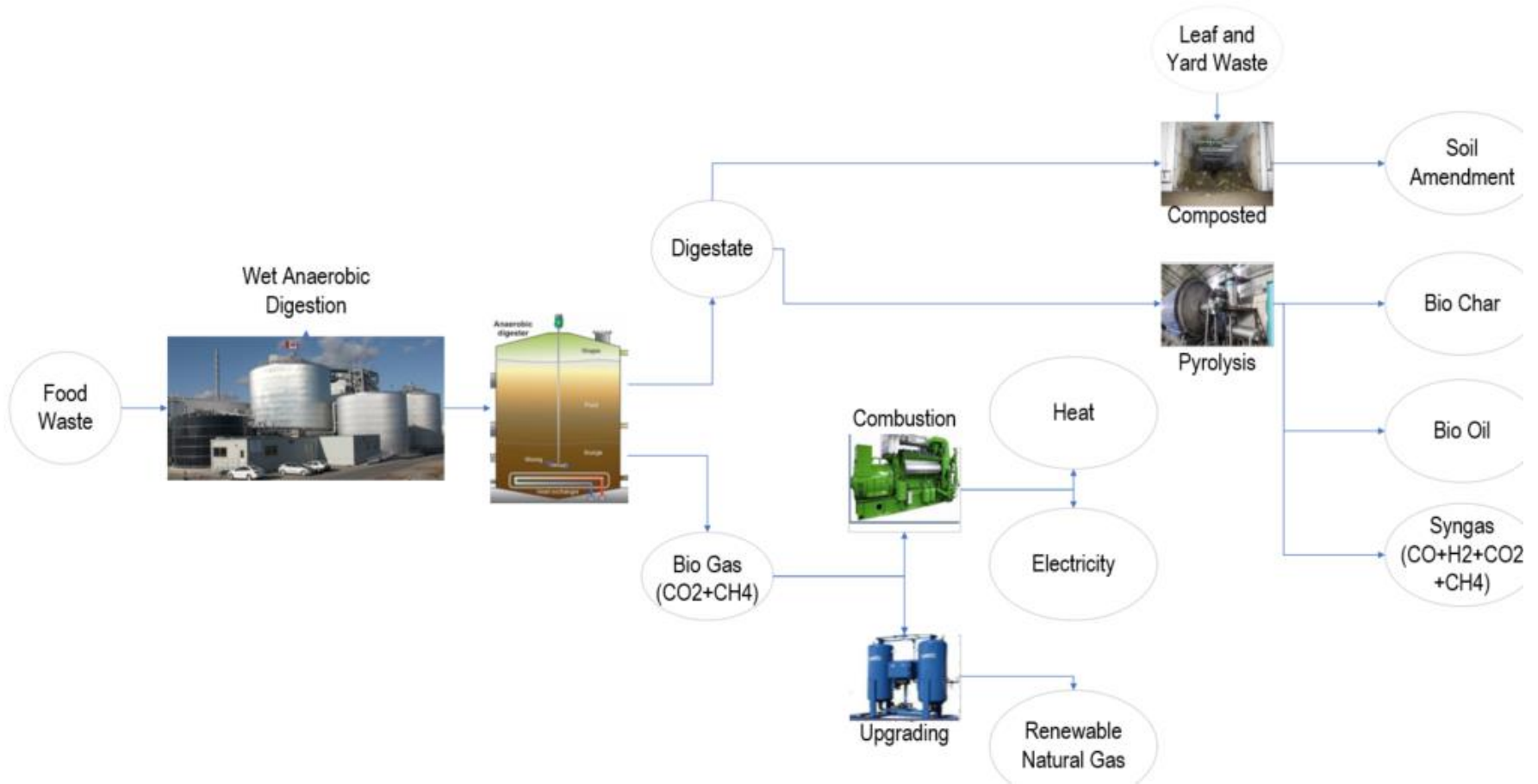
Organics Management Strategy

Report Findings:

- 19 options were identified and evaluated based on seven parameters:
 - Renewable Energy and GHG Emission Reduction,
 - Net Cost
 - Flexibility/Longevity
 - Lifecycle Costs / Replacement Cost
 - Revenue
 - Clean and Beneficial Use of Finished Product
 - Alignment with Corporate Strategies
- Evaluation identified three options to move forward for further investigation
 - Wet Anaerobic Digestion – Compost Digestate
 - Wet Anaerobic Digestion – Pyrolysis Digestate
 - Plug Flow Anaerobic Digestion

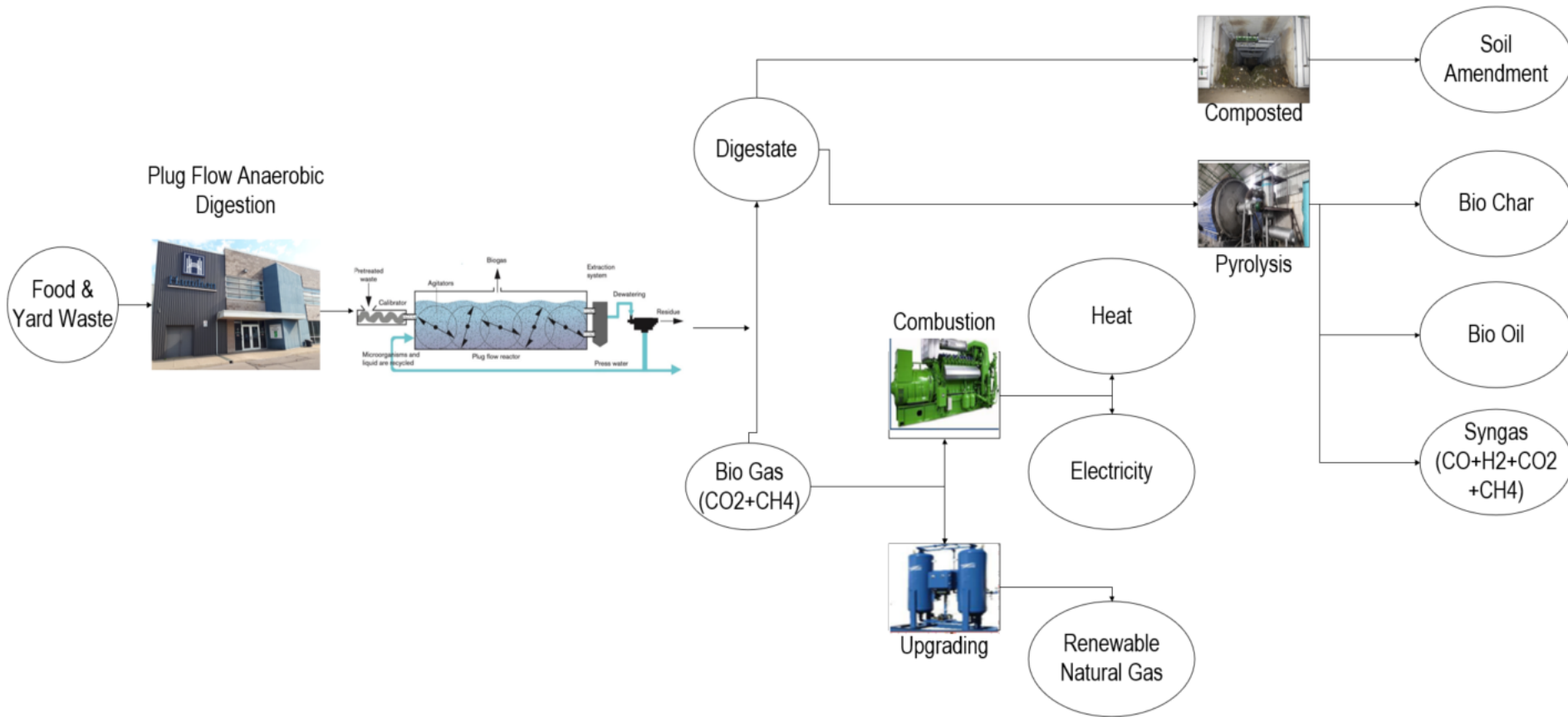
