#### **INFORMATION**

Procurement is required to report to Council on a quarterly basis on the use of Sections 4.10 and 4.11 of the Procurement Policy.

Report FCS23019(b) is issued quarterly in accordance with the Procurement Policy and details the procurement of goods and / or services during emergency situations and those detailed in Section 4.11 – Non-competitive Procurements for the third quarter of 2023.

The Policy for Non-competitive Procurements is used in defined circumstances where it is justified that the policies for the general acquisition process could not be followed. The "Emergency Procurement / Non-competitive Procurement Form" is completed by the Client Department and approved by the General Manager.

During the third quarter of 2023, there were 119 purchases totalling \$12,299,583.36 (Canadian dollars) and \$119,976.13 (US dollars), which were processed through the use of an approved Policy 10 or 11. These are summarized in Appendix "A" to Report FCS23019(b).

The breakdown is as follows:

- Six purchases totalling \$6,902,850.31 were issued under Policy 10, as "Emergency" purchases, whereby goods and services were acquired by the most expedient and economical means. The following purchase represents the largest dollar amount in this category:
  - Purchase Order 103038 for \$6,738,521.00 was issued to Canadian Protection Services Inc. for security guard services City wide. Canadian Protection Services Inc. was secured to replace Neptune Security Services Inc., who were forced into court ordered receivership on May 18, 2023, resulting in a default of contract and forcing a work stoppage under Contracts C11-52-18 and C8-01-19. This Policy 10 Emergency procurement allowed for continuation of these services. Corporate Security is accelerating the development of a new Request for Proposals to complete a competitive procurement process and award a new contract.
- Ten purchases totalling \$1,199,322.00 represent short-term "Extensions" of current contracts which have expired and unforeseeable circumstances have caused a delay in awarding a new contract. The following purchases represent the largest dollar amounts in this category:
  - Purchase Order 102950 for \$625,000.00 was issued to 1419718 Ontario Inc. o/a Marble Renewal Niagara for a second single source extension to Contract C11-70-17 for the supply of marble, terrazzo and polished concrete floor cleaning, maintenance and restoration services. Due to the redevelopment of specifications, this extension was required to continue these services under the contract and provide additional time to complete the procurement process and award a new contract. The new Request for Proposals is expected to be issued in Q1 2024.
  - Purchase Order 100375 for \$400,000.00 was issued to Hamilton Fire Control Ltd. for a second single source extension to Contract C12-03-17 for the supply and delivery of fire safety equipment inspections, testing and repair services. Due to staffing changes within the client department this extension was required to continue the required services under the Contract and provide additional time to complete the procurement process and award a new contract. The new Request for Tenders is expected to be issued in February 2024.
- 103 purchases totalling \$4,197,411.05 (Canadian dollars) and \$119,976.13 (US dollars) were identified as "Single Source" purchases whereby a particular vendor was recommended because it was more cost-effective or beneficial to the City. The following purchases represent the largest dollar amounts in this category:

- Purchase Order 102704 for \$249,999.99 was issued to AECOM Canada Architects Ltd. for prime consulting services to implement the Next-Generation 911 ("NG911") Call Handling System. This single source was required to expedite design and development phases of the NG911 project to meet the mandated deadline of March 4, 2025 imposed by the Canadian Radio-television & Telecommunications Commission.
- Purchase Order 102771 for \$200,000.00 was issued to Deloitte Inc. for consultant services to assess the current state of the City's Human Resources (HR) and Payroll technology. This single source was required as there are components of the current technology platform, PeopleSoft, that the vendor (Oracle) has deprecated, creating a need to fast-track the development of the HR strategic plan and supporting technology roadmap with one of the qualified vendors suggested by Oracle. Upon completion of the initial phase of this work, vendors for follow-on work will be procured through a competitive process. To ensure that Deloitte Inc. does not have a competitive advantage for subsequent follow-on work, all prospective service providers that bid on the follow-on work will be provided with the products created during this initial phase.
- Purchase Order 97232 for \$190,194.51 was issued to G. O'Connor Consultants Inc. o/a OMC Landscape Architecture (OMC) for prime consultant services for phase 2 of the renewal plan for the Hamilton Amateur Athletic Association (HAAA) grounds project. OMC was awarded phase 1 through Contract C12-06-18, Request for Roster Candidates for Professional and Consultant Services, to undertake community engagement to inform a renewal plan (master plan) for the HAAA grounds project and develop detailed design drawings and contract documents. The HAAA grounds project was originally planned to be constructed in two phases over multiple years. However, this approach caused significant obstacles leading to numerous delays. The overall completion date for construction must be met by March 31, 2025 to receive funding from Investing in Canada Infrastructure Program (ICIP). This single source was required to execute this project as a single-phase project in lieu of the original multi-year phased approach to meet the timelines set out in the ICIP funding agreement and allow for efficiency in design.
- Purchase Order 102687 for \$150,000.00 was issued to Data Direct Group Inc.
  (Data Direct) for the supply and delivery of promotional material, confidential
  communication and tax bills for the Vacant Unit Tax program. Data Direct
  currently provides similar services to Taxation managing the confidential
  information involved in these forms of communication and the required services
  cannot be fulfilled by the vendors under the current print services corporate
  contract.

- Purchase Order 102691 for \$150,000.00 was issued to Henry Schein Canada Inc. (Henry Schein) for design and consulting services for the purchase and installation of dental cabinetry and mechanical equipment for the Mountain Dental Clinic renovation project. These goods and services were required to inform the electrical and plumbing designs for the clinic space. Henry Schein is the current vendor for supply and delivery of dental equipment, supplies and maintenance for Public Health. To maintain continuity, meet the March 2024 operational project deadline and minimize additional costs, it is in the best interest of the City to single source the additional scope to Henry Schein.
- Purchase Order 103144 for \$150,000.00 was issued to Regional Fire Services Group Inc. for the supply and delivery of a fire system devices and equipment inventory list, regulation testing of fire and sprinkler systems and on-demand services for fire system issues. These services were not included in the current corporate Contract (C12-03-17, Fire Safety Equipment Inspections, Testing & Repair Services as & when Required). In addition, the awarded supplier on this Contract is not qualified to facilitate these services. The single source is required to ensure compliancy with Ontario Fire Code, O.Reg. 213/07. Hamilton Water is working with Procurement to ensure these services are captured in the new corporate contract to be issued in January 2024.
- Purchase Order 98091 for \$149,969.00 was issued to GM Blueplan Engineering Ltd. (GMBP) for Hydrogeological & Geotechnical Review, Stage 2 Archaeological Assessment & Indigenous Engagement, Cultural Heritage Impact Assessment and Natural Environment Impact Assessment beyond the scope of work included in the original Request for Proposals (C11-07-21, Proposal for Professional Engineering Consultant Services Required for the Waterdown Watermain Trunk Twinning Schedule B Municipal Class Environmental Assessment (EA) and Conceptual Design). As the majority of the watermain will pass through land owned by Royal Botanical Gardens and regulated by the Niagara Escarpment Commission, these stakeholders identified the enhanced scope as a requirement to gain their support. To avoid delays and ensure project continuity, it was in the best interest of the City to have the incumbent vendor provide these additional services.
