Mayor Horwath called the meeting to order at 9:31 a.m. and recognized that Council is meeting on the traditional territories of the Erie, Neutral, HuronWendat, Haudenosaunee and Mississaugas. This land is covered by the Dish with One Spoon Wampum Belt Covenant, which was an agreement between the Haudenosaunee and Anishinaabek to share and care for the resources around the Great Lakes. It was further acknowledged that this land is covered by the Between the Lakes Purchase, 1792, between the Crown and the Mississaugas of the Credit First Nation. The City of Hamilton is home to many Indigenous people from across Turtle Island (North America) and it was recognized that we must do more to learn about the rich history of this land so that we can better understand our roles as residents, neighbours, partners and caretakers.

Councillor Kroetsch declared a non-disqualifying to Item 11.2 respecting Encampment Litigation Update (LS20023(i)), considered at May 22, 2024 Council meeting, as his views on this matter were well known before this litigation commenced and his relationships to Ashley Wilson and Wade Poziomka (Legal Counsel for the applicants in the encampment litigation) would, in no way, prejudice or influence his decision making or participation in discussions on this matter.

Councillor B. Clark declared a non-disqualifying interest to Minute Item 7.5 of the General Issues Committee Minutes, GIC 25-001 (Agenda Item 7.2) respecting Report HSC25008, concerning the Encampment Response Update - October to December 2024, as he referred Wade Poziomka to a Ward 9 community group experiencing an ongoing environmental issue.

Councillor B. Clark declared a non-disqualifying interest to Minute Item 9.2 of the General Issues Committee Minutes, GIC 25-001 (Agenda Item 7.2) respecting Rescinding of City of Hamilton Encampment Protocol – REVISED, as he referred Wade Poziomka to a Ward 9 community group experiencing an ongoing environmental issue.

Councillor J.P. Danko declared a non-disqualifying interest to the Public Health Sub-Committee Minutes, PHSC 25-001 (Agenda Item 7.5), as his wife is a member of the Sub-Committee.

Councillor M. Spadafora declared a disqualifying interest to Minute Item 8.5 of the General Issues Committee Minutes, GIC 25-001 (Agenda Item 7.2) respecting Report FCS25001, respecting 2025 Tax Supported User Fees (City Wide), as he has an interest in a hockey organization and renting facility ice time.

Councillor M. Spadafora declared a non-disqualifying interest to Agenda Item 9.3 respecting Chedoke Twin Pad Arena Sound Upgrades (Ward 14 Infrastructure Upgrade Via Area Rating Discretionary Account #3302109014), as he has an interest in a hockey organization and rents facility ice time, however, an upgrade to the sound system would not solely benefit a hockey organization.

Mayor A. Horwath declared a disqualifying interest to Minute Item 8.10 of the General Issues Committee Minutes, GIC 25-001 (Agenda Item 7.2) respecting Report FCS25009, respecting Proposed Amendments to the Timelines for the Vacant Unit Tax Program, as she has a property with a vacant unit.

#### **CEREMONIAL ACTIVITIES**

#### 4.1 Staff Commendations – Tourism and Culture Team

Marnie Cluckie, City Manager recognized the outstanding contribution of staff across Creative Industries and Cultural Development, Public Art and Placemaking, Tourism and Events, and Heritage Resource Management, all under the leadership of Acting Director of Tourism and Culture, Lisa Abbott, and Acting General Manager Steve Robichaud. The efforts of these teams have truly helped to position Hamilton as a premier tourism destination.

We thank the Tourism and Culture team managers Kim Adrovez, Peter Fortune, and Ryan McHugh for their passion and dedication, which has helped put Hamilton on the map.

In 2024, our Tourism and Culture team received numerous accolades and awards. Festival & Events Ontario named Hamilton the 2024 Municipality of the Year, a testament to our city's success in producing, funding, and promoting festivals and events.

Additionally, the Re-enactment of the Battle of Stoney Creek and Hamilton Winterfest were recognized among the Top 100 Festival & Events by Festival & Events Ontario. The Re-enactment of the Battle of Stoney Creek event drew over 10,600 attendees who participated and learned about history through Indigenous games at the Battlefield Museum and National Historic Site. Hamilton Winterfest brought vibrancy to our city in February, thanks to a collaboration with the City and Cobalt Connects Creativity. It was also a big year for Sports Tourism, with Sport Tourism Canada awarding the 110<sup>th</sup> Grey Cup Festival with the Canadian Event of the Year. The Grey Cup welcomed over 223,000 attendees and 33,835 visitors, generating an estimated \$20.8 million in visitor spending.

The City of Hamilton is also proud to receive the Partnership & Collaboration Award from the Southern Ontario Tourism Conference for the "Your Summer Playground" Campaign. This successful initiative, which included many local partners and social influencers, highlighted our region's unique offerings and inspired travellers to explore and enjoy vibrant summer activities.

Beyond these major accolades, several initiatives received honourable mentions. The Hamilton Civic Museum's digital project, "Stories of Migration and Belonging" was recognized for Excellence in Community Engagement. Magnolia Hall earned an Honourable Mention in the 2024 Architecture Master Prize Awards for its stunning adaptive reuse of St. Mark's Church. Lastly, the Visitor Experience Centre was named an Innovator of the Year finalist by the Tourism Industry Association of Canada. These achievements are a result of Council's unwavering support and the collective efforts of divisions across the City of Hamilton.

### 4.2 Staff Commendations – Economic Development Team

Marnie Cluckie, City Manager recognized the outstanding achievements of our Economic Development staff in strengthening Hamilton's reputation as a leader in economic development and investment.

The City of Hamilton has once again been named one of Canada's Top 20 Investment Locations by *Site Selection Magazine*. This recognition underscores our City's strategic location, skilled workforce, and thriving innovation ecosystem—standing as a testament to the hard work and dedication of our Economic Development team under the leadership of Norm Schleehan.

The Economic Development division has received the prestigious 2024 PlanON Award from the Ontario Professional Planners Institute. This award recognizes the success of Hamilton's Environmental Remediation and Site Enhancement Community Improvement Plan, a program expertly led by Phil Caldwell, whose unwavering commitment to our commercial districts and small businesses continues to drive positive change in our community.

Ms. Cluckie extended congratulations to Judy Lam, who was named Brownfielder of the Year by the Canadian Brownfields Network at the 25th Annual Brownie Awards. Judy's decade of service in revitalizing brownfield sites across Hamilton has been instrumental in transforming our landscape and unlocking new opportunities for growth and development.

The City of Hamilton has also been recognized by the International Economic Development Council (IEDC) with four prestigious awards, including two gold awards for excellence in marketing—one for Economic Development Week and another for our targeted business retention and attraction efforts in the agri-food and beverage manufacturing sector. Two bronze awards also recognized the success of our 2023 Newcomer Day event and the Global Startups Bootcamp program, which continues to foster entrepreneurship and innovation on an international scale.

These accolades not only reflect the talent and dedication of our Economic Development team but also demonstrate Hamilton's ongoing commitment to economic growth, sustainability, and inclusivity.

# 10.1 Feasibility on the Adoption and Enforcement of a By-law to Prohibit Protests at Places of Worship and Their Facilities

WHEREAS, section 10 of the Municipal Act, 2001, S.O. 2001, c. 25, as amended provides that a Municipality may pass by-laws respecting: economic, social and environmental well-being of the Municipality; health, safety and well-being of persons; and the protection of persons and property;

WHEREAS, the Canadian Charter of Rights and Freedoms protects religious expression;

WHEREAS, places of worship provide a safe space for people to come together to express their religious beliefs;

WHEREAS, acts of violence and intimidation at or near places of worship create can cause people to be hesitant to exercise their rights due to fear and/or lack of safety;

WHEREAS, the City of Hamilton's Community Safety and Well-Being Plan aims to create the community conditions where everyone is safe and has a sense of belonging;

WHEREAS, the City of Hamilton is a place where diversity and inclusivity are embraced and celebrated;

WHEREAS, the City of Hamilton respects the right to peaceful protest as a fundamental freedom afforded to all individuals. However, it also recognizes that any acts of violence, threats of violence or vandalism in the course of a protest are not protected by the Canadian Charter of Rights and Freedoms;

# THEREFORE, BE IT RESOLVED:

That staff be directed to prepare a report for Planning Committee's consideration no later than Q1 2025, on the feasibility of the City of Hamilton adopting and enforcing a by-law to prohibit protests at Places of Worship and their facilities— all while balancing the fundamental importance of freedom of expression and freedom of assembly, with the safety and well-being of community members accessing these places of worship and their facilities.

### 9.2 Rescinding of City of Hamilton Encampment Protocol - REVISED

WHEREAS, Justice James Ramsay, Ontario Superior Court Judge, issued a ruling on December 23, 2024 dismissing the claim of fourteen applicants that the City of Hamilton's bylaw preventing encampments in City parks was a violation of the applicants' Canadian Charger of Human Rights and Freedoms;

WHEREAS, in his ruling, Justice Ramsay wrote:

"I was reminded by counsel for the applicant that while the legislature represents the will of the people, the court holds the moral compass that is often the only protection for the most vulnerable. I observe that the most vulnerable includes not only the homeless but also the elderly person and the child who want to use a sidewalk or a city park without tiptoeing through used needles and human feces."

"The life, liberty, and security of the applicants are not put at risk by enforcement of the by-law. They are put at risk by homelessness. Encampments contribute to this risk. They are lawless, dangerous, and unsanitary."

"Encampments are a symptom, not a solution. The City is trying to find a solution to homelessness in consultation with numerous others. It has attempted to address the problem with the old protocol, the encampment process and the new protocol. It has limited resources and a duty to its housed constituency. I think I am well advised to leave them to it without interference. Micro-management by judges will not be productive."

### THEREFORE, BE IT RESOLVED:

- (a) That the City of Hamilton Encampment Protocol be rescinded as of March 6, 2025;
- (b) That the General Managers of Healthy and Safe Communities, Planning & Economic Development, and Public Works, report back at the February 26, 2025 GIC meeting with the necessary resources and staffing needed to transition from the current Encampment Protocol to the City of Hamilton Parks Bylaw;
- (c) That Housing Services staff be directed to continue working with local social agencies to find shelter space for those living in encampments; and
- (d) That Municipal Law Enforcement (MLE) and Parks staff be directed to dismantle all encampments as well as clean and restore parks to the inviting, safe, and green recreational spaces they once were, to be enjoyed by City of Hamilton taxpayers and their families.

WHEREAS, with the exception of three speakers in the Red Rink – only one of which is functional -- the sound system is the original sound system installed in 1992, and at 43 years old, has well surpassed its end of life;

WHEREAS, the quality of the sound system has significantly deteriorated to the point where individuals cannot properly hear spoken remarks or music and has resulted in complaints from the public

- (i) That the applicant makes an application to the Ontario Superior Court of Justice, under Section 88 of the Registry Act, for an order to permanently close the Subject Lands, if required by the City, subject to:
  - (1) The General Manager of Public Works, or designate, signing the appropriate documentation to obtain any required court order; and
  - (2) The documentation regarding any required application to the Ontario Superior Court of Justice being prepared by the applicant, to the satisfaction of the City Solicitor;
- (ii) That the applicant be fully responsible for the deposit of a reference plan in the proper land registry office, and that said plan be prepared by an Ontario Land Surveyor, to the satisfaction of the Manager, Geomatics and Corridor Management Section, and that the applicant also deposit a reproducible copy of said plan with the Manager, Geomatics and Corridor Management Section;

- (iii) That, subject to any required application to the Ontario Superior Court of Justice to permanently close the Subject Lands being approved:
  - (1) The City Solicitor be authorized and directed to prepare all necessary by-laws to permanently close and sell the alleyway, for enactment by Council;
  - (2) That the City Solicitor be authorized to amend and waive such terms as they consider reasonable to give effect to this authorization and direction;
- (iv) The Corporate Real Estate Office of the Planning and Economic Development Department be authorized and directed to enter into any requisite easement agreements, right of way agreements, and/or other agreements deemed necessary to affect the orderly disposition of the Subject Lands and to proceed to sell the Subject Lands to the owners of 154 Lottridge Street, 798 Barton Street East, and 800 Barton Street East, Hamilton, as described in Report PW22074, in accordance with the City of Hamilton Sale of Land Policy By-law 14-204;
