Development of the Community Benefits Protocol or Social Value Framework

WHEREAS, Council did not approve the Budget amendment to spend an additional \$75,000 to continue the development of a Community Benefits Protocol or Social Value Framework during the 2025 Budget;

WHEREAS, staff recommended the use of an unallocated \$75,000 from the tax stabilization be used to pilot a Social Value Procurement program as a first step in developing a Community Benefits Protocol (Social Value Framework) that would guide the City of Hamilton in the corporation's social value/community benefits efforts;

WHEREAS, the development of a Community Benefits Protocol or Social Value Framework is foundational work and essential to the overall success of a pilot Social Value Procurement program; and,

WHEREAS, City staff have advised that the pilot Social Value Procurement program could be paused, and re-introduced for consideration as part of the 2026 budget process, in order to instead develop a Community Benefits Protocol or Social Value Framework in 2025

THEREFORE, BE IT RESOLVED:

That up to \$75 K from the Tax Stabilization Reserve (110046) be allocated to fund the development of the Community Benefits Protocol or Social Value Framework and that the consideration of a pilot Social Value Procurement be deferred pending completion of the Community Benefits Protocol or Social Value Framework.

Historic Background on Community Benefits Committee



HISTORICAL BACKGROUND

The concept of Community Benefits has been of interest to the City of Hamilton since 2018, when Council approved a motion to establish a Community Benefits Protocol Sub-Committee, supported by the Hamilton Community Benefits Network (HCBN). At that time, City staff were also investigating procurement-led Community Benefits and between 2018 and 2019, the City's Procurement Team piloted a series of procurement projects that utilized social value criteria in their Request for Proposals. Lacking the necessary staff resources and capacity, in addition to concerns over the projects, the pilot project model led by the Procurement Division did not continue past its initial phases, and projects that were part of the pilot were not monitored for social value outcomes.

The Community Benefits Protocol Sub-Committee's Terms of Reference were established in 2019, approved by Council in 2022, and amended by Council in 2023. The Community Benefits Protocol Sub-Committee's Terms of Reference indicate that the Committee's purpose is three-fold:

- To develop a protocol for the use and prioritization of Community Benefits Agreements in the City of Hamilton.
- To consider opportunities to include Social Procurement within publicly funded tenders.
- To create a venue to inform, connect and encouraged Community Benefits Agreements within the City.

The first Community Benefits Protocol Sub-Committee meeting was held on September 28, 2023.
