6. ITEMS FOR INFORMATION (Item 8)

(i) Research A Grave (Item 8.1)

There have been two informative presentations to Navy Cadet Units, and a third scheduled this week. There is an enthusiasm to participate. Staff Liaison and T. Ryan to schedule time to present to Army Cadets.

(ii) Decoration Day (Item 8.2)

February 25, 2025

T. Ryan presents an alternative suggestion for grave decorating for 2025: Have cadet officers look after each of their units and explain the movement through the cemetery to the younger cadets. Once the ceremony has concluded, split the cadets evenly (not by their units) so that each decorating team has the same amount of people. Cadet officers can supervise the units and move them from South-West section to North-East section with all decorating teams ending near York Street.

(iii) Merchant Mariner Marker (Item 8.3)

Committee is awaiting word from Pier 8 regarding potential placement. The Chair is to write a letter on behalf of the Committee to move the plans forward.

(iv) Breadth of Garrison and Cadet Representation on Committee (Item 8.4)

There should be representation on the Committee from different units and volunteer groups to ensure that the Committee's mandate is met and that there is better communication regarding information and concerns. This would include: Artillery, Signals, Cadets and Legion members. These individuals could join as resource members to begin with. Committee Members are asked to bring name suggestions to The Chair.

(v) Listing of Remembrance and Memorial/Anniversary Services (Item 8.5)

Committee members are interested in using a webpage on The City of Hamilton's website to promote events and services throughout the year. The Chair has asked for a discussion of ideas at the March Meeting. C. King also offered The Hamilton Civic Museums website as an option for a webpage.
