THE GOVERNANCE REVIEW SUB-COMMITTEE PRESENTS REPORT 11-005 AND RESPECTFULLY RECOMMENDS:

1. 2012 Committee Calendar (Item 4.1)

- (a) That the 2012 Committee/Council Calendar amended as follows, and attached as Appendix "A", be approved:
 - (i) That Board of Health meet on the third Monday of every month commencing at 1:30 p.m.;
 - (ii) That the General Issues Committee meet on the first and third Wednesday of every month commencing at 9:30 a.m.;
 - (iii) That the Emergency & Community Services Committee meet on the second Monday of every month commencing at 1:30 p.m.;
 - (iv) That the Audit, Finance & Administration Committee meet on the second Monday of every month commencing at 9:30 a.m.;
- (b) That the amendments to the 2012 Committee/Council Calendar be implemented on a one year trial;

- (c) That staff be directed to prepare the necessary amendments to the Procedural By-law;
- (d) That staff be directed to report back to the Governance Review Sub-Committee prior the end of 2012 with the results of the one-year trial period.

(a) APPROVAL OF MINUTES

(i) October 6, 2011

The minutes of the October 6, 2011 Governance Review Sub-Committee meeting were approved.

(b) DISCUSSION ITEMS

(i) 2012 Committee Calendar (Item 4.1)

The Deputy Clerk, Ms. Gallagher, discussed the proposed two General Issues Committee (GIC) calendar. Staff has consulted with the Senior Management Team respecting the calendar. With the move to two GIC dates, both Audit Finance & Administration and Emergency & Community Services would be scaled back to one meeting per month. The Committee expressed interest in having the Board of Health meet on the same day that Public Works commences their first monthly meeting. Furthermore, the Committee wanted to amend the Committee calendar with the prescribed changes for a one-year trial period.

(ii) Disclosure Policy for Expenses Submitted by Elected Officials and Senior Staff (Item 4.2)

Councillor Clark indicated that a report is forthcoming from the City Manager's Office respecting proactive disclosure. A proactive approach would lower the number of Freedom of Information requests and add to the transparency of Councillor's expenses. Ms. Barroso, Manager of Records and Freedom of Information gave an overview of what other municipalities and levels of government are doing to provide financial disclosure of elected officials.

The Disclosure Policy for Expenses Submitted by Elected Officials and Senior Staff, was moved to the Outstanding Business List to return in the 2nd guarter of 2012.

(iii) Opening Prayer at City Council (Item 4.3)

The Committee discussed the letter sent to Council by Mr. Jelly respecting the prayer at City Council meeting. The Committee indicated that they are comfortable with the process currently in place. The Committee indicated that they would like to have the details of the current process posted on the City's webpage for public knowledge.

The correspondence respecting the Opening Prayer at City Council meetings, was received.

(c) OTHER BUSINESS (Item 5)

(i) Ward Boundary Review

The Committee indicated that they would like to have the issue of Ward Boundary Review appear on the next agenda.

(ii) Agenda Review & Print Schedule

Ms. Gallagher raised the issue of Agenda Review meetings with Committee Chairs and their preference to scheduling reviews prior to agenda printing or after. Ms. Gallagher also addressed the current concerns respecting meeting the print and delivery deadlines if reviews are conducted prior to agenda printing. Committee members preferred the pre-printing agenda reviews, and suggested that the deadlines be moved up to accommodate the print and delivery deadlines required by Clerks.

(d) ADJOURNMENT (Item 6)

The Governance Review Sub-Committee meeting was adjourned at 2:45 p.m.
