## 6.2 Removal of Parking Meters in Downtown Stoney Creek and Downtown Waterdown

## (Clark/Partridge)

Whereas the parking meters in Downtown Stoney Creek and Downtown Waterdown were installed primarily to generate revenue, and

Whereas the parking meters in Downtown Stoney Creek and Downtown Waterdown have financially underperformed since being installed on July 1, 2010, and

Whereas the actual annual revenues are only approximately \$53,000 combined for the parking meters in Downtown Stoney Creek and Downtown Waterdown.

#### Therefore be it resolved:

- (a) That the on-street parking meters in Downtown Stoney Creek and Downtown Waterdown be removed and that staff be directed to prepare a by-law amendment to restore the previous on-street parking regulations; and
- (b) That the revenue shortfall in the operating budget be dealt with during the 2012 budget process.

## 7. NOTICE OF MOTION

7.1 Councillor B. McHattie introduced the following Notice of Motion:

## **Hamilton Conservation Authority Surcharge**

Whereas, the 2012 Rate Supported Budget is fully funde d and is a self supported budget outside of the Tax Supported Budget process;

Whereas, the HCA has identified a 2012 budget pressure of \$40,000 in relation to the cost of wastewater charges specific to the operation of the Wave pool;

Whereas, the 2012 Rate Supported Budget did not assume the \$40,000 surcharge revenue against the HCA;

Therefore Be It Resolved:

That the Mayor and City Clerk be authorized and directed to execute a Surcharge Agreement between the City of Hamilton and the Hamilton Conservation Authority with respect to the wastewater services at the Wild Waterworks Wave pool, effective January 1, 2013, in form satisfactory to the City Solicitor.

### (McHattie/Johnson)

That the rules of order be waived in order to allow for the introduction of a motion respecting Hamilton Conservation Authority Surcharge.

## **Hamilton Conservation Authority Surcharge**

#### (McHattie/Johnson)

Whereas, the 2012 Rate Supported Budget is fully funded and is a self supported budget outside of the Tax Supported Budget process;

Whereas, the HCA has identified a 2012 budget pressure of \$40,000 in relation to the cost of wastewater charges specific to the operation of the Wave pool;

Whereas, the 2012 Rate Supported Budget did not assume the \$40,000 surcharge revenue against the HCA;

Therefore Be It Resolved:

That the Mayor and City Clerk be authorized and directed to execute a Surcharge Agreement between the City of Hamilton and the Hamilton Conservation Authority with respect to the wastewater services at the Wild Waterworks Wave pool, effective January 1, 2013, in form satisfactory to the City Solicitor.
