RE: Notice of Commencement Under Ontario Regulation 287/07 Preparation of Drinking Water Source Protection Plans

This letter is to notify you that the Halton-Hamilton Source Protection Committee has begun preparing Source Protection Plans under the *Clean Water Act* to address threats to the sources of water for the municipal drinking water supplies in your area.

Source Protection Plans will build on the science of now-completed Assessment Reports. The Assessment Reports identify vulnerable areas where activities could impact the quality and/or the quantity of the water reaching the municipal wells or lake intakes. The risk to the water supplies has been assessed and threats ranked at low, moderate or significant levels.

According to provincial law, Source Protection Committees must develop policies to address significant threats. This policy development process is now starting.

## Background

The Clean Water Act was passed in 2006 as a result of the Walkerton water crisis in 2000. This Act requires communities across Ontario to establish Source Protection Committees to develop science-based plans to protect drinking water at the source, before it even reaches municipal treatment plants. Following provincial government approval, municipalities will implement these source water protection policies to reduce risk in areas that are 'vulnerable' to contamination. Source protection is a key component of a multi-barrier approach designed to safeguard Ontario's drinking water and human health.

## Source Protection Plans

## The Plans will:

- 1. Propose measures to protect water sources from current activities in the vulnerable areas that might contaminate our municipal drinking water.
- 2. Propose measures to prevent any future activities in these vulnerable areas that may contaminate our municipal drinking water.
- 3. Include policies that are strategic in nature on such topics as spill prevention and water conservation.

The committee has a number of "tools" when developing policies. These include:

- 第5分 (中) (中) Education and outreach about activities that could result in a significant threat;
  - Incentive programs;
  - Provincial instruments, such as certificates of approval and nutrient management plans;
  - Risk management plans negotiated with the landowner;
  - Restriction or prohibition of activities; or
  - Combination of the above.

Over the course of the next year, the Source Protection Committee will develop the Source Protection Plan with an explanatory document explaining the rationale behind the policies. Your agency will be given opportunities to provide input. The Source Protection Committee is committed to maximum accountability and transparency in the preparation of Source Protection Plan policies and is consulting with staff of your agency.
