# THE GENERAL ISSUES COMMITTEE PRESENTS REPORT 11-024 AND RESPECTFULLY RECOMMENDS:

#### 1. Peter Hutton, Chair of the Waste Reduction Task Force (Added Item 6.1)

That the presentation from Peter Hutton, Chair of the Waste Reduction Task Force, respecting the Solid Waste Management Master Plan, be received.

#### 2. Staff Presentations (Items 7.1, 8.1 and 8.2)

That the following staff presentations be received:

- (a) Solid Waste Management Master Plan Review;
- (b) Waste Collection and Recycling Processing Procurement Processes for 2013-2020 (PW11030(a)) (City Wide)
- (c) Illegal Dumping, Litter and Escaped Waste (PW11052/PED11127) (City Wide)

## 3. Waste Collection and Recycling Processing Procurement Processes for 2013-2020 (PW11030(a)) (City Wide)

- (a) That staff be directed to issue a Request for Proposals (RFPs) and undertake internal costing to obtain pricing on the following waste collection options:
  - (i) Status Quo with Enhancements:
    - (1) weekly 2-stream recycling collection of paper and containers, co-collected;
    - (2) weekly green cart and leaf and yard waste (LYW), co-collected;
    - (3) weekly garbage (one bag) and call-in bulk collection, collected together
  - (ii) Alternate Week Garbage with Enhancements
    - (1) weekly 2-stream recycling collection of paper and containers, co-collected;

- (2) weekly green cart and LYW, co-collected;
- (3) bi-weekly garbage (2 or more bags) and call-in bulk, collected together.
- (iii) Status Quo
  - (1) weekly 2-stream recycling collection of paper and containers, co-collected
  - (2) weekly garbage and green cart collection, co-collected;
  - (3) seasonal bi-weekly collection of leaf and yard waste;
  - (4) seasonal weekly call-in collection of bulk waste when leaf and yard waste is not collected.
- (b) That staff be directed to review and report back on the following further refinements to curbside waste collection practices:
  - (1) Alternatives for recycling collection to reduce escaped waste;
  - (2) Options for considering the implementation of a tag system as a potential contribution to reducing illegal dumping;
  - (3) Options for container limits for bi-weekly garbage collection;
  - (4) Review options for smaller green carts
- (c) That the General Manager of Public Works be authorized and directed to enter into negotiations with Canada Fibers Limited for an additional seven years beyond the current contract term which expires on March 30, 2013 for the operation of the City's Materials Recycling Facility;
- (d) That the General Manager of Public Works be authorized and directed to negotiate with Canada Fibers Limited for necessary capital equipment for the operation of the Materials Recycling Facility;
- (e) That staff report back to Council on the outcome of the negotiations for Recommendations (c) and (d);
- (f) That staff undertake a financial analysis of pricing from recommendations (a) and (b) and report back on the waste collection and materials recycling processing components of the waste management system so that new contracts for service may be awarded.
- (g) That the procurement and internal costing processes for waste collection services include an option for an annual collection event for each of the six waste collection zones in the City.

### 4. Illegal Dumping, Litter and Escaped Waste (PW11052/PED11127) (City

(a) That the General Manager of Public Works be directed to:

- (i) report back to the Public Works Committee with the 2012 work plan for the Clean City Strategy before the end of 2011;
- (ii) provide an semi-annual Clean City Strategy progress report to the General Issues Committee.;
- (b) That Public Works and Planning and Economic Development Departments staff be directed to undertake investigations and report back comprehensively in the Fall of 2011 on:
  - (i) educational efforts towards illegal dumping, litter and escaped waste in the City;
  - (ii) improvements to the Waste, Streets, Parks and Yard Maintenance By-Laws to enhance the effectiveness of enforcement of illegal dumping;
  - (iii) enforcement strategies, service levels and staffing requirements to adequately address illegal dumping complaints.
  - (iv) minimum fees and tipping fees at the City's Community Recycling Centres/Transfer stations and potential fee changes as a way to reducing illegal dumping.
- (c) That staff be directed to implement the following action plans to address areas of concern identified by Councillors as outlined in Appendix "A," attached hereto, as amended:
  - Continued attention to clean up of litter, illegal dumping and escaped waste on areas of concern on City lands through existing programs, including prioritization and regular monitoring of these locations;
  - (ii) Continued enforcement on private lands;
  - (iii) Arrange to meet with agencies to develop plans to address remediation and prevention for the areas of concern;
  - (iv) Report back on progress as part of recommendation (b).

On a motion, the request from Peter Hutton, Chair of the Waste Reduction Task Force, was approved, and that the rules of order were waived to allow the delegation to address the Committee at today's meeting.

#### (e) DELEGATION REQUESTS

#### (i) Peter Hutton, Chair of the Waste Reduction Task Force

Peter Hutton, Chair of the Waste Reduction Task Force (WRTF), appeared before the Committee to express views on behalf of the WRTF and his own with respect to the Solid Waste Management Master Plan. His comments included, but were not limited to, the following:

- Reason for presenting is predicated on seeing two recent articles in the Spectator, one by Andrew Dreschel and the other from Beth Goodger
- Need to know that there are varying points about these issues Council – July 7, 2011

- Concerned about how citizen participation is being handled around this issue; WRTF is extremely frustrated; citizens should have stronger input
- Task Force was not consulted; not involved in the process
- Urge committee to be careful about signals being sent; struck by the fact of how little actual hard data on economic impact; Council needs to geta handle on how it does evaluation; does not seem to have facts; use expertise that the community has to offer to make the best decisions
- Fair to say that virtually all members of he Task Force are sending the signal today that going to a relaxed bag limit without really having determined whether this will solve the problem; may start undoing much of the work that the WRTF has been working on for 10 years; it's about changing attitudes and habits; citizens want open process
- Rewarding people who choose to disobey the law; education and enforcement always has to be part of the puzzle; start rewarding good behaviour of the vast majority of citizens who want this to work
