I am seeking your assistance to have a charge of \$5,000 which was wrongfully placed on my property tax bill be removed.

My propert at the above address has been completely fenced in and padlocked for the past 3 years.

I received a work order from property standards on may 8 2011 to which I complied And phoned their office on may 15 2011 and informed them of this.

On may 23 2011 I went to my property and found a man working to repair a section of the fence that he had broken down to gain entrance to the property. I asked the man who gave him permission to be there and he said that he was working for the city. I went imedeatly to the office at 77 James St. N where I spoke with Mr. Sertic who was in charge of my file. My file was pulled and there was no other work order other than the one I hadAlready complied with.

He said I should go back and ask him to leave as there was no authorization from the Office for anyone to be there doing work. He assured me that no charge would be placed against me for any work done. When I returned the fence was repaired and the man had Already left. I also noticed that the frames around the front of the house had been painted.

When I went to pay my property tax I was shocked to find that an exorbitant charge of \$5,000 was placed against my tax bill, for which there is no substancial work. I went back to the office on James St. to clarify the matter and was told I should call the supervisor kim Coombs. After several weeks of calling and leaving messages a gentleman called to say that there was another work order issued on jan.31 2011. There was a mailbox at the house and I did not receive this other work order.

The order I recived on may 8 2011 to which I complied, did not mention any work that was supposedly mentioned in the jan.31 order.

This is a severe burden for me and the city is charging me penalties on top of this everyday. Your assistance in this matter is greatly appreciated?
