CITY OF HAMILTON

BY-LAW NO. 12-

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Belmont East Cannon to Campbell 1 hr 8 am – 5 pm Mon – Fri"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Locke West Canada to 53 feet southerly Anytime"

and by adding to Section "E" thereof the following item, namely:

"Rosseau West Montrose to Hixon Anytime"

and by adding to Section "G" (Loading Zones) thereof the following item, namely:

“Locke West from 9m south of Canada to Anytime”
6m southerly

3. Schedule 10 (Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

“Rosseau Greenhill to T. H. & B. Railway West East”

and by adding to Section "E" thereof the following item, namely:

“Rosseau Greenhill to Montrose West East”

4. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

“Caroline West from 32m south of Market to 6.1m Anytime
southerly

Glassco West from 45.9m north of Dunsmure to Anytime
6.1m northerly

Murray South from 12.3m west of Mary to 6m Anytime
easterly

Rosslyn East from 38.8m south of Campbell to Anytime
5.5m southerly

Rosslyn West from 47.5m south of Campbell to 6m Anytime”
southerly

and by adding to Section "E" thereof the following items, namely:

“Belmont East from 67.3m north of Cannon to 5.8m Anytime
northerly

Cope East from 17.5m south of the extended Anytime
south curb line of Hope to 6m
southerly

Oak East from 57.2m north of Cannon to 5.8m Anytime”
northerly

5. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"John	West	Robert to 20.8m southerly	Anytime
John	East	Robert to 17m southerly	Anytime"

6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
7. This By-law shall come into force and take effect on the date of its passing and enactment.
