THE ACCOUNTABILITY AND TRANSPARENCY SUB-COMMITTEE PRESENTS REPORT 12-002 TO THE GENERAL ISSUES COMMITTEE AND RESPECTFULLY RECOMMENDS:

- 1. Review of the Integrity Commissioner's Contract Renewal (Verbal) (Item 6.1)
 - (a) That the Integrity Commissioner's Contract be amended to include the following provisions:
 - (i) That the Integrity Commissioners contract be amended in Schedule "A", to include under the sub-section "service", to include the following words, "that the Integrity Commissioner be available for up to three meeting invitations annually from community groups, with only out of pocket expenses being reimbursed.";

- (ii) That the initial point of contact be from the Integrity Commissioner to Councillors when a complaint is filed;
- (iii) That a notice of receipt and a 36-hour time frame for responses from the Integrity Commissioner be established for both citizen and Councillor inquiries."
- (b) That By-law No. 08-154, To Establish The Office Of the Integrity Commissioner, be amended to include the following provisions:
 - (i) That Section 22.(1) of the By-law be amended and that the contract be amended to include that, "the Integrity Commissioner is to report back to Council within 60-days of receipt of a complaint, unless the Integrity Commissioner makes application for an extension.";
 - (ii) That the by-law be amended to include a statement indicated that a media blackout be upheld from when the complaint is filed to when the final ruling is presented to Council. Should the complainant speak to the media, the complaint will be immediately dismissed;
- 2. Closed Meeting Investigations (LS12008) (City Wide) (Item 6.2)

Staff are to report back with a suggested revision to the bylaw that will have a time limitation to when an individual may file a complaint that matches the stipulations outlined in the Police Services Act for a complaint of conduct of a police officer.
