- (a) That the portion of unopened road allowance being Part 2 (unnamed road allowance, Registered Plan 310) and Part 5 (Elizabeth Street, Registered Plan 310) on Plan 62R-14865 be permanently closed and transferred to Movengo Corp. the adjacent owner of Parts 1, 3 and 4 on Plan 62R-14865, as shown on Appendix B attached to Report PW12046, subject to the following conditions:
 - That the applicant makes an application to an Ontario Superior Court of Justice Court, under Section 88 of the Registry Act, R.S.O 1990, for an order to permanently close and purchase the subject lands;
 - (ii) That the General Manager, Public Works or his designate sign the appropriate documentation confirming that no public funds have been expended on the lands to be closed;
 - (iii) That the documentation regarding the application to the District Court Judge be prepared by the applicant, to the satisfaction of the City Solicitor;
 - (iv) That the applicant register a reference plan under the Registry Act and that the said plan be prepared by an Ontario Land Surveyor to the satisfaction of the Manager, Surveys and Technical Services Section and that the applicant deposit a

reproducible copy of said plan with the Manager, Surveys and Technical Services Section;

- (b) That provided the Judge's Order to permanently close the lands is granted:
 - (i) That the City Solicitor be authorized and directed to prepare a by-law to permanently close the highway;
 - (ii) That the appropriate by-law be introduced and enacted by Council;
