#### **RECOMMENDATIONS:**

- a) That the Bicentennial closing event, William Claus Wampum Belt and 200 Years of Peace Project, be approved as part of the War of 1812 Bicentennial Commemoration Program;
- b) That the \$80,000 in funding approved through the City of Hamilton's War of 1812 Bicentennial Commemoration Program Report CS11075 for the *Movement of Troops from Fort George to Stoney Creek* event be reallocated to support the *Tall Ships*® *Hamilton 2013* and the Bicentennial closing event *William Claus Wampum Belt and 200 Years of Peace Project*;

#### **EXECUTIVE SUMMARY**

The Movement of Troops from Fort George to Stoney Creek event was identified as a signature event with an \$80,000 budget as part of the City of Hamilton's War of 1812 Bicentennial Program as approved by City Council on December 14, 2011 (Report CS11075). The event was initiated by Parks Canada staff in 2009. Communications between staff and the Parks Canada Special Events Coordinator in September 2012 confirm that Parks Canada is not coordinating or funding a Tall Ships tour between Niagara and Hamilton as had been anticipated. As a result, the event has been removed from the City of Hamilton's War of 1812 Bicentennial Commemoration Program.

Cancellation of the *Movement of Troops from Fort George to Stoney Creek* event provides an opportunity for Hamilton to reallocate the event's \$80,000 budget to support two other signature events. Hamilton's War of 1812 Bicentennial Community Advisory Committee supports reallocation of funds to the *Tall Ships® Hamilton 2013* (reallocated amount of \$25,000) and the Bicentennial closing event focusing on the *William Claus Wampum Belt and 200 Years of Peace Project* (reallocated amount of \$55,000).

#### FINANCIAL / STAFFING / LEGAL IMPLICATIONS

**Financial:** No new funding is being requested for the Hamilton's Bicentennial Commemoration, only a re-allocation of previously approved funds.

Recommendation (c) of Report PED12204 requires that recommendation (b) of Report CS11075 be amended such that the capital funding in the amount of \$447,200 be distributed annually over four years as follows: \$118,500 in 2012; \$251,700 in 2013; \$47,000 in 2014; and, \$30,000 in 2015.

#### HISTORICAL BACKGROUND

The years 2012-2015 mark the 200<sup>th</sup> anniversary of the War of 1812, a three-year war that resulted in the establishment of Canada as a nation. The Hamilton area saw significant activity during the War of 1812 with the following events:

Spring 1813	British forces take over Burlington Heights and turn it into a fortified supply depot
June 6, 1813	Battle of Stoney Creek
August 6, 1813	Ships the <i>Hamilton</i> and the <i>Scourge</i> sink during a storm on Lake Ontario
September 28, 1813	The Burlington Races - American and British ships in Lake Ontario manoeuvre for advantage as they try to reach Burlington Bay
May through July, 1814	Treason trials known as the Bloody Assizes begin in Ancaster and end with hangings on Burlington Heights
April 24 – 26, 1815	British, Six Nations and other indigenous nations met at Burlington Heights to discuss the War of 1812 peace treaty; the Pledge of the Crown wampum belt was exchanged

The natural focal point for Hamilton's Bicentennial commemoration is 2013 because four of the six Hamilton area War of 1812 events occurred in 1813.

The City of Hamilton's War of 1812 Bicentennial Commemoration Program, and \$447,200 in capital funding for the program, was approved at City Council on December 14, 2011 as part of Report CS11075. The report identified signature events and bicentennial initiatives to be completed by Tourism and Culture Division staff from 2012 through 2015.

Staff continue to be engaged in a network of Bicentennial committees working with all levels of government to align Bicentennial initiatives to avoid duplication of, for example, events or research and to maximize funding opportunities such as developing collaboratives for granting programs or attracting business sponsors for jointly coordinated events.

#### ANALYSIS / RATIONALE FOR RECOMMENDATION

#### **Event Cancellation**

The Movement of Troops from Fort George to Stoney Creek event was initiated by Parks Canada staff in 2009 and was intended to add a week of tall ships activities between a re-enactment of the Battle of Fort George (May 24-26, 2013) and the reenactment of the Battle of Stoney Creek (May 30-June 2, 2013). The event was dependent on funding from Parks Canada to pay for the Tall Ship appearance fees (estimated at \$77,000) and the assistance of Parks Canada staff to develop a planning committee with municipalities along the South Western shore of Lake Ontario. As indicated in a communication from September 13 2012, the Committee has not been struck and no Parks Canada funding has been allocated to bring Tall Ships to each community.

The City of Hamilton committed \$80,000 to the *Movement of Troops from Fort George to Stoney Creek* event as approved at City Council on December 14, 2011. However, this budget was dependent on partnership funding. In the absence of partners, the budget is inadequate to mount the event as a solely City of Hamilton initiative. As a result, the event has been removed from the City of Hamilton's War of 1812 Bicentennial Commemoration Program.

It is important to note that cancellation of this event has no impact on the *Tall Ships*® *Hamilton 2013* event scheduled from June 28 - July 1, 2013 at Pier 8.

Cancellation of the *Movement of Troops from Fort George to Stoney Creek* event provides an opportunity for Hamilton to reallocate the event's \$80,000 budget to support two other signature events.

At the October 1, 2012 meeting of the City of Hamilton War of 1812 Bicentennial Community Advisory Committee supported the following reallocation of funds:

#### Reallocation to Tall Ships® Hamilton 2013

Tall Ships® Hamilton 2013 is the largest initiative in Hamilton's War of 1812 Bicentennial Commemoration Program. Staff have been working with representatives from Tall Ships America to understand the full logistical requirements needed to host four to five tall ships over the 2013 Canada Day long weekend. The most significant event expense is paying each ship's appearance fee which ranges in cost from \$10-\$15,000 per ship per day.

Hamilton is expected to receive funding through the Province's Ontario Blockbuster Grant Program which will cover a portion of the \$110-\$120,000 total ship appearance fees, however, funding to cover all ship appearance fees had been expected. The Tall Ships are the most important element of the event and as such, a \$25,000 budget reallocation is requested so that the greatest number of Tall Ships possible can be brought to Hamilton.

### Reallocation to the Bicentennial Closing Event William Claus Wampum Belt and 200 Years of Peace Project

Reallocating budget to the closing event would expand the City's Bicentennial Commemoration Program to include themes and issues that are currently under-represented. Hamilton's War of 1812 Bicentennial Community Advisory Committee has identified weaknesses in the current program including a lack of initiatives that focus on First Nations community, perspective and history, and initiatives that explore the 200 years of peace found after the War of 1812.

At the end of the war in 1815, Col. William Claus, the British Superintendent of Indian Affairs, met with Six Nations and other indigenous nations to discuss the end of the War of 1812. Claus offered a wampum belt, now referred to as the *William Claus Wampum Belt*, to Six Nations Chiefs as a pledge by the Crown to renew their alliance, to protect Six Nations cultural rights and to uphold Six Nations right to govern themselves. To ancestors and the current generation of Haudenosaunee, the 1815 pledge by Claus is a solemn vow of the British Crown.<sup>1</sup>

As stated by the Six Nations Legacy Consortium in a press release in June 2012:

"Wampum belts, especially the Covenant Chain, treaty belts and the Pledge of the Crown belt are not quaint Native artifacts. They exist as formal, diplomatic protocols that were adopted by the officials of Great Britain. Some of these belts were crafted by the Crown officials and their solemn pledges and agreements were recorded in the tiny shell beads that were woven into- belt-like documents. The wampum connects our people in profound ways."

An event commemorating the William Claus Wampum Belt and the 200 years of peace that followed it, will be planned for Burlington Heights in 2015 by staff working collaboratively with representatives from Six Nations Legacy Consortium and the Culture of Peace Network Hamilton organization. See letters of support from the Six Nations Legacy Consortium and the Culture of Peace Network Hamilton organization attached as Appendices A and B to Report PED12204.

#### **ALTERNATIVES FOR CONSIDERATION:**

#### <u>Alternative 1</u> – Reallocation to Bicentennial closing event only

Reallocate \$55,000 of the War of 1812 Bicentennial Commemoration Program approved budget to the bicentennial closing event *William Claus Wampum Belt and 200 Years of Peace Project* and remove \$25,000 from the War of 1812 Bicentennial Commemoration Program approved budget.

Reallocating budget to the *William Claus Wampum Belt and 200 Years of Peace Project* would expand the City's Bicentennial Commemoration Program to include themes and issues that are currently under-represented. The event allows the City to work collaboratively with the Six Nations Legacy Consortium and the Culture of Peace Network Hamilton to acknowledge the complexity of war, allies, treaties and peace.

Alternative 1 does not provide additional support to the *Tall Ships*® *Hamilton 2013* event and will limit the number of Tall Ships brought to Hamilton.

**Financial:** \$25,000 would be removed from the City of Hamilton's War of 1812 Bicentennial Commemoration Program capital budget and recommendation (b) of Report CS11075 would require amending such that capital funding in the amount of \$422,200 be distributed annually over four years as follows: \$118,500 in 2012; \$226,700 in 2013; \$47,000 in 2014; and \$30,000 in 2015.

**Staffing:** There are no staffing implications associated with Alternative 1.

**Legal:** The legal implications of Alternative 1 would remain the same as those to the Recommendations of Report PED12204.

#### Alternative 2 – Reallocation to Tall Ships® Hamilton 2013 event only

Reallocate \$25,000 of the War of 1812 Bicentennial Commemoration Program approved budget to the *Tall Ships® Hamilton 2013* event and remove \$55,000 from the War of 1812 Bicentennial Commemoration Program approved budget.

Reallocation of funds only to the *Tall Ships® Hamilton 2013* would ensure that the extensive logistic needs of the tall ships are met and that there is adequate War of 1812 themed programming available to event attendees.

Alternative 2 does not alter the City of Hamilton's War of 1812 Bicentennial Commemoration Program significantly enough to address the weaknesses (a lack of First Nations and peace themed programming) that have been identified in the current program.

**Financial:** \$55,000 would be removed from the City of Hamilton's War of 1812 Bicentennial Commemoration Program capital budget and recommendation (b) of Report CS11075 would require amending such that capital funding in the amount of \$392,200 be distributed annually over three years as follows: \$118,500 in 2012; \$251,700 in 2013; and \$22,000 in 2014.

**Staffing:** There are no staffing implications associated with Alternative 2.

**Legal:** The legal implications of Alternative 2 would remain the same as those to the Recommendations of Report PED12204.

### <u>Alternative 3</u> – Removal of *Movement of Troops from Fort George to Stoney Creek* event budget from capital allocation

That \$80,000 for the now cancelled *Movement of Troops from Fort George to Stoney Creek* event be removed from the War of 1812 Bicentennial Commemoration Program approved budget.

Alternative 3 does not alter the City of Hamilton's War of 1812 Bicentennial Commemoration Program significantly enough to address the weaknesses (a lack of First Nations and peace themed programming) that have been identified in the current program. In addition, support will not be provided to the *Tall Ships® Hamilton 2013* event which will limit the number of Tall Ships brought to Hamilton.

**Financial:** \$80,000 would be removed from the City of Hamilton's War of 1812 Bicentennial Commemoration Program capital budget and recommendation (b) of Report CS11075 would require amending that capital funding in the amount of \$367,200 be distributed annually over three years as follows: \$118,500 in 2012; \$226,700 in 2013; \$22,000 in 2014.

**Staffing:** There are no staffing implications associated with Alternative 3.

**Legal:** The legal implications of Alternative 3 would remain the same as those to the Recommendations of Report PED12204
