

CITY OF HAMILTON

BY-LAW NO. 12-

**To Amend By-law No. 01-218, as amended,
Being a By-law To Regulate On-Street Parking**

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Parking Meters) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Locke Both Main to 37m south of Herkimer 2 hr \$1.00"

and by adding to Section "E" thereof the following item, namely:

"Locke Both Main to 37m south of Herkimer 3 hr \$1.00"

2. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Edinburgh South Ottawa to London 1 hr Anytime Anyday"

3. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "C" thereof the following item, namely:

7. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

“Glennie	East	from 32.8m south of Melvin to 7.8m southerly	Anytime”

8. Schedule 15 (Commercial Vehicle Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

“Hughson East from 12.7m north of King to 28.4m northerly Anytime”

and by adding to Section "E" thereof the following item, namely:

“Hughson East from 12.7m north of King to 28.4m northerly 7:00 a.m. to 9:00 p.m.”

9. Schedule 16 (Taxi Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

“Hughson East from 12.7m north of King to 28.4m northerly 9:00 p.m. to 7:00 a.m.”

Hughson East from 17.7m north of King William to 12m northerly 9:00 p.m. to 7:00 a.m.”

10. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.

11. This By-law shall come into force and take effect on the date of its passing and enactment.
