**BY-LAW NO. 12-**

## To Amend By-law No. 01-215 Being a By-law To Regulate Traffic

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215.


"Hillcrest Ave. Eastbound/Westbound Beulah Ave."


and by adding to Section "E" (Hamilton) thereof the following item, namely:
