### 5. Matters Arising From Minutes.

7.2.3 T. Roglic followed up with Gail Belisario, Principal of Equity at the HWDSB regarding the status of the Black History Committee. The decision to suspend the Black History Committee was in part due to staff unavailability and the political climate last fall. There is an opportunity for either the Black History Society to revive the committee or students to take more of a leadership role, with the passing of Bill 13- the Acceptance Schools Act, which give students autonomy to form clubs that they feel aligns with their needs and issues. Jessica Brennan volunteered to follow up.

- **6. Presentations-** Maureen Brown, Facilitator/Consultant, Anti-Racism Resource Centre Project
  - **6.1** Maureen Brown presented a summary of the Anti-Racism Resource Centre consultation report highlighting the following:
    - Survey responses were received from 6 organizations
    - Responses indicated a clear need for the role that a resource centre could play in enhancing capacity to address the impacts of racism on the lives of Hamilton's racialized citizens.
    - The participation from Social Service Agencies funded to provide anti-racism, antioppression, diversity and discrimination services was minimal
    - It is clear that many of the agencies that serve racialized clients are limited in their ability to address racism-related challenges their clients face.
    - Key funding sources/partners were proposed such as foundations, businesses, schools and parents.
    - Participants felt that overall the Centre will help create civic health; potentially lower absenteeism and crime; and build community safety and productivity.

M.Carter provided an overview from the two reports on the proposed Anti-Racism Resource Centre project and informed Committee that Sub-Committee I will have the final report for the Committee in September, anticipating that the approved recommendations will be presented to General Issues Committee in October or November 2013.

Members inquired whether there was a social auditor to hold organizations funded to do anti-racism work, accountable for their lack of due diligence. Due to the lack of such a social auditor, committee members suggested that the City of Hamilton could leverage diversity and anti-racism initiatives from through the funded agencies and City Partners. This idea would need to be further discussed and brought back to the full committee for decision

Committee was advised that sub-committee I had been reviewing the list of City funded agencies and projects.
