### 3. APPROVAL OF MINUTES OF PREVIOUS MEETING

#### 4. PRESENTATIONS

- 4.1 The Tipping Point: Love Food, Hate Waste presentation was given by Hélène St. Jacques, chair of the Toronto Food Policy Council. In Canada, 51% of food waste occurs in the home, and much of this is edible food. Can we address hunger with new strategies for reducing edible food waste? Have we reached the tipping point for new strategies that involve new skills, thrift pays, unavoidable & avoidable waste, good for the planet practices, labelling and new retail practices? Let's make the connections between food waste and
  - local food eaters & farmers.
  - human health,
  - well-being & vitality,
  - environmental protection, and
  - sustainable, healthy communities.

Although Hamilton recycles more food waste through the Green Bin program than Toronto, members acknowledged that food waste is a problem. Education appears to present the best opportunity to reduce food waste.
