## **CITY OF HAMILTON**

### **BY-LAW NO. 13-**

#### **To Amend the Sewer Use By-law No. 04-150 and Implement the 2014 Fees and Charges**

**WHEREAS** on June 30, 2004, the Council of the City of Hamilton passed and enacted By-law No. 04-150, known and referred to as the "Sewer Use By-law", which By-law came into force and effect on June 30, 2004;

**AND WHEREAS** pursuant to section 391 of the *Municipal Act, 2001*, S.O. 2001, c.25, sections 9 and 10 of the said Act authorize a municipality to pass by-laws imposing fees or charges for services or activities provided or done by or on behalf of the municipality and for the use of the municipality's property, including property under its control;

**AND WHEREAS** on the 11th day of December, 2013, the Council of the City of Hamilton did approve of Item 2 of General Issues Committee Report 13-022(a) and did authorize the 2014 fees and charges set out herein;

**AND WHEREAS** notice of the 2014 fees and charges set out herein has been given in accordance with the provisions of the City of Hamilton's Public Notice Policy By-law No. 07-351.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule D to By-law No. 04-150 is deleted and replaced with the new Schedule D attached to this by-law.
2. The fees and charges imposed by this by-law continue in force until amended, repealed or replaced (by by-law or by a resolution of the Council of the City of Hamilton confirmed by by-law) and for greater certainty this includes continuing in force after December 31, 2014 until amended, repealed or replaced.
3. This by-law comes into force on January 1, 2014.
