Dear Honourable Premier-designate Wynne and Minister Goodyear,

Hamilton City Council, at its Special meeting held on January 31, 2013, approved Item 7.1, which reads as follows:

**Ancaster Senior Achievement Centre Community Infrastructure Improvement Fund**

WHEREAS in its 2012 Budget, the Government of Canada allocated \$150 million to the newly created Community Infrastructure Improvement Fund ("CIIF") to rehabilitate and improve, and expand, existing community infrastructure facilities;

WHEREAS the Minister responsible for the Federal Economic Development Agency for Southern Ontario has agreed to make a non-repayable contribution to the City of Hamilton up to the maximum amount of five hundred thousand dollars (\$500,000) in support of the Expansion and Upgrades to the Ancaster Senior Achievement Centre;

WHEREAS on December 12, 2012 the Council of the City of Hamilton approved the Expansion and Upgrades to the Ancaster Senior Achievement Centre project with gross costs of one million five hundred thousand dollars (\$1,500,000) with five hundred thousand dollars (\$500,000) of the funding coming from the City of Hamilton;

WHEREAS the forecast budget and scope may require up to one million seven hundred fifty thousand dollars (\$1,750,000);

Therefore be it resolved:

- (a) That the Council of the City of Hamilton request that the Province of Ontario provide two hundred fifty thousand dollars (\$250,000) towards the Expansion and Upgrades to the Ancaster Senior Achievement Centre project, thereby maintaining the five hundred thousand dollars (\$500,000) level of commitment from both the City of Hamilton and the Federal Economic Development Agency for Southern Ontario;
- (b) That upon confirmation of Provincial funding, staff be directed to request an amendment to the contribution agreement with the Federal Economic Development Agency for Southern Ontario to reflect the revised one million seven hundred fifty thousand dollar (\$1,750,000) budget including a non-repayable contribution from the Federal Economic Development Agency for Southern Ontario of up to five hundred thousand (\$500,000).
- (c) That the Minister responsible for the Federal Economic Development Agency for Southern Ontario be notified in writing that the City of Hamilton has requested additional government financial support from the Province of Ontario for the Expansion and Upgrades of the Ancaster Senior Achievement Centre project as per section 5.2 of the Contribution Agreement.

Your consideration of this matter is greatly appreciated.
