Chris Murray, City Manager, provided and overview to the Future Fund Board members of the project. He introduced Paul Johnson, Director of Neighbourhood Development Strategies, who discussed the work done on the Pan Am Stadium Precinct and the recent partnering with the Hamilton Wentworth District School Board to redevelop the recreational facilities in that area. He discussed the co-locating of resources with the school and clarified that they are not funding the building of a school or the purchase of land.
