CITY OF HAMILTON

BY-LAW NO. 14-091

A By-law to Amend the Water and Wastewater/Storm Fees and Charges By-law No. 13-325

WHEREAS the Council of the City of Hamilton passed a by-law to establish and maintain a list of all of its water and wastewater/storm fees and charges for services, activities and use of property provided by the City of Hamilton, being By-law 13-325;

AND WHEREAS on the 9th day of April, 2014, the Council of the City of Hamilton did approve of Item 5 of Public Works Committee Report 14-004 and did approve the imposition of the water and wastewater/storm fees and charges resulting from the passing of a new Sewer Use By-law;

AND WHEREAS notice of the water and wastewater/storm fees and charges set out herein has been given in accordance with the provisions of the City of Hamilton's Public Notice Policy By-law No. 07-351.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. The Water and Wastewater/Storm Fees and Charges By-law No. 13-325 is amended by deleting section 13 and by renumbering the subsequent sections accordingly.
2. Schedule "B" to Water and Wastewater/Storm Fees and Charges By-law No. 13-325 is amended by deleting subsection D (Sewer Use By-law 04-150 Fees and Charges) and by replacing it with the new subsection D (Sewer Use By-law No. 14-090 Fees and Charges) attached as Appendix A to this By-law.
3. This By-law comes into force on May 1, 2014.
