#### HISTORICAL BACKGROUND

The Grand River Watershed is one of the largest in Ontario and a portion of this watershed (Fairchild Creek and Big Creek) is located within our municipal boundaries accounting for a significant portion of our rural lands. The Lynden municipal well owned

and operated by the City of Hamilton to supply drinking water to the community of Lynden is located within this watershed as well.

The Grand River Conservation Authority (GRCA) conceived their first water management plan in the 1930's, updated over the years with the last version dating back to 1982. Based on a collaborative initiative within the last few years between various agencies (municipalities, ministries, conservation authority) a new Grand River Watershed Water Management Plan has been drafted (refer to "Appendix A").

The Plan is a voluntary, collaborative process with no financial or legal obligation associated with it. The objective of the plan is to promote the adoption of best practices and the implementation of projects and programs that provide the greatest benefits relative to the effort.

The Water Management Plan consists of two sections. The first part provides an overview of the issues within the watershed and the latest scientific information on those issues as well as identifying the goals of the plan, which include:

- Ensure sustainable water supplies for communities, economies and ecosystems;
- Improve water quality to improve river health and reduce the river's impact on Lake Erie:
- Reduce flood damage potential; and
- Increase resiliency to deal with climate change.

The second part is the Integrated Action Plan, a compilation of recommendations and action Items. The recommendations identify the steps to be taken to reach the goals highlighted above while the action items are the tasks that partner agencies are already undertaking or plan to take to implement the recommendations.

Hamilton Water activities and mandate, even if not directly named in the report, at a municipal level aligns with a number of actions outlined in the plan such as ensuring sustainable (municipal and private) water supplies, proactively managing the water demand, reducing point source pollution by targeting wastewater effluent quality performance targets for phosphorus, reducing the non-point source pollution through appropriate stormwater management programs, outreach and education programs, etc.

Hamilton Water staff is supportive of this activity in the neighbouring Grand River Watershed. The principles identified in the Grand River Watershed Water Management Plan are consistent with City of Hamilton Strategic Priority #1 "A Prosperous and Healthy Community" and more specifically under objective 1.6 enhance overall sustainability.

The recommendation contained in this report support the Mission Statement of the Public Works Business Plan "Innovate Now" - "Provide safe, strategic and environmentally conscious services that bring our communities to life".
