Notice of Detail Design Project

Highway 6 Resurfacing (City of Hamilton, Haldimand County) Ministry of Transportation W.P. 2111-13-01, W.P. 2112-13-01

The Ontario Ministry of Transportation (MTO) has initiated Detail Design for resurfacing two (2) segments of Highway 6. Details of the proposed work include:

Segment 1 (W.P. 2111-13-01)

- Resurfacing Highway 6 from approximately 200 m south of Highway 5 to just south of Concession Road 6 West (City of Hamilton). The total length is approximately 6.2 km (project limits shown in attached key map).
- Culvert replacement and/or rehabilitation where necessary.
- Fence replacement along the highway right-of-way at select locations.

Segment 2 (W.P. 2112-13-01)

- Resurfacing Highway 6 from approximately 300 m north of Greens Road (Haldimand County) to approximately 200 m north of Old Highway 6/Highway 6 North Junction (City of Hamilton). The total length is approximately 6.0 km (project limits shown in attached key map).
- Minor widening of Highway 6 south of Chippewa Road West to expand the left turn lane and improve traffic operations.
- Culvert replacement and/or rehabilitation where necessary.

The project will involve milling and paving the full cross section of lanes for resurfacing, minor regrading to widen the left turn lane near Chippewa Road, and culvert works. There will be nighttime activities and lane closures necessary to expedite the work and minimize disruption to motorists and nearby residents. Work is currently scheduled to take place during the 2015 construction season, subject to receiving funding and all required approvals.

The project is following the approved environmental planning process for Group 'C' projects under the Class Environmental Assessment (EA) for Provincial Transportation Facilities (2000), which includes the preparation of Environmental Screening Documents to describe the proposed works and identify environmental mitigation measures.

The purpose of this letter is to inform you of this project and provide an opportunity for your input. Please provide any comments you may have about this project by **February 6, 2015.**




