## (i) King Street Transit Only Lane Pilot Project (PW11079(g)) (City Wide) (Item 8.3)

David Dixon, Director of Transit, provided a PowerPoint presentation respecting Report PW11079(g) - King Street Transit Only Lane Pilot Project. The presentation included, but was not limited to, the following:

- o King Street Transit Only Lane (TOL) Pilot Project
  - Council Approval May 22, 2013
  - o Operational since October 23, 2013
  - Funded from Metrolinx Quick Wins

## Monitoring Activities

- Transit Operations and Ridership
  - There has been a positive impact on transit travel times.
  - Operators found the Transit Only Lane made operations easier.
  - Ridership growth data specific to the Transit Only Lane Pilot period is not available.
  - Between 2009 and 2014 ridership along the corridor increased by approximately 4% Per Year.
  - Between 2009 and 2013 city wide ridership increased by approximately 1% per year.

## Traffic Analysis

- o Traffic along King Street has been affected.
- On average, it takes just over 5 minutes longer to drive through the corridor (p.m. rush hour).

#### Collision Data

 There have been collision increases in 2014 as compared to the previous 6 years.  Due to the short duration of the pilot, data is not statistically significant or sufficient to identify trends.

#### On Street Parking

- Payment method changed to pay and display kiosks (west of Bay Street).
- Parking usage is down from Caroline to Queen streets.

#### Enforcement and Driver Adherence

 Police Services advise (verbally) that 21 violations were issued to May 13, 2014.

#### Stakeholder Comments and Issues

- Cyclists
  - The Transit Only Lane should be a shared bus and bike lane.

#### o Impacts to Traffic

 Traffic in the core is congested due to the Transit Only Lane

## Businesses King Street West BIA

- Opposed to the Transit Only Lane, which is having an adverse impact on businesses.
- Opposed to the relocation of parking to the south side of King Street.

#### International Village BIA

 Out of 38 businesses: 9 in support; 8 unaffected and 21 not in support.

#### Taxis

- Preference is to have full use of the Transit Only Lane.
- Allowing loading/unloading in the Transit Only Lane was determined to be the best compromise.

#### Transit Passengers

- Positive feedback from transit passengers.
- Effectiveness of Public Transit King Street and Bay Street during the morning rush hour:
  - 3 general purpose lanes a volume of approximately 1,190 vehicles;
  - 1 Transit Only Lane approximately 1,104 passengers; and,
  - 1 lane dedicated to transit can be as effective in moving people as 2-3 general vehicle lanes.

#### Conclusions

- Moving forward with a proactive public transportation strategy will:
  - Avoid future traffic congestion and associated delays.
  - Avoid a need to invest more in roads.
  - Help achieve health, social and environmental benefits.
  - The Traffic Only Lane is an important and strategic step in developing the City's long term transportation network.

## (ii) Discontinuation of the Transit Only Lane Pilot Program

#### (Collins/Ferguson)

WHEREAS, the number of vehicular accidents has significantly increased along the Transit Only Lane Pilot route;

AND WHEREAS, many commercial operators have been adversely affected by the implementation and operation of the Transit Only Lane Pilot project;

AND WHEREAS, there are no documented transit benefits listed in the Transit Only Pilot report;

AND WHEREAS the Transit Only Lane Pilot project has created unnecessary traffic congestion, causing lengthy delays for downtown shoppers, residents, workers and merchants;

#### THEREFORE BE IT RESOLVED:

- (a) That the Transit Only Lane Pilot project be discontinued;
- (b) That staff be directed to make the necessary arrangements to return the transit lane to a fully functional lane for all vehicles; and,

(c) That staff be directed to prepare a by-law to amend By-law 01-215 to reflect these changes and present to Council for enactment.
