THE ACCESSIBILITY COMMITTEE FOR PERSONS WITH DISABILITIES PRESENTS REPORT 15-001 AND RESPECTFULLY RECOMMENDS:

1. Urban Braille Installation on Centennial Parkway (Added Item 6.1 (a))

That staff be directed to exam the feasibility of installing Urban Braille on Centennial Parkway from Delawana Avenue to Queenston Road.

2. Urban Braille Policy Review (Added Item 6.2 (b))

That the Urban Braille Policy, approved by Council on April 10, 2010, and the January 6, 2015 Report of the Built Environment Sub-Committee (attached hereto as Appendix A to ACPD Report 15-001), be reviewed as soon as possible.

That the Advisory Committee for Persons with Disabilities be consulted in the process of the review of the Urban Braille Policy and included in the site selection and criteria for Urban Braille implementation.

(i) Presentation from Al Fletcher, Manager, Licensing Inspections and Enforcement, respecting an Update on various issues in the Taxi Industry (Item 5.1)

Mr. Al Fletcher, Manager, Licensing Inspections and Enforcement, provided the Committee with a verbal update about various issues in the Taxi Industry.

Mr. Fletcher's presentation included, but was not limited to, the following:

General Issues Committee – February 4, 2015

- Status of Accessible Taxis
 - a total of 16 accessible taxis are now in licensed, inspected and in operation
 - in general the accessible taxi system is working well however two complaints about passengers with accessibility needs not being properly secured were received; the complaints were investigated and action was taken
 - all new drivers are required to take training in how to operate an accessible tax
- Schedule 25 of the Taxi By-law is being reviewed in 2015;
 Licensing staff will be consulting with the Committee about the proposed changes
- Issues surrounding Uber taxi service are being monitored by staff; under the current by-law Uber is considered a broker and as such must be licensed and Uber vehicles must be inspected

The update from Al Fletcher, Manager, Licensing Inspections and Enforcement, respecting a verbal update about various issues in the Taxi Industry was received.

(ii) Presentation from Dave Dixon, Director of Transit, respecting Introduction to the Committee as the New Director (Item 5.2)
