THE ADVISORY COMMITTEE FOR PERSONS WITH DISABILITIES PRESENTS REPORT 15-001 AND RESPECTFULLY RECOMMENDS:

1. Richmond Hill Accessibility Advisory Committee Meetings - Teleconferencing (Item 6.1)

- (a) That the Ontario Government consider the appropriate legislative amendments to the *Municipal Act, 2001* to permit telephone or video conference participating by appointed members of municipal accessibility advisory committees required by the *Accessibility for Ontarians with Disabilities Act, 2005*; with the understanding that participation for anyone with a disability will be provided in a manner that is fully accessible to that person.
- (b) That a copy of this motion be forwarded to the Council for the Town of Richmond Hill.

Healthcare Hamilton – Charlton Campus, St. Joseph's Healthcare Hamilton – King Campus, St. Joseph's Healthcare Hamilton – West 5th-Fennell Campus, Hamilton General Hospital, Juravinski Hospital, and St. Peter's Hospital and report to ACPD with the results of the consultation.

3. Automatic Door Opener at the Chedoke Twin Pad Arena Multi-Purpose Facility (Item 8.2)

Whereas, the Built Environment Sub-Committee of the Advisory Committee for Persons with Disabilities conducted a tour of the newly renovated Multi-Purpose Facility at the Chedoke Twin Pad Area; and,

Whereas, the Sub-Committee found that the automatic door actuator for the main entrance was installed in the wrong location, therefore resulting in persons with disabilities being unable to safely open the door and enter expeditiously;

Therefore be it resolved:

That staff be directed to move the automatic door actuator at the main doors to the Chedoke Twin Pad Arena Multi-Purpose Facility to a proper location in order to make the doors operable for persons with disabilities and be in compliance with the *Ontario Building Code*.

(i) Accessibility at Healthcare Facilities

Whereas, Hamilton Street Railway (HSR) bus access to the main entrance to the McMaster University Medical Centre was terminated in 2014; and,

Whereas, subsequent to this action an assessment by the members of the City's Advisory Committee for Persons with Disabilities (ACPD) has determined that there is also no primary access for HSR passengers to the entrances of the following Hamilton hospitals/health care facilities: St. Joseph's Healthcare Hamilton – Charlton Campus, St. Joseph's Healthcare Hamilton – King Campus, Hamilton General Hospital, Juravinski Hospital, and St. Peter's Hospital; and,

Whereas, the entrance to each of the above facilities requires persons using public transit to either negotiate steep and long pathways or long pathways to gain main entrance access; and,

Whereas, ACPD believes strongly that the current main access entrances to each of these facilities is a barrier and safety concern for persons with disabilities seeking either health care services or simply attending the facilities; and, Whereas, ACPD believes that public transit access to the main entrances of each of these facilities may be the only means by which barriered access can be remedied,

Therefore be it resolved:

That staff be directed to initiate consultations with representatives of the Hamilton Health Sciences Corporation, St. Joseph's Healthcare Hamilton and the Accessibility Committee for Persons with Disabilities (ACPD) to determine what steps can be taken to address the issue of barriered access for persons with disabilities to: McMaster University Medical Centre, St. Joseph's Healthcare Hamilton – Charlton Campus, St. Joseph's Healthcare Hamilton – King Campus, St. Joseph's Healthcare Hamilton – West 5th-Fennell Campus, Hamilton General Hospital, Juravinski Hospital, and St. Peter's Hospital and report to ACPD with the results of the consultation.

That staff be directed to move the automatic door actuator at the main doors to the Chedoke Twin Pad Arena Multi-Purpose Facility to a proper location in order to make the doors operable for persons with disabilities and be in compliance with the *Ontario Building Code*.
