## **BY-LAW NO. 15-**

Being a By-law to Permanently Close a Portion of the Road Allowance of Kingsview Drive abutting 2 Tamarack Place, established by Plan 62M-399, City of Stoney Creek, now City of Hamilton, designated as Parts 1, 2, 4 and 5 on Plan 62R-17984

**WHEREAS** the Council of the City of Hamilton is empowered under Section 34 of the *Municipal Act*, 2001, S.O. 2001, c.25 as amended, to permanently close any highway or part of a highway;

**AND WHEREAS** the Council of the City of Hamilton on June 12, 2013, in adopting Item 2 of Public Works Committee Report 13-007, authorized the City to permanently close and sell a Portion of the Road Allowance of Kingsview Drive, Stoney Creek, abutting 2 Tamarack Place, being Part of Agate Street, Plan 62M-399 (Name changed to Kingsview Drive by By-law No. 2176-86, unregistered), designated as Parts 1 and 2 on Plan 62R-17984 and Part of Block 42, Plan 62M-399, opened as Public Highway by By-law 01-260 registered as Instrument No. WE64480, designated as Parts 4 and 5 on Plan 62R-17984, City of Stoney Creek, now City of Hamilton;

**AND WHEREAS** the road is a highway under the jurisdiction of the City of Hamilton;

**AND WHEREAS** notice of the City's intention to pass this By-law has been published pursuant to the *Municipal Act, 2001*, S.O. 2001, c.25 as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. That the part of the road allowance, set out as:

Part of Agate Street, Plan 62M-399 (Name changed to Kingsview Drive by By-law No. 2176-86, unregistered), designated as Parts 1 and 2 on Plan 62R-17984, and Part of Block 42, Plan 62M-399, opened as Public

- 2. That the soil and freehold of Parts 1, 2, 4 and 5 on Plan 62R-17984, hereby permanently closed, be sold to Armando David Vacca and Lori Arlene Vacca for the sum of Three Hundred and Seventy-Five Dollars (\$375.00).
- 3. That this by-law shall come into force and effect on the date of its registration in the Land Registry Office for the Land Titles Division of Wentworth (No. 62).
