BY-LAW NO. 15-

Respecting

Removal of Part Lot Control

**Block 148, Registered Plan of Subdivision No. 62M-1204, "Paramount"
201, 207, 209, 211, 213, 215, 217, 219, 221, 225, 227, 229, 231, 233, and 235
Westbank Trail, Stoney Creek**

WHEREAS the sub-section 50(5) of the *Planning Act*, R.S.O. 1990, Chapter P.13, as amended, establishes part-lot control on land within registered plans of subdivision;

AND WHEREAS sub-section 50(7) of the *Planning Act*, provides as follows:

"Designation of lands not subject to part lot control. -- Despite subsection (5), the council of a local municipality may by by-law provide that subsection (5) does not apply to land that is within such registered plan or plans of subdivision or parts of them as are designated in the by-law."

AND WHEREAS the Council of the City of Hamilton is desirous of enacting such a by-law with respect to the lands hereinafter described;

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Subsection 5 of Section 50 of the *Planning Act*, for the purpose of creating 18 lots for townhouse dwellings (Parts 1 to 18 inclusive, Part 75, Part 79, and Parts 82 to 85 inclusive), 56 lots for maisonette dwellings (Parts 19 to 74 inclusive), 5 maintenance easements (Part 79 and Parts 82 to 85 inclusive), 2 sanitary easements in favour of the City of Hamilton (Part 75 and Part 76), 5 access easements in favour of the City of Hamilton (Part 75, Part 76, Part 77, Part 78 and Part 81), and 6 common elements for a future Plan of Condominium (Parts 76 to 78 inclusive, Part 80, Part 81, and Part 86), on Deposited Reference Plan 62R-20012, shall not apply to the portion of the Registered Plan of Subdivision that is designated as follows, namely:

Block 148, Registered Plan of Subdivision 62M-1204, in the City of Hamilton.

2. This By-law shall be registered on title to the said designated land and shall come into force and effect on the date of such registration.
