# (ii) Heather Millar, respecting the Port Fuels and Materials Services Inc. Matter for the April 15, 2015 GIC Meeting (Item 6.2)

Heather Millar addressed Committee respecting the Port Fuels and Materials Services Inc. matter. Her comments included, but were not limited to, the following:

- It has been just over a year since we first learned of the garbage incinerator project that was being proposed for the Pier 15 area, by Port Fuels and Materials Services Inc.
- The project was not presented as a garbage incinerator, but rather as a 'waste-to-energy facility' that would use groundbreaking technology to take waste that would normally end up in a landfill and convert it into energy, in the form of gas. The idea certainly sounded promising, but I wanted to hear more about the proposal. I wanted to see the science, the financials, and the company's proven track record in this field.
- I studied all of their diagram boards, heard all the reassurances by the company's CEO (and retired naval admiral) Robert Clark. I was told: This plant has zero emissions. The waste will only be sourced locally. This technology is unique. Hamilton is fortunate to be 'chosen' for this groundbreaking technology. We have lots of experience in the waste-to-energy field, and we operate a plant like this in England.
- After a year of talking to, and sharing information with other concerned residents of Hamilton, researching the history of waste-to-energy

plants, and reading the information presented by actual experts in the field, I learned that one of the worst decisions that Hamilton could make would be to allow this type of facility to be built on their waterfront. I came to this conclusion by examining the information provided by the experts.

- By listening to experts like Dr. Stan Blecher, MD, Fellow of the Canadian College of Medical Geneticists, and Professor Emeritus in Molecular Biology and Genetics at the University of Guelph, I learned about nanoparticles. Nanoparticles are particles that are about one millionth the size of the head of a pin. The burning of syngas, the gas that will be produced by Port Fuels' incinerator, will release toxic nanoparticles into Hamilton's air. They will not be caught or trapped by any sorts of filters or scrubbers, because, as stated by Dr. Blecher, 'to date no technique has succeeded in preventing the release of syngas incineration pollutants'. So despite Admiral Clark's claim of zero emissions, we will indeed be breathing in these toxic nanoparticles.
- It may seem puzzling that particles so small could be so harmful, but the reason is that these tiny toxic particles can enter the pores of our lungs, then into our blood vessels. Once in your bloodstream, they circulate to all your internal organs, including your brain. Our bodies have no filters to keep out these nanoparticles.
- Dr. Blecher goes on to state that 'with respect to medical problems that can arise from pollution caused by gasification effluent, in general terms the list includes: Cancers which are caused by genetic mutations; genetic mutations that could potentially produce cancers and birth deformities in the next generations - our city's children, and their children; effects on the nervous system causing mental deficiency and paralysis: respiratory system disease and heart disease in the elderly, and much more.
- And unlike the fly ash that is released from traditional burn incinerators, these nanoparticles are so tiny and light that they travel for significant distances, so these toxins will be shared by all of Hamilton and the surrounding communities. Yes, even on the mountain.
- I listened to the information that was shared by Dr. Paul Connett, who spoke recently here at our City Hall. For those of you who were unable to attend this very important information session, I'm certain that Councillor Green would be happy to provide a summary of Dr. Connett's presentation. Dr. Connett is Professor Emeritus in Environmental Chemistry at St. Lawrence University in Canton, NY. For the past 30 years, he has used his scientific knowledge to help communities around the world in understanding the science of incineration. He explained that any type of incineration, including any gas plasma technology, is not a viable solution for waste issues. Aside

from the associated health risks (which are significant), gas plasma technology does not work at the scale proposed, and their claims of zero emissions are quite simply a myth. Additionally, incineration of any type is a waste of energy, and communities can save four times the amount of energy by recycling and reusing.

- In short, these facilities are toxic, financially impractical, and kill the jobs that would be created by more practical waste solutions.
- o The Ministry of the Environment states that an elevation request for a more rigorous assessment must demonstrate the project's potential for significant environmental effects. I can't think of a more important environmental effect than the potential poisoning of the residents of Hamilton and the surrounding communities. As a resident, the one thing I know for certain is that Hamilton's air shed simply cannot withstand another potential source of contamination. We are already suffering the negative effects of generations of accidental emission releases from our industrial neighbours such as the steel industry. Unfortunately we do not have the power to change what has occurred to-date, but we do have the power to demand that any new industry seeking to operate in Hamilton must prove that they will not cause any further damage to Hamilton's environment.
- Look at the history of environmental disasters in Hamilton: Plastimet, SWARU, and Randle Reef, to name but a few; all held to account by citizens who stepped forward to demand environmental assessments and monitoring. Where were the municipal, provincial and federal monitors and safeguards that should have prevented these disasters?
- Is it any wonder that we are skeptical each time a new industry comes to our city, promising to be an environmentally responsible neighbour? Is it surprising that Hamilton residents are wary of Port Fuels' unproven technology, and is it unreasonable for residents to expect that for once, just once, community health and safety will be our first priority?
- As a resident of Hamilton, I am calling upon municipal and provincial authorities, including the Ministry of the Environment and Climate Change, to ensure that the most rigorous level of scrutiny be applied to any environmental assessment of this proposed facility, and I urge this City Council to take the necessary steps to formally oppose this project.

I am also a member of the Port Fuels Community Liaison Committee.
- Although there is no internationally accepted, or even commonly agreed upon, definition of "green technology", the United Nations Conference on Environment and Development defined it to be Environmentally Sound Technology and was further defined as technologies geared to protect the environment, are less polluting, use all resources in a more sustainable manner, recycle more of their waste and products, and handle residual waste in a more acceptable manner than the technologies for which they are substituted.
- When compared to our current method of land filling our waste, that is not composted or recycled, it becomes obvious that Port Fuels and Materials Services, Inc. is, in fact, green technology.
- A quick internet search has been able to put into perspective the veritable army of professionals having a hand in evaluating this process. Conestoga-Rovers and Associates, WSP, Golder and

Associates, the Fichtner Group, the U.S. Army and the Gas Technology Institute constitute the resources of over 50,000 engineers, consultants and scientists, and a likely investment of over \$150,000 by the City of Hamilton, having been involved in assessing Port Fuel's Gas plasma technology.

- Further, in December 2014, the Ministry of the Environment and Climate Change (MOECC) issued a New Environmental Technology Evaluation Certificate for Gas Plasma Energy-from-Waste process for Port Fuels. It was based on a review of the data and information submitted and the Ministry concluded that it may be used to convert waste material into a fuel gas suitable to generate power.
- With this legion of professionals working on this issue, WSP was able to come up with 11 further questions in their Summary and have no mention of a recommendation for a bump up to a full Environmental Assessment (EA) in the report. Some of the answers for these questions were already available in the original work provided by Conestoga-Rovers and Port Fuels, but were perhaps missed by the peer reviewers.
- The City of Hamilton professes to be Open for Business, yet instead of exploring this 21st century usage of century old well-proven technologies to deal with our problems that will quickly be out of hand, there are some who would use extreme measures to stand in its way.
- O Port Fuels is estimated to pay half a million dollars a year in property taxes alone. Add to this the 35 to 50 well-paying jobs that will be created by the company, putting millions into the local economy. Then add to this the 3 spin-off jobs that are created for every job created in the industrial and advanced manufacturing sector. Further, include the potential for another 150 jobs in a second stage development of an advanced technology, a Solid Oxide Fuel Cell factory, and a further 3 to 1 spin off jobs plus additional property taxes from the Fuel Cell factory. I don't profess to be an economist, but the potential of 800 jobs and, eventually over, 1 million a year in property taxes, all in one small neighbourhood.
- I have to ask, what might be the intention behind demanding a full EA, when the Ministry has already said that the proponents have used the proper methodology for waste processing facilities that have the potential to generate energy.
- PFMSI has already conducted their Environmental Screening Report with all of the same technical requirements and protocols of

a full EA. There is no new technical information to be gained from a full EA.

- Why don't we just let PFMSI respond to the latest questions of the City's consultants and let's get back to responsibly dealing with our own waste issues, getting Hamiltonians back to work, expanding the non-residential tax base, and truly being open for business.
- My own 15 years in logistics for the mining and smelting industry, has at least given me the insight into the ability and workings of the pollution controls that are available.

### (v) Robert Clark, Chief Operating Officer of Port Fuels and Materials Services, Inc. respecting the Port Fuels and Materials Services Inc. Matter for the April 15, 2015 GIC Meeting (Item 6.5)

Robert Clark, Chief Operating Officer of Port Fuels and Materials Services, Inc., addressed Committee respecting the Port Fuels and Materials Services Inc. Matter. His comments included, but were not limited to, the following:

- There are three process streams that waste management project could fall under:
  - 1. Projects exempt from Part II of the *Environmental Assessment Act*. Such projects are generally of small scale and are known, through past experience, to have insignificant environmental effects.
  - 2. Projects exempt from Part II of the *Environmental Assessment Act*, subject to the legal requirement of completion of the Environmental Screening Process. Such projects are of moderate scale and are considered to have predictable environment effects that can be readily reduced that to acceptable levels through the application of mitigation measures.
  - 3. Projects designated under the *Environmental Assessment Act* that must undergo an individual environmental assessment. Such projects tend to be complex and major in scale with potentially far reaching environmental affects requiring significant levels of assessment and mitigation.

- The Proposed Full Environmental Assessment
- Major differences between the Environmental Screening performed by Port Fuels and Materials Services, Inc. and a full Environmental Assessment
- Working with the City and Peer Reviewers
- Consultant Report Recommendations
- Summary:
  - PFMSI voluntarily agreed to delay the process to work with the City. Port Fuels notified the Ministry of the Environment and Climate Change (MOECC) and they agreed with our proponent-driving delay request since it is required for the extension.
  - PFMSI welcomes a deeper level of scrutiny. That is why a technical equivalent of a full environmental assessment was completed.
  - PFMSI appreciates the professionalism of the City and all the consultants and their questions. This consultation will be included in our Environmental Screening Review.
  - We also acknowledge the positive comments:
    - "The severity of risk is low to medium... It can be concluded that the plant does not introduce unacceptable environmental risks." - WSP
    - "The proposed Energy-from-Waste facility is a promising, innovative technology to manage solid waste that could position Hamilton as a municipal leader in supporting environmentally "green" technology. The ability to minimize negative environmental impacts can clearly have positive impacts for public health." COH PHS
    - This is a continuing process and we are in direct contact with our counter-parts to discuss the remaining items.
- Conclusions:

- PFMSI respectfully submits to the City that they have completed an EA where the technical work and analysis for the proposed undertaking has been at a high level; similar to what is required of Full EA.
- We believe that the EA completed under the Screening process is already a fully-detailed EA and there would be no additional benefit to the environment or to the public interest by requiring an Individual Full EA.
- It is clear that once the 11 remaining issues are resolved, the end result of the evaluation and analysis of the undertaking show that standard mitigation measures reduce potential environmental effects to acceptable levels.
- Therefore, the Peer Review will be satisfied and the project may be submitted for approval to the Director.

Blair Shoniker, Senior Environmental Planner, of Conestoga-Rovers and Associates, who carried out the Environmental Assessment for Port Fuels and Materials Services, Inc., also answered questions asked by the Committee.

- March 2014: Port Fuels and Material Services Inc. (PFMSI) issues a Notice of Commencement of an Environmental Screening Process under the *Environmental Assessment Act.*
- April November 2014: Stakeholder Consultation and Public Open Houses.
- December 2014: PFMSI issues a Notice of Completion and Environmental Screening Report (ESR).
- January 2015: External Environmental and Legal Consultants retained to provide peer review of the proponent's proposal and technical reports.
- February 2015: 60-day extension is granted to May 4, 2015 to allow time for City to peer review and consideration of elevation request.
- March 31, 2015: Building Division issues Zoning Verification Certificate.
- April 6, 2015: WSP Canada Inc. completes technical review of the ESR and technical reports.
- April 15, 2015: Presentation of Staff Report and Recommendations to GIC.
- April 20, 2015: Presentation of Medical Officer of Health Report to Board of Health.
- April 22, 2015: Council meeting to decide on request to MOECC.
- May 4, 2015: Deadline for Submission to Ministry of the Environment and Climate Change (MOECC) on Elevation Request.
- Planning Framework:
  - Official Plan:
    - Designated "Employment Lands Shipping and Navigation
    - Designation does not permit Waste Processing Facilities

- Zoning By-law:
  - Zoned "K" District in Zoning By-law No. 6593
  - Waste Processing Facility is a permitted use in the "K" District
  - Waste Processing Facility by definition includes Thermal Treatment
- Peer Review/Technical Findings:
  - WSP initial review of Environmental Screening Report and supporting studies.
  - WSP Request for additional information from PFMSI / CRA.
  - CRA / PFMSI provides additional information and meets with WSP to respond to questions.
  - WSP completes draft discipline-by-discipline peer review reports.
  - WSP provides draft peer review reports to PFMSI / CRA and obtains comments.
  - Finalize WSP Report and Recommendations
  - Two key deficiencies identified in peer review:
    - Reliance on small scale pilot plant as supporting data for the project;
    - Uncertainty regarding various feedstock scenarios to support the plant and its air quality standards;
    - Additional information and assessment is needed to support EA approval; and,
    - Risk of environmental impairment if issues not addressed.
  - Design and Operations:

- Additional information is required to determine feedstock makeup and handling for Hamilton plant so that there is confidence that the operations would not exceed environmental standards.
- Air Quality:
  - Emissions modelling are not conservative enough. This is important given the existing limited data from the Swindon, UK pilot plant.
- Human Health Risk Assessment:
  - Study did not fully address all Contaminants of Concern (COCs) or address the potential of mixture effects and its effects on residents.
  - Malfunction or accident scenarios requiring air pollution controls were not evaluated.
  - The Assessment will be revised to accommodate the issues, however, this has not been provided for review.
- Surface Water/Stormwater:
  - Stormwater Management measures are inadequate to provide acceptable level of quality control for stormwater discharge into Hamilton Harbour.
  - More information in the Spills Response Plan to address liquid waste spillage from tanker trucks.

# • Traffic:

- The study should be revised to include a preferred truck route along Burlington Street and the QEW, and away from residential neighbourhoods.
- Geology and Hydrogeology:

- Further information is needed showing the staging and handling of wastes, and the potential negative impacts on groundwater quality and quantity.
- Natural Environment:
  - Additional information is required on the stormwater inflow and how it may impact water quality on Randle Reef in Hamilton Harbour.
  - Monitoring is recommended during construction and operation of the facility.
- Land Use and Socio-Economic:
  - Additional information is required on the financial implications on the decommissioning of the project, and site remediation should the facility cease operations.
- Acoustic Impact Assessment:
  - The findings are satisfactory and potential noise impacts and mitigation has been identified.
- Conclusions:
  - Review of the technical reports identified two main deficiencies:
    - 1. The use of the Swindon, United Kingdom (UK) pilot plant as part of the supporting data for the project; and,
    - 2. Uncertainty regarding various feedstock scenarios to support the plant and its air quality standards.
  - Additional information and assessment is needed to support EA approval.
  - Risk of environmental impairment if issues not addressed.

- Five Key WSP Findings:
  - 1. Significant Uncertainties:
    - Reliance on small scale pilot project; and,
    - Waste stream feedstock.
  - 2. Uncertainties point to need for more air quality study.
  - 3. Revisions to Health Risk Assessment recommended.
  - 4. Need for assessment of overall advantages and disadvantages.
  - 5. WSP conclusion that risk of environmental impairment if issues not addressed.
- Other Relevant Considerations for Elevation Requests:
  - Precautionary Principle
  - Potential for Negative Environmental Impacts
  - Public Benefits of Full EA: Further Consultation and Transparency
  - Opinion of Medical Officer of Health: Need for a Health Equity Impact Assessment

AND WHEREAS, the waste facility proponents Port Fuels & Materials Services, Inc. have applied to the province, under the classification of energy-from-waste, in order to fast track Ministry of Environment approval without any individual environmental assessment;

AND WHEREAS, Port Fuels & Materials Services, Inc. has recently applied to the City of Hamilton for "K" zoning (Heavy Industry, etc.), and has received a zoning verification as a waste processing facility;

THEREFORE BE IT RESOLVED:

- (a) That, taking into account the potential for serious safety and environmental risks and impacts, Hamilton City Council officially opposes Port Fuels & Materials Services, Inc.'s Energy-From-Waste Facility project, on the grounds of it being unproven as a waste processing technology facility at full scale operation;
- (b) That the Mayor correspond with The Honourable Glen Murray, Minister of the Environment and Climate Change, to immediately request an elevation to an Individual Environmental Assessment (Part II approval), under the *Ontario Environmental Assessment*

*Act,* which is a process overseen directly by the Minister of the Environment and Climate Change, based on Port Fuels & Materials Services, Inc.'s recent switch in classification to waste management facility, and given the unproven nature of the proposed technology; and,

(c) That, without a full Individual Environmental Assessment, a moratorium on any future business dealings with the proponents, Port Fuels & Materials Services, Inc., and any future private operators of said proprietary technology on Port Authority lands, be approved.
