

Staff Recommendation: Provide a DC Deferral Agreement Extension for 1 year with 40% due on original due date and interest at the City's 5 year serial debenture rate plus 2.25%.

The sample payment schedule for the Staff Recommendation illustrates a payment schedule where the DC Deferral Agreement is extended for 1 year with 40% of the outstanding balance due on the original Deferral Agreement expiry date followed by 12 equal monthly payments.

This sample schedule uses the April 2015, 5 year serial debenture rate for illustration only. The June 2015, 5 year serial debenture rate would be used in the actual calculation.
