### Statistics

In the last 6 years:

- 156 soldiers died in the Afghanistan in a war zone
- 719 children die while in foster care in Ontario
- 2,595 children dying in five provinces across
  Canada under child protective services

### Death Rate of Kids while under the Supervision of the Ontario CAS

### Ontario

In 2006, 83 children died

In 2007, 90 children died

In 2008, 105 children died

In 2009, 120 children died

In 2010, 105 children died

In 2011, 109 children died

In 2012, 107 children died

#### 719

These numbers are both kids in care of CAS and kids just under the watchful eye of the CAS while at still at home. These numbers come from the Pediatric Death Review Committee and the Office of the Chief Coroner Report. Protecting Canadian Children was launched in 2007

## Children's Aid Society (CAS)

 Many people have asked me why I have never registered as a non-profit or charity. This is the reason why ....

For example, a registered charity with a charitable purpose to provide for the welfare of children can engage in activities that take a public position about certain legislation in the field of child welfare, provided the activities are within the limits described above. However, an organization established solely for purposes of pressuring for a change in the legislation affecting the welfare of children cannot be registered as a charity.
